• Closure:

- (i) On January 10th 2016, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
