<p>JERUSALEM</p>	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) On April 3rd 2015 the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 40 from conducting prayers at Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 14:00, Israeli forces set up a checkpoint near Beit Hanina. (ii) At 16:00, Israeli forces set up a checkpoint along Jaba’ village roundabout and prevented vehicles from travelling on a road bypass road leading to Mikhmas village and towards Nablus and impeded the free flow of traffic. (iii) At 23:05, Israeli forces set up three checkpoints in Al-Ram. • <u>Raid:</u> At 13:00, Israeli forces raided Al-Ram, clashed with several residents then withdrew at 14:20. • <u>Detention:</u> At 12:00, Israeli forces detained Hadi Al-Ajlouni in the old city of Jerusalem. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 16:30, Israeli forces positioned at Ras Kabsah junction which is located between Abu Dis and Al-Eizariya fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning. (ii) At 21:00, Israeli forces positioned in Silwan neighbourhood fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning • <u>Assault on Places of Worship:</u> At 21:45, Israeli settler under the protection of Israeli forces and Israeli Police stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshipers. • <u>Demonstration:</u> At 17:10, a demonstration took place in Al-Sheikh Jarrah neighbourhood in Jerusalem protesting against Israeli settler occupation of

	<p>Palestinian resident's homes and Israeli Military confiscation of land for the purpose of settlement construction.</p> <ul style="list-style-type: none"> • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.
RAMALLAH & AL BIREH	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages. • <u>Flying Checkpoint:</u> At 18:20, Israeli forces set up a checkpoint at the entrance of Al-Nabi Saleh village until 19:30. • <u>Raid:</u> At 12:35 and again at 17:15, Israeli forces raided Al-Bireh city until 17:40 • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 16:20, Israeli forces positioned near the entrance of Al-Jalazoun camp fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning. (ii) At 17:10, Israeli forces positioned near the wall gate located in south area of Al-Bireh city fired, stun and tear gas grenades towards several children for alleged stoning. (iii) At 18:00, Israeli forces positioned at the entrance of Silwad, fired stun and tear gas grenades towards several residents for alleged stoning. (iv) At 18:00, Israeli forces positioned at the entrance of Sinjil village, fired stun and tear gas grenades towards several residents for alleged stoning. • <u>Demonstrations:</u> <ul style="list-style-type: none"> (i) At 13:30, a demonstration took place in Bil'in protesting against the construction of the wall during which they clashed with Israeli forces and as a result injured Kifah Burnat and suffocated several residents from tear gas inhalation. (ii) At 13:35, a demonstration took place in Al-Nabi Saleh village protesting against the confiscation of land for the purpose of settlement construction during which they clashed with Israeli forces who fired live ammunition, stun and tear gas grenades towards demonstrators and as a result injured 2 residents: Manal Al-Tamimi and Mohammad Rayan and left them suffocated from tear gas inhalation. (iii) At 16:10, a demonstration took place in Ni'lin protesting against the construction of the wall during which they clashed with Israeli forces and as a result injured the child Hussien Sarur (16 years old) and left them suffocated from tear gas inhalation.
JENIN	<ul style="list-style-type: none"> • <u>Closure of Main Road:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road leading to the town of 'Arraba east of the illegal settlement Dotan. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya'bad. • <u>Flying Checkpoint:</u> At 21:00, Israeli forces set up a checkpoint at Ya'bad junction until 22:30. • <u>Wall Gates:</u> Israeli forces continue too close the wall gate and only allow those holding special permits to enter through it.
TUBAS	<ul style="list-style-type: none"> • <u>Flying Checkpoint:</u> At 15:00, Israeli forces set up a checkpoint near Al-Aqaba village.

<p>TULKAREM</p>	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road connecting Kafr Al-Labad town to Shufa village. (ii) The Israeli army continues to close with dirt mounds the detour road leading to Ramin village along the Tulkarem-Nablus main road. • <u>Checkpoint:</u> At 12:50, Israeli forces intensified their restrictions at “Eniv” checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic until 15:50. • <u>Flying Checkpoint:</u> At 18:20, Israeli forces set up a checkpoint at the entrance of Shufa village until 20:15.
<p>QALQILIYA</p>	<ul style="list-style-type: none"> • <u>Closure of Roads:</u> <ul style="list-style-type: none"> (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) Since 16:55 on December 18th 2014, Israeli forces closed an agricultural road leading to Far’ata village which is located near “Gillad” settlement with dirt mounds • <u>Flying Checkpoint:</u> At 10:30, Israeli forces set up a checkpoint in the area between Hajja and Kafer Qaddum village, prevented journalist from entering Kafer Qaddum village then withdrew at 15:30. • <u>Raid:</u> At 11:30, Israeli forces raided Kafer Qaddum village, clashed with several residents then withdrew at 15:30. • <u>Demonstration:</u> At 13:30, a demonstration took place in Kafr Qaddum against the closure of the east entrance during which they clashed with Israeli forces who tried to disrupt the demonstration who fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards demonstrators who attempted to reach they demonstration site and as a result injured 3 residents: Murad Ishtewi, Majed Obied and Abdallah Jum’a and also left several demonstrators suffocating form tear gas inhalation. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at ‘Azzun ‘Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
<p>NABLUS</p>	<ul style="list-style-type: none"> • <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of ‘Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma’in and the villages of Duma and Qaryut. • <u>Checkpoint:</u> At 12:25, Israeli forces intensified their restrictions at Huwarah checkpoint and impeded the free flow of Traffic until 14:15 • <u>Flying Checkpoint:</u> At 19:45, Israeli forces set up a checkpoint at Beit Furiq

	<p>junction and prevented vehicles from using the raid leading to “Yitmar” settlement then withdrew at 22:30.</p>
SALFIT	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland. (ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian, which was closed since the year 2000 and prevented access from 08:00 until 09:20. (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama’ located in western area of Deir Istiya with cement blocks. • <u>Checkpoints:</u> At 12:25, Israeli forces continue to intensify their restrictions at Za’tara checkpoint and impeded the free flow of traffic until 14:15.
JERICHO	<ul style="list-style-type: none"> • <u>Checkpoints:</u> Israeli forces intensified its restrictions at Al-Hamra checkpoint set up along the road connecting Jericho and Nablus District. • <u>Flying Checkpoint:</u> <ol style="list-style-type: none"> (i) At 11:15, Israeli forces set up a checkpoint at the Dead Sea junction and detained two residents from Jenin. (ii) At 16:45 and again at 19:15, Israeli forces set up a checkpoint at the south entrance of Jericho until 19:35 • <u>Raid:</u> At 18:30, Israeli forces raided Al-Oja village, stormed and searched a home then withdrew at 19:30. • <u>Detention:</u> Israeli forces detained Fadi Hamdan and Fadi Faris at a checkpoint near the Dead Sea junction.
BETHLEHEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to close roads to An Nu’mān village, with the exception of the road leading to the Wall gate in the south-eastern area of the village. (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunums of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities. • <u>Closure of Main Roads:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu’mān: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; Wadi Rahal road near “Ifrat” settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds. (ii) The Israeli army continues to close the road leading to “Newe Daniyyel” settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za’tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks. (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla. (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires. (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds. (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt

	<p>mounds.</p> <p>(vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds.</p> <p>(viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.</p> <ul style="list-style-type: none"> • <u>Flying Checkpoint:</u> At 15:30, Israeli forces set up a checkpoint at the entrance of Beit Jallah until 16:00. • <u>Raid:</u> At 13:20, Israeli forces raided Husan village until 15:10. • <u>Demonstration:</u> At 14:00, a demonstration took place in Al-Ma'sra village protesting against the construction of the wall during which Israeli forces fired stun and tear gas grenades towards demonstrators and prevented them from reaching the demonstration site.
<p style="text-align: center;">HEBRON</p>	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages. (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City. (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town. (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks. (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 09:35, Israeli forces set up a checkpoint at the entrance of Al-Fah's area located in South Hebron until 10:20. (ii) At 18:00, Israeli forces set up a checkpoint in Al-Adasiya area located in south Sa'ir until 18:45. • <u>Raid:</u> At 14:10, Israeli forces raided Wadi Qabun area located in North Hebron.

<p style="text-align: center;">ALL DISTRICTS</p>	<ul style="list-style-type: none"> • At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. • Israeli forces positioned behind the Green line broke the cease-fire agreement by opening fire towards Gaza and Khan Yunis and as a result injured three residents in Khan Yunis. • Israeli Naval vessels broke the ceasefire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza.
<p style="text-align: center;">NORTHERN GAZA</p>	<ul style="list-style-type: none"> • Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical patients, journalists, NGO staff, and passengers travelling abroad and through Al-Karama crossing with previous coordination. • Attack: At 05:30, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Al-Sudaniya beach located in West Beit Lahiya.
<p style="text-align: center;">GAZA</p>	<ul style="list-style-type: none"> • Closure of Crossing Points: <ul style="list-style-type: none"> (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. (ii) Al-Shija'iyah (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision. • Attack: On the morning of April 4th 2015, Israeli forces positioned behind the Green Line opened fire and launched tank artillery shells towards agricultural land in east Al-Zaytouneh neighbourhood located in south east Gaza city.
<p style="text-align: center;">KHAN YUNIS</p>	<ul style="list-style-type: none"> • Attack: On the evening of April 3rd 2015, Israeli forces positioned behind the Green Line opened fire, launched stun and tear gas grenades towards several residents in east Abbassan and Kha'zza towns and as a result injured 3 residents.
<p style="text-align: center;">RAFAH</p>	<ul style="list-style-type: none"> • Closure of Crossing Points : <ul style="list-style-type: none"> (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (<i>Al 'Awdah</i>) Crossing is closed. (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is closed.
