dunumes (acres) of agricultural crops owned by Iz Gayth.
• Wall Construction: Wall construction was halted in the area surrounding the

At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles and on March 21st 2013 re imposed fishing restrictions of 3 miles. Israeli forces broke the cease fire agreement by opening fire, launched tear gas grenades and launching tank artillery shells from their positions behind the Green Line towards Gaza and Central Gaza. Israeli Naval vessels broke the cease fire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza. Palestinian Gunmen broke the cease fire agreement by launching 4 projectiles towards the Green Line.
NORTHERN GAZA	 <u>Closure of Crossing Point:</u> Beit Hanun (Erez) is closed. <u>Attack:</u> (i) At 05:00 on April 6th 2014, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Beit Lahiya. (ii) At 07:10 on April 6th 2014, Israeli forces positioned behind the Green line opened fire and launched tear gas grenades towards several residents positioned near Beit Hanun (Erez) Crossing point in North Beit Hanun. <u>Palestinian Attack:</u> On the afternoon of April 6th 2014, Palestinian gunmen launched 4 projectiles towards the Green Line
GAZA	 Launched 4 projectiles towards the Green Line. Closure of Crossing Points: Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has been closed following a unilateral Israeli decision.

RAFAH	 <u>Closure of Crossing Points :</u> (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (<i>Al 'Awdah</i>) Crossing is open for the entry of residents and students. (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is open for the passage of critical patients, journalists, NGO staff, businessmen and passengers travelling abroad through Al-Karama crossing with previous coordination, diesel fuel for electric generators, construction material for UNWRA funded projects.
