- (i) The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound.

- At 21:00 on November 21st 2012, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire.
- On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles and on March 21st 2013 re imposed fishing restrictions of 3 miles.
- Israeli forces broke the cease fire agreement as they stormed Khan Yunis and opened fire from their positions behind the Green Line towards Khan Yunis.
- Israeli Naval vessels broke the cease fire agreement towards Palestinian fishing boats off the shores of North Gaza.
- Palestinian gunmen opened fire and detonated a UXO near an Israeli Military vehicle as it passed near the border fence.

NORTHERN GAZA

- <u>Closure of Crossing Point:</u> Beit Hanun (Erez)) is open for the passage of critical patients, journalists, NGO staff, businessmen and passengers travelling abroad through Al-Karama crossing with previous coordination.
- Attack: At 06:30 on April 24th 2014, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Beit Lahiya and confiscated fishing net owned by Yusef Al-Sultan.
- <u>Injury:</u> On the afternoon of April 23rd 2014, 10 residents including 5 children: Hanin Al-Masri (11 years old), Reem Al-Habal (5 years old), Khaled Al-Ghoul (15 years old), Isra Al-Habal (8 years old) and Salim Al-Za'noun (15 years old) were injured during Israeli airstrikes towards Palestinian gunmen in Beit Lahiya in addition to those mentioned in the previous report.
- Palestinian Attack: At 18:40, Palestinian gunmen detonated a UXO near the border fence as an Israeli military vehicle was passing near the fence during which Israeli forces opened fire and launched tank artillery shells towards the Palestinian gunmen in east Jabaliya.

GAZA	 Closure of Crossing Points: Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has been closed following a unilateral Israeli decision.
