WEST BANK

Closure:

- The Israeli army, intensified their restrictions at the entrance to Jerusalem (i) city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 40 from conducting prayers at Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- The Israeli army continues to impose a blockade and deny civilian access to a (iii) hill between Biddu and Beit Iksa villages.

Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- The Israeli army continues to close with an iron gate the eastern entrance to (ii) Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

- (iii) Israeli forces detained Nour Rayan in Beit Dugu village.
- Attack: At 23:30, Israeli forces positioned near Al-Suwana neighbourhoods fired stun and tear gas grenades towards several residents for alleged stoning.

Wall Gates:

- (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
- The Israeli army continues to deny civilian access through the Wall gate (ii) on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic

ALL DISTRICTS

- At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month.
- Israeli forces broke the cease-fire agreement by opening fire towards North Gaza and Central Gaza.
- Israeli Naval vessels broke the cease-fire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza and Khan Yunis.

Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical patients, journalists, NGO staff, businesspersons and passengers travelling abroad through Al-Karama crossing with previous coordination. Attack: **NORTHERN** (i) On the morning of April 28th 2015, Israeli Naval vessels opened fire **GAZA** towards Palestinian fishing boats of the shores of Al-Sudaniya located in west Beit Lahiya. (ii) At 18:10, Israeli forces positioned behind the Green Line opened fire towards several residents on agricultural land near Al-Shiuhada cemetery located in east Jabaliya. **Closure of Crossing Points:** (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. **GAZA** (ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision. Attack: At 09:15, Israeli forces positioned behind the Green Line opened fire **CENTRAL** towards agricultural land in east Deir Al-Balah. **GAZA** Attack: At 20:15, Israeli Naval vessels opened fire towards Palestinian fishing KHAN YUNIS boats of the shores of Khan Yunis. • Closure of Crossing Points: (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (Al 'Awdah) Crossing is closed. **RAFAH** (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is open for the entry of tourist and foreign diplomats and the entry of Humanitarian assistance and construction material funded by UNRWA.
