The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.  Closure of Main Roads:  The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.  The Israeli army continues to close the gate along the Wall section separating the area of Dahiyat Al-Bareed from Al-Ram town.  The Israeli army continues to close with an iron gate the eastern entrance to
