• <u>Settler Violence</u> : At 20:40, an armed Israeli settler pointed his weapons towards a vehicle carrying 3 residents: Hatem Qanibi, Oday Sharabati and Zaki Sharabati near a bypass road in Taqou' during which Israeli forces inspected the 3 residents identification cards then released them at a later time.

	 Closure: (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.
