WEST BANK

• Closure:

- (i) On 06 August 2010, the Israeli army intensified its restrictions at checkpoints located at the entrances to the city of Jerusalem, set up several flying checkpoints in the old city of Jerusalem and around Al Aqsa Mosque compound, and denied access to civilians to perform Friday prayers at the mosque.
- (i) On 05 January 2009, the Israeli authorities issued Military Order # S/02/09 on the closure of and denial of civilian access to the "demarcation area" along the Wall in the area surrounding the city of Jerusalem. Accordingly, local residents and civilians holding permits can access this area through crossings and gates set up at the entrances to the city of Jerusalem. (The demarcation area is defined by a set of military orders relating to land confiscation for Wall construction).
- (ii) The Israeli army continues to impose a blockade and deny civilian access to a hill between the village of Biddu and Beit Iksa due to its geographical significance as it overlooks the city of Jerusalem.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt barricades the entrance to the village of Jaba'.
- (ii) The Israeli army continues to close the iron gate along the Wall section, separating the area of Dahiyat al Bareed from the town of Ar Ram.
- (iii) On 28 May 2010, the Israeli army closed with an iron gate the eastern entrance to the village of Beit Iksa leading to the city of Jerusalem and reported to civilians that they should cross Qalandiya checkpoint to access the city.
- <u>Checkpoint</u>: The Israeli army continues to consider Qalandiya checkpoint a "border crossing point" and has designated a special crossing lane for holders of Jerusalem IDs and those possessing permits to access the city of Jerusalem.
- Raid: At 14:50, the Israeli army raided and patrolled the town of Ar Ram.
- Arrest: At 22:00, Israeli troops positioned at the Jaba' checkpoint on the road connecting the districts of Jerusalem, Ramallah and Jericho arrested Ala' Saleh Hasan Abu Sharifeh.
- <u>Demonstration</u>: On 06 August 2010, a mass demonstration, including international peace activists, took place in the Ash Sheikh Jarrah neighbourhood in the city of Jerusalem in protest against seizure of civilian houses belonging to the Al Ghawi and Hannoun families by Israeli settlers. Participants also protested against Israeli settlement enterprise in East Jerusalem.

• Wall Gates:

JERUSALEM

- (i) The Israeli army continues to close the Wall gate in the town of Abu Dis with cement blocks.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Ash Shayyah road in the area between the villages of As Sawahira ash Sharqiya and As Sawahira al Gharbiya, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.
- Wall Construction: Wall construction continues in the area of Al 'Eizariya to Ash Shayyah, from Beit Surik village to Biddu; in the areas of Al Judeira, Bir Nabala, and Beit Hanina; west of the village of Al Jib; in the vicinity of the village of Qatanna; south of the village of Beit Hanina; and in the area surrounding the checkpoint set up at the entrance to Shu'fat refugee camp.

• Closure of Main Roads:

- (i) The Israeli army continues to close with dirt barricades and cement blocks the entrances to the town of Sinjil, the village of Saffa; and the junction to the villages of Kafr Malik 'Ein Samiya.
- (ii) On 15 March 2010, the Israeli army issued a military order, providing that the area located between civilian houses and the Wall in the town of Ni'lin and the village of Bil'in would be a closed military zone between 08:00 and 20:00 on Fridays for a period of 6 months. To prevent weekly demonstrations against Wall construction, civilian access to the area will be denied except with a special permit.
- Flying Checkpoint: At 23:30, the Israeli army set up a flying checkpoint at the entrance to the village of Kharbatha al Misbah and searched civilians and vehicles.

• Demonstrations/Attacks/Injuries/Detentions:

- (i) At 13:00, a mass demonstration took place in the village of An Nabi Salih against Israeli settler violence and confiscation of civilian land for expansion of the settlement of Halamish. Confrontations took place between the Israeli army and protestors, during which the Israeli army injured a number of participations as a result of tear gas inhalation. In addition, the Israeli army detained 2 international peace activists, including an Italian, and released them at a later time.
- (ii) At 13:30, a mass demonstration, including international peace activists, took place in the town of Ni'lin against Wall construction. Confrontations took place between the Israeli army and protestors, during which the Israeli army wounded a number of participants as a result of tear gas inhalation.
- (iii) At 13:30, a mass demonstration, including international peace activists, took place in the village of Bil'in against Wall construction. Confrontations took place between the Israeli army and protestors, during which the Israeli army injured 2 civilians. Israeli troops also severely beat and injured another civilian. In addition, a number of participants sustained injuries as a result of

	 tear gas inhalation. Wall Construction: Wall construction continues west of the town of 'Abud; in the village of Bil'in; and in the areas of Al Midya to Ni'lin and Ni'lin to Deir Qaddis.
JENIN	 Closure of Main Road: The Israeli army continues to close with dirt barricades the road leading to the town of 'Arraba east of the settlement of Dotan. Wall Gates: Passage through the Wall gates is restricted to civilians granted special Israeli permits, which affects the educational and health conditions of civilians living behind the Wall.
TUBAS	 Checkpoint: Though allowing civilian access to the Northern Jordan Valley between 06:00 and 22:00, the Israeli army continues to intensify its restrictions at Tayasir checkpoint east of the city of Tubas. Flying Checkpoint: At 20:00, the Israeli army set up a flying checkpoint at the entrance to the village of Bardala and searched civilians and vehicles. Demonstration: At 13:00, residents of the village of Yarza performed Friday prayers in the village's mosque, which the Israeli army had threatened to demolish. As was reported on 30 July 2010, the Israeli army distributed notices for the demolition of the mosque as well as 4 civilian houses, claiming that they had been built without the required construction licences in Area C, which is under full Israeli control.
TULKAREM	 Closure of Main Roads: The Israeli army continues to close with dirt barricades the road connecting the town of Kafr al Labad to the village of Shufa as well as the road connecting the villages of Shufa and 'Izbat Shufa. Checkpoint: The Israeli army continues to intensify restrictions at 'Einav checkpoint set up on Tulkarem-Nablus main road. Raids: At 17:40, the Israeli army raided and patrolled the town of Zeita. At 02:00, the Israeli army raided and patrolled the town of Beit Lid. Wall Gates: Passage through the wall gates is restricted to civilians granted special Israeli permits.
QALQILYA	 Closure of Roads: The Israeli army continues to close with cement blocks agricultural roads east of the town of 'Azzun. Flying Checkpoints: At 12:30, the Israeli army set up a flying checkpoint in the area between the town of 'Azzun and the village of 'Asla and searched civilians and vehicles. At 20:15, the Israeli army set up a flying checkpoint at the entrance to the village of An Nabi Elyas and searched civilians and vehicles. At 20:50, the Israeli army set up a flying checkpoint at the entrance to the town of 'Azzun and searched civilians and vehicles. Raids/House Occupations: Beginning at 03:00 on 06 August 2010, the Israeli army has remained positioned in the town of 'Azzun and continued to occupy roofs of 3 civilian houses, which it converted into military posts. The Israeli army

also patrolled the area and withdrew at 24:00.

(ii) At 19:15, the Israeli army raided and patrolled the village of Kafr Oaddum.

• Wall Gates:

- (i) The Israeli army continues to intensify its restrictions at 'Azzun 'Atma Wall gate and to search civilians, including students, with a metal detector.
- (ii) The Israeli army continues close with an iron gate the entrance to the village of Wadi ar Rasha and to deny civilian access. The Israeli army allows residents to access the village through Gate #109. Having removed the iron gate at the entrance to the village of Ras 'Atiya, the Israeli army only allows students to cross to their schools outside the village through the Habla gate.

• Closure of Main Roads:

- (i) The Israeli army continues to close the roads of Till-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osarin; and the detour road between the town of Qabalan and the village of Osarin.
- (ii) The Israeli army continues to close the northern entrance to the town of Qabalan; the southern entrances to the villages of Duma and Qaryut; and the western entrance to An Naqura village opposite Shavei Shomron settlement.
- <u>Checkpoints</u>: The Israeli army continues to regulate times for crossing checkpoints set up around the city of Nablus:
- (i) At Tur neighbourhood checkpoint (set up on Jerzim Mount) is closed on Fridays and Saturdays as well as during Jewish holidays. On all other days, it is open for civilian residents of the neighbourhood only between 07:00 and 02:00.
- (ii) At 'Awarta commercial checkpoint, civilians are allowed to cross between 05:00 and 20:00, but between 05:00 and 15:00 on Fridays. All civilian vehicles are allowed to access the city of Nablus, but only commercial vehicles and ambulances can leave the city through the checkpoint.

• Flying Checkpoints:

- (i) At 09:25, the Israeli army set up a flying checkpoint on the junction to the villages of Yasid and Beit Imrin and searched civilians and vehicles.
- (ii) At 17:05, the Israeli army set up a flying checkpoint on the junction to the villages of Till and 'Iraq Burin and searched civilians and vehicles.
- <u>Settler Violence/Destruction of Property</u>: At 09:00, a group of Israeli settlers set fire to civilian farmland in the village of Yanun east of the town of 'Aqraba. The fire later extended to farmland in the area of At Taramiq in the town of Beit Furik, damaging hundreds of olive trees. Israeli settlers also denied access to Palestinian Civil Defence fire engines to extinguish the fire.

- Closure of Main Roads: The Israeli army continues to close with dirt barricades the road of Beit Jala-Wadi Ahmad; a road east of the town of Beit Fajjar; and an agricultural road connecting the town of Tuqu' to the village of Khirbet al Baq'a.
- <u>Checkpoint</u>: At 22:15, the Israeli army intensified its restrictions at As Sawahira ash Sharqiya (the 'Container') checkpoint and impeded civilian access
- Flying Checkpoint/Physical Assault: At 15:30, the Israeli army set up a flying checkpoint on An Nashash junction (the southern entrance to the city of Bethlehem) and searched civilians and vehicles. Israeli troops detained a civilian vehicle and severely beat driver Yousef Ya'qoub Da'dou', leaving him with contusions. As a result, Da'dou' was admitted to hospital for medical treatment.

• Raids/Detentions:

- (i) At 09:00, the Israeli army raided the town of Tuqu', searched a house, detained 3 civilians, and released them after coordination with the Israeli authorities (through the DCO). At 19:20, the Israeli army withdrew from the area.
- (ii) At 22:30, the Israeli army raided the town of Beit Fajjar and patrolled the area until 23:00.

• Demonstrations/Physical Assaults:

- (i) At 11:00, a mass demonstration, including international peace activists, took place in the village of Artas in protest against Wall construction.
- (ii) At 13:55, a mass demonstration, including international peace activists, took place in the village of Al Ma'sara in protest against Wall construction. Having obstructed the demonstration, Israeli troops severely beat a number of participants and denied access to the Wall construction site.
- <u>Wall Construction</u>: Wall construction continues in the area northwest of the town of Al Khadr; northwest of the city of Beit Jala; in the area of Wadi Rahhal east of Efrat settlement; and in the area surrounding Al Walaja.

• Closure:

HEBRON

- (i) The Israeli army continues to close the following locales in the old city of Hebron: Ash Shuhada' Street and the area of As Sahleh with cement blocks and barbed wire; the old gold market with an iron gate; the area of Khuzq al Far near the settlement of Abraham Avino with a dirt barricade and an iron gate; and the entrance to the area of Al Khan with an electronic gate, isolating the area from Al Laban Market and the area of As Sahleh. In addition to closing the entrance to Al Laban Market with iron plates, the Israeli army continues to install an iron gate at the entrance to the area of Al Hisba (the fruits and vegetables market) in the old city of Hebron, controlling civilian access in the area.
- (ii) Having evacuated civilian residents and denied civilian access, the Israeli army continues to close the area located along the Green Line south of the town of Yatta.

Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks the entrance to the town of As Samoa'; the eastern entrance to the village of Kharsa; the entrance to the Al Qeisi neighbourhood in the old city of Hebron; the entrances to Al 'Arrub refugee camp, the village of At Tuwani, and the town of Adh Dhahiriya; and the road connecting the town of Surif to the village of Al Jab'a.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along Ash Shalala Old Street in the old city of Hebron.
- (iii) The Israeli army continues to close with dirt barricades the road between the villages of Al Karmil and At Tuwani and all roads leading to Road # 60.
- <u>Flying Checkpoint</u>: At 23:00, the Israeli army set up a flying checkpoint on the junction to the village of Kharsa and searched civilians and vehicles.
- **Physical Assault:** Israeli troops severely 'Isam Mohammed al Huroush, 16 years old, while he was present inside the Green Line, leaving him with contusions. At 11:00, Al Huroush was admitted to Yatta Hospital.

• Raids/Physical Assaults:

- (i) At 12:00, the Israeli army raided Al 'Arrub refugee camp. Confrontations took place between the Israeli army and civilians. At 19:20, the Israeli army raided the refugee camp for the second time and confrontations took place between the Israeli army and civilians again. Israeli troops also severely beat 2 children:
 - (i) Omar al Hudoush, 12 years old; and
 - (ii) Ihab Hasan, 13 years old.
- (ii) At 16:10, the Israeli army raided and patrolled the village of Deir Samit.
- (iii) At 16:10, the Israeli army raided and patrolled the town of Adh Dhahiriya. At 00:05, the Israeli army raided the town again, set up a checkpoint, searched civilians and vehicles, and patrolled the area.
- (iv) At 18:00, the Israeli army raided and patrolled the town of Dura.
- (v) At 02:10, the Israeli army raided and patrolled the town of As Samoa.

• Settler Violence/Physical Assaults/Attack/Injuries:

- (i) At 10:30, a group of Israeli settlers severely beat 5 civilians, including 3 children, in the area of Al Buweira east of the city of Hebron, leaving them with contusions:
 - (i) Nour Saleem ash Sha'rawi, 3 years old;
 - (ii) Zeina Saleem ash Sha'rawi, a 4-year-old girl;
 - (iii) Usamah Saleem ash Sha'rawi, 4 years old;
 - (iv) Suzan Sufvan Sultan, a female civilian; and
 - (v) Ala' Sufyan Sultan.

All affected civilians were transported to hospital for medical treatment.

- (ii) At 14:15, a group of Israeli settlers severely beat Suzan Jamil Sultan, a female civilian, as well as a Danish and Canadian peace activists in the area of Al Buweira east of the city of Hebron. Having sustained contusions, the female civilian and international activists were transported to hospital for medical treatment.
- (iii) At 21:00, a group of Israeli settlers attacked a number of civilian houses

belonging to the families of Al Ja'bari, Az Za'tari, and Sultan in the area of Al Buweira east of the city of Hebron. The Israeli army fired sound grenades on civilians, who confronted settlers, injuring 2 civilians:

- Sharif Abdul Rahman Sultan; and (i)
- Hamman Sultan. (ii)

The Israeli army also injured 2 civilians.

- Arrests: The Israeli army arrested 2 civilians in the area of Al Buweira east of the city of Hebron:
- (i) 'Isa 'Amr; and
- Samer Sultan. (ii)
- Wall Construction: Wall construction continues in the section of Tarqumiya checkpoint terminal; in the area surrounding the settlement of Eshkolot near the town of Adh Dhahiriya; and in the area between the villages of 'Arab ar Ramadin and Imneizil.

ALL DISTRICTS	• At 02:00 on 18 January 2009, the unilateral ceasefire declared by the Israeli authorities came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire for a week. Later, armed Palestinian groups extended the ceasefire until 05 February 2009. Despite the fact that the extension period expired, the ceasefire continues to hold pending negotiations carried out by Egypt.
