WEST BANK

• Closure:

- (i) The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

• Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

• Flying Checkpoint:

- (i) At 22:00, Israeli forces set up a checkpoint in Ain Al-Louza area in Silwan neighbourhood.
- (ii) At 01:40, Israeli forces set up a checkpoint at Jaba' village junction.

• <u>Raid:</u>

- (i) At dawn on August 10th 2015, Israeli forces raided Al-Eisawiya village and detained three residents.
- (ii) At 04:00, Israeli forces raided Qutna village and clashed with several residents.

• Detention:

- (i) At 09:00, Israeli forces detained Mu'taz Al-Sa'ou in Al-Sheikh Jarrah neighbourhood for allegedly stoning the light train railway.
- (ii) Israeli forces detained three residents: Mahmoud Muhsien, Ali Muhsin and Oday Dari in Al-Eisawiya village.
- <u>Temporary Detention:</u> At 16:00, Israeli forces temporarily detained Mo'ayad Al-Hashim (A security Guard at Al-Aqsa Mosque compound) then released him after assaulting him and as a result left him hospitalised with a broken arm.
- **Expulsion:** On August 10th 2015, Israeli courts ordered that Abdel-Rahman Barakat to be expelled from Al-Aqsa Mosque compound for a period of 3 months.

• Closure:

- (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village.
- (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities.

• Closure of Main Roads:

- (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala; Wadi Rahal road near "Ifrat" settlement, the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds.
- (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks.
- (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla.
- (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
- (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.
- (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
- (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds
- (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.

• Raid:

- (i) At 18:30, Israeli forces raided Tagou' and detained a child.
- (ii) At 06:00, Israeli forces raided Bethlehem and detained a resident.

• Detention:

- (i) Israeli forces detained Hazem Sabah (13 years old) in Taqou for alleged stoning.
- (ii) Israeli forces detained Ma'moun Ta'amreh in Bethlehem.
- Attack: At 15:50, Israeli forces positioned near Al-Ayda camp in Bethlehem fired stun and tear gas grenades towards several residents for alleged stoning.

• Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

- (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and also closed the entrance of south Yatta with cement blocks.
- (vi) At 11:00 on August 6th 2015, Israeli forces closed Al-Hajjra village located in south Dura with dirt mounds.

• Raid:

- (i) At 09:20, Israeli forces raided Hebron, detained a resident then withdrew at 12:00.
- (ii) At 11:30, Israeli forces raided Al-Rohat village located in south Al-Thahriya, demolished a 2 livestock sheds owned by Rajeh Al-Samarneh for allegedly being built without a licence because of its location in Area C which is under Israeli Military and Administrative control.
- (iii) At 01:45, Israeli forces raided Deir Sammit village, stormed and searched a home then withdrew at 03:10.
- (iv) At 02:50, Israeli forces raided Al-Samou' then stormed and searched a home.
- (v) At 03:20, Israeli forces raided Al-Tabaqa village and detained a resident.

• Detention:

- (i) At 19:10, Israeli forces positioned at "Mitar" crossing located along the Green Line in south AL-Thahriya detained the child Yasmin Abu Sarour (17 years old){A Resident of Bethlehem} for allegedly carrying a knife as she was travelling to visits her brother in Israeli prisons.
- (ii) Israeli forces detained Munjid Al-Ja'bari in Hebron.
- (iii) Israeli forces detained Husam Abu Ras in Al-Tabaqa village.

• Physical Assault:

- (i) At 19:20, Israeli forces positioned in Tel Al-Rumayda neighbourhood in the old city of Hebron assaulted the child Alaa Shabaneh (15 years old) and as a result, left him hospitalised with contusions.
- (ii) At 21:55, Israeli forces positioned near Al-Shallalat road in the old city of Hebron assaulted Ma'moun Al-Natsheh and as a result, left him hospitalised with contusions.
- <u>Destruction of Property:</u> At 10:10, Israeli forces stormed Ma'ali area located in south Al-Thahriya and demolished a livestock shed owned by Odah Abu Sharkh for allegedly being built without a licence because of its location in area C which is under Israeli Military and Administrative control.

At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by ALL the end of the year and to decrease the Military area to 100 meters, allow freedom of DISTRICTS movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. Israeli Naval vessels broke the ceasefire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza and Gaza. Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical patients, journalists, NGO staff, businessmen and passengers travelling abroad **NORTHERN** through Al-Karama crossing with previous coordination. Attack: On the morning of August 11th 2015, Israeli Naval vessels opened fire **GAZA** towards Palestinian fishing boats off the shores of AL-Sudaniya beach located in West Beit Lahiva **Closure of Crossing Points:** (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. (ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision. **GAZA Attack:** At 07:00 on August 10th 2015, , Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Gaza and temporarily detained 2 fishermen: Mohammad Al-Sharafi and Mohammad Al-Sa'edi then released them after confiscating their fishing boat. **<u>Detention:</u>** At 20:00, Israeli forces detained 3 unidentified residents as they were **CENTRAL** attempting to climb they border fence into Israel from east area of Al-Maghazi camp. **GAZA Closure of Crossing Points:** (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (Al 'Awdah) Crossing is closed. **RAFAH** (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is open for the entry of tourist and foreign diplomats and the entry of Humanitarian assistance and construction material funded by UNRWA.
