| | • <u>Wall Construction</u> : Wall construction continues in the area of Al 'Eizariya to Ash Shayyah, from Beit Surik village to Biddu; in the areas of Al Judeira, Bir Nabala, and Beit Hanina; west of the village of Al Jib; in the vicinity of the village of Qatanna; south of the village of Beit Hanina; and in the area surrounding the checkpoint set up at the entrance to Shu'fat refugee camp. |

| RAMALLAH & EL BIREH | <u>Closure of Main Roads</u>: The Israeli army continues to close with dirt barricades and cement blocks the entrances to the town of Sinjil, the village of Saffa; and the junction to the villages of Kafr Malik – 'Ein Samiya. On 15 March 2010, the Israeli army issued a military order, providing that the area located between civilian houses and the Wall in the town of Ni'lin and the village of Bil'in would be a closed military zone between 08:00 and 20:00 on Fridays for a period of 6 months. To prevent weekly demonstrations against Wall construction, civilian access to the area will be denied except with a special permit. <u>Flying Checkpoint</u>: At 19:30, the Israeli army set up a flying checkpoint on the junction to the village of Deir Ibzi' and searched civilians and vehicles. <u>Wall Construction</u>: Wall construction continues west of the town of 'Abud; in the village of Bil'in; and in the areas of Al Midya to Ni'lin and Ni'lin to Deir Qaddis. |

| ALL DISTRICTS | At 02:00 on 18 January 2009, the unilateral ceasefire declared by the Israeli authorities came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire for a week. Later, armed Palestinian groups extended the ceasefire until 05 February 2009. Despite the fact that the extension period expired, the ceasefire continues to hold pending negotiations carried out by Egypt. <u>Violations of the Ceasefire:</u> (i) The Israeli army raided Palestinian territory and opened fire on civilian houses and property in the districts of Khan Yunis and Rafah. The Israeli army opened fire and fired artillery shells from its location on the Green Line towards Khan Yunis district. Israeli F16 combat aircraft fired missiles on Gaza, Khan Yunis, and Rafah, resulting in the injury of 2 civilians. (ii) Armed Palestinian individuals fired 2 mortars towards the Green Line. |
