ALL DISTRICTS	• The Israeli army continues to intensify its restrictions at checkpoints set up on the main roads connecting the West Bank districts, thereby isolating the northern districts from the southern districts as well as the Jericho district and the Jordan Valley from the remainder of the West Bank.
JERUSALEM	<ul> <li>Closure: <ul> <li>On 28 August 2009, the Israeli army intensified its restrictions at checkpoints located at the entrances to the city of Jerusalem, set up several flying checkpoints in the old city of Jerusalem and around AI Aqsa Mosque compound, and denied access to civilians to perform Friday prayers in the first week of the holy month of Ramadan at the mosque. However, the Israeli army only allowed access to male civilians above 50 years of age and female civilians above 45 years as well as to male and female civilians, who hold access permits and are above 45 and 30 years of age respectively. As a result, many civilians performed prayers on streets and near checkpoints set up at entrances to the city of Jerusalem. In addition, the Israeli army released an aerostat equipped with a camera over the AI Aqsa Mosque compound. An Israeli combat helicopter also patrolled the skies over the compound and watched worshippers.</li> <li>On 05 January 2009, the Israeli authorities issued Military Order # S/02/09 on the closure of and denial of civilian access to the "demarcation area" along the Wall in the area surrounding the city of Jerusalem. Accordingly, local residents and civilians holding permits can access this area through crossings and gates set up at the entrances to the city of Jerusalem. Having access to the Wall construction site denied, Israeli troops severely beat protestors with clubs and rifle butts, leaving 9-year-old Usamah Iyad Breijiyyeh with injuries and contusions.</li> <li><u>Wall Construction</u>: Wall construction continues in the area northwest of the town of Al Khadr; northwest of the city of Beit Jala; in the area of Wadi Rahhal east of Ifrat settlement; and in the area surrounding the village of Al Walaja.</li> </ul>
HEBRON	<ul> <li>Closure: <ul> <li>(i) The Israeli army continues to close the following locales in the old city of Hebron: Ash Shuhada' Street and the area of As Sahleh with cement blocks and barbed wire; the old gold market with an iron gate; the area of Khuzq al Far near the settlement of Abraham Avino with a dirt barricade and an iron gate; and the entrance to the area of Al Khan with an electronic gate, isolating the area from Al Laban Market and the area of As Sahleh. The Israeli army also continues to install an iron gate at the entrance to the area of Al Hisba (the fruits and vegetables market) in the old city of Hebron, thereby controlling civilian access in the area.</li> <li>(ii) On 05 January 2009, the Israeli army issued Military Order # 09/06/S for closure of the area located along the Green Line south of the town of Yatta, evacuation of civilian residents, and prevention of civilian access to the area. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire for a week. Later, armed Palestinian groups extended the ceasefire until 05 February 2009.
