#### **WEST BANK**

### • Closure:

- (i) The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

### • Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

### • Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
- (ii) On September 19<sup>th</sup> 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

## • Raid: At dawn on August 30<sup>th</sup> 2015, Israeli forces raided Al-Eisawiya village and detained two residents.

• <u>Detention:</u> Israeli forces detained Mahmoud Abdel-Raouf Mahmoud and Ameid Obied in Al-Eisawiya village.

### • Attack:

- (i) At 14:00, Israeli forces positioned in "Koghav Yacoub" settlement in east Kafr Aqab village fired stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 21:10, Israeli forces positioned near Al-Ram junction fired stun and tear gas grenades towards several residents for alleged stoning.
- **Physical Assault:** On the evening of August 29<sup>th</sup> 2015, Israeli forces positioned near Shu'fat checkpoint assaulted and electrocuted him using a Taser Ahmad Alqam and as a result, left him hospitalised with contusions.
- <u>Settler Violence:</u> At 21:00, a group of Israeli settlers positioned near "Rakhis Shufat- Ramot Shlomo" settlement located near Shufat camp stoned a vehicle owned by Abdel-Karim Abu Khdeir (A resident of Shufat) and as a result shattered the front windshield of the vehicle and as a result left him hospitalised with a hand injury.

### • Wall Gates:

- (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

#### **Closure:**

- (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village.
- Since 15 September 2007, the Israel army has prevented civilians from (ii) accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities.

### **Closure of Main Roads:**

- (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Oumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala; Wadi Rahal road near "Ifrat" settlement, the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds.
- The Israeli army continues to close the road leading to "Newe Daniyyel" (ii) settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Tagou and Khirbet Al-Deir with cement
- Since August 2<sup>nd</sup> 2012, Israeli forces closed a road leading to Beit Jalla. (iii)
- Since May 8<sup>th</sup> 2013, Israeli forces closed the road connecting Al-Carmisan area (iv) in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
- Since June 3<sup>rd</sup> 2013, the Israeli army closed the road connecting Nihalin and (v) road 60 with dirt mounds.
- Since 13:20 on September 29th 2013, the Israeli army closed a road leading to (vi) 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
- Israeli forces closed the main road connecting Surif and Al-Jub'a village with (vii)
- On January 28th 2014, Israeli forces closed the steel gate at the entrance of (viii) Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.
- Flying Checkpoint: At 21:30, Israeli forces set up a checkpoint at the west entrance of Tagou' until 23:30.
- Raid: At 01:00, Israeli forces raided Marah Rabah village, summoned two residents: Numan AL-Shiekh and Alaa Al-Shiekh to report to Israeli intelligence for questioning then withdrew at 01:50.
- Attack: At 17:00, Israeli forces positioned near Al-Ayda camp in Bethlehem fired stun and tear gas grenades towards several residents for alleged stoning

### **Closure:**

- (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

### Closure of Main Roads:

### **HEBRON**

**BETHLEHEM** 

(i) The Israeli army continues to close the entrances to Al-Tuwani and Al-Karmil villages.

- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.
- (vi) At 11:00 on August 6<sup>th</sup> 2015, Israeli forces closed Al-Hajjra village located in south Dura with dirt mounds.
- <u>Flying Checkpoint:</u> On the evening of August 29<sup>th</sup> 2015, Israeli forces set up a checkpoint near Zif village junction and opened fire towards a vehicle for allegedly attempting to run over an Israeli soldier before fleeing.
- Raid:
  - (i) At 10:40, Israeli forces raided Al-Karmil village until 12:00.
  - (ii) At 23:00, Israeli forces raided Tarqumiya.
  - (iii) At 03:00, Israeli forces raided Hebron.
- <u>Temporary Detention:</u> At 13:00, Israeli forces positioned along Al-Shuhada road located in the old city of Hebron temporally detained Hisham Assib after assaulting him then released him later.
- <u>Detention:</u> Israeli forces detained Yusef Baraghith and Mahmoud Baragith in Beit Ummar.
- <u>Demonstration</u>: At 11:00, a demonstration took place near "Beit Al-Baraka" hospital in Al-Urub camp protesting against the Israeli Authorities decision to demolish the hospital confiscate the land and build a settlement project on the site during which Israeli forces prevented protestors from reaching the demonstration site and declares the area a closed military zone and as a result injured 4 residents: Yusef Abu Mariya, Rateb Al-Jobar, Yadi' Quweik and Yunis Arrar.

### **GAZA STRIP**

### ALL DISTRICTS

- At 19:00 on August 26<sup>th</sup> 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month.
- Israeli Naval vessels broke the ceasefire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza and Rafah.

**Closure of Crossing Point:** Beit Hanun (Erez) is closed.

### • Attack:

### NORTHERN GAZA

- (i) At 08:40, Israeli naval vessels opened fire towards Palestinian fishing boats off the shores of Al-Sudaniya beach located in west Beit Lahiya.
- (ii) At dawn on August 30<sup>th</sup> 2015, Israeli naval vessels opened fire towards Palestinian fishing boats off the shores of Al-Waha beach located in North West Beit Lahiya.

GAZA	Closure of Crossing Points:     (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision.
