WEST BANK

• Closure:

- (i) The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city for the alleged stabbing of an Israeli settler.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

• Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and impeded the free flow of traffic.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

• Raid:

- (i) At dawn on December 1st 2014, Israeli forces raided Al-Ram, stormed and searched a home after breaking down the main entrance door and detained a resident.
- (ii) At 08:00, Israeli forces raided Al-Eisawiya village, clashed with several residents and as a result injured an unidentified resident.
- (iii) At 22:00, Israeli forces raided Biddo village and detained two residents.
- (iv) At 03:30, Israeli forces raided Qalandiya camp and detained three residents including a Police officer.

• Detention:

- (i) On the morning of December 1st 2014, Israeli forces detained three residents including a child: Yazen Najdi (17 years old), Saed Najdi and Rami Najdi in Ras Al-Amoud neighbourhood in Jerusalem.
- (ii) On the morning of December 1st 2014, Israeli forces detained Mohammad Abu Shusheh after storming his home in Wadi Al-Juz neighbourhood in Jerusalem.

JERUSALEM

- (iii) On December 1st 2014, Israeli forces detained four residents: Ali Ibrahim Al-Abbassi {after being assaulted by Israeli forces}, Ali Ahmad Abbassi, Imad Ahmad Abbassi and Mohammad Ahmad Abbassi as they were attending the trail of Omar Al-Abbassi at a court in Jerusalem during which Israeli forces assaulted Mohammad Abbassi and his mother.
- (iv)On December 1st 2014, Israeli forces detained Thaer Abu Sbieh (A resident of Jerusalem) after suffering an eye injury during confrontations with Israeli forces
- (v) At 01:30, Israeli forces detained two residents: Rami Assad and Mohammad Abdou in Jabal Al-Mukabir neighbourhood.
- (vi) At 01:30 on December 2nd 2014, Israeli forces detained three residents: Obada Dandis, Ahmad Najdi and Mohammad Najdi in Silwan and Ras Al-Amoud neighbourhoods.
- (vii)Israeli forces detained Hamzah Jabr in Al-Ram.
- (viii) Israeli forces detained two residents: Lou'ay Al-Kahdour and Adham Tabankhah in Biddo.
- (ix) Israeli forces detained three residents: Mohammad Khalil (A Palestinian Police officer), Munif Taha and Mohammad Asslan in Qalandiya camp.
- <u>Attack:</u> At 22:00, Israeli forces positioned near Silwan, Al-Tur, Bab Hataa and Al-Sa'adeh neighbourhood fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- <u>Home Demolition:</u> At 13:00, Israeli forces stormed Silwan and served a demolition order to demolish a home owned by Sami Al-Rajabi.
- Assault on Medical Sector: At 08:00, Israeli forces raided Al-Tur neighbourhood in Jerusalem and stormed and searched Augusta-Victoria (Al-Mutala') hospital
- <u>Assault on Places of Worship:</u> On the morning of December 1st 2014, Israeli settlers under the protection of Israeli Police and Military stormed Al-Aqsa mosque compound and provoked worshipers.
- <u>Settler Violence</u>: At 15:30, Israeli settlers sprayed pepper spray onto the face of a resident as he was driving his vehicle and as a result left him hospitalised with burnt eyes and suffocation.

• Wall Gates:

- (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages.
- (ii) Since September 3rd 2013, Israeli forces closed the north east entrance of Al-Mughier village with dirt mounds.
- (iii) At 22:30 on November 28th 2014, Israeli forces closed the entrance of Beit Illu village with cement blocks.

• Flying Checkpoint:

- (i) At 09:30, Israeli forces set up a checkpoint at the entrance of Rantis village until 10:20.
- (ii) At 20:05, Israeli forces set up a checkpoint at Yabrud Village Bridge until 21:20.
- (iii) At 20:45, Israeli forces set up a checkpoint at Atara Bridge until 23:30.
- (iv) At 20:45, Israeli forces set up a checkpoint at the entrance of Al-Nabi Saleh village until 23:30.

- (i) At 08:30, Israeli forces set up a checkpoint in Ush Al-Ghurab area located in east Beit Sahur until 09:40.
- (ii) At 11:50, Israeli forces set up a checkpoint at the east entrance of Marah Rabah village until 14:30.
- (iii)At 17:50, Israeli forces set up a checkpoint in Aqbat Hassna area located along the main road leading to the villages in west Bethlehem until 20:00.

• Raid:

- (i) At dawn on December 1st 2014, Israeli forces raided Taqou' and detained a child
- (ii) At 08:50, Israeli forces raided Bethlehem until 09:15.
- (iii)At 09:30, Israeli forces raided Taqou', occupied Nayef Salamin's home and converted its rooftop into a military post and again at 00:50 Israeli forces stormed and searched 2 homes then withdrew at 00:50.
- (iv)At 12:00, Israeli forces raided Beit Fajjar and Marah Rabah village, imposed a curfew, clashed with several residents after storming and searching homes, temporarily detained 3 residents: Jihad Taqatqa, Khalil Taqatqa and Ali Taqatqa and released them at a later time then withdrew at 14:40.
- (v) At 14:50, Israeli forces raided Khirbiet Al-Deir village located near Taqou', occupied Awad Sulimans home and converted its rooftop into a military post then withdrew at 16:10.
- (vi)At 16:30, Israeli forces raided Al-Khadr, clashed with several residents as they stormed and searched a Bakery and Supermarket and confiscated surveillance camera tapes and summoned Ahmad Salah to report to Israeli Intelligence for questioning then withdrew at 17:30.
- (vii)At 16:55, Israeli forces raided Bethlehem and stormed a merchant shop.
- (viii) At 03:500, Israeli forces raided Wadi Fuqin village, stormed several homes, detained three residents including a child then withdrew at 05:05.
- <u>Injury:</u> At 10:55, Amal Taqatqa (A resident of Beit Fajjar) was hospitalised with critical injuries after Israeli forces opened fire towards her near "Kafar Itsiyon" settlement junction for allegedly attempting to stab an Israeli settler.

• <u>Detention:</u>

- (i) Israeli forces detained Ali Sabah (16 years old) in Taqou'.
- (ii) Israeli forces detained three residents: Muhanad Haroub (17 years old), Mazen Mannasrah and Malik Manassrah in Wadi Fuqin village.
- <u>Attack:</u> At 11:50, Israeli forces positioned near Al-Khadr fired stun and tear gas grenades towards several children for alleged stoning.

• Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the

HEBRON

Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.
- (vi) On September 4th 2014, Israeli forces closed a road in Eiwn Al-Bas and Al-Bayda and Al-Ras area in Ithna locat6ed near the wall gate.
- (vii)At 13:40 on September 16th 2014, Israeli forces closed the main road leading to Al-Ibrahim mosque in the old city of Hebron.

• Flying Checkpoint:

- (i) At 08:00, Israeli forces set up a checkpoint at Halhul Bridge.
- (ii) At 17:00, Israeli forces set up a checkpoint at the entrance of Al-Fuwar camp and detained a resident.

• Raid:

- (i) At 07:40 on December 1st 2014, Israeli forces raided Deir Sammit village until 08:00.
- (ii) At 20:50, Israeli forces raided Hebron, stormed several homes and set up a checkpoint.
- (iii)At 02:20, Israeli forces raided Al-Thahriya and detained two residents then withdrew at 05:00.
- (iv)At dawn on December 2nd 2014, Israeli forces raided Beit Ummar and detained a resident after storming his home.

• Detention:

- (i) Israeli forces detained Amin Bayad at the entrance of Al-Fuwar camp.
- (ii) Israeli forces detained two residents: Sami Sharkh and Abdallah Sharkh in Al-Thahriya.
- (iii) Israeli forces detained Amin Sabarneh in Beit Ummar.
- <u>Attack:</u> At 20:10, Israeli forces positioned near Al-Urub camp fired stun and tear gas grenades towards several residents for alleged stoning.

- At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month.
- Israeli forces broke the cease-fire agreement by opening fire towards Khan Yunis.
