JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) On 28 November 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshippers under the age of 50 from conducting prayers at Al-Aqsa mosque compound which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem according to Military Order 09/02S and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Ikksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Ikksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. (iii) On 16 November 2015, Israeli forces closed the southern entrance of Jabal Al-Mukabir neighbourhood leading to Armon Hanatsif settlement with cement blocks. (iv) At 15:15 on 29 November 2015, Israeli forces closed a road near Panorama Hotel in Ras Al-Amud neighbourhood in Jerusalem with cement blocks. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city. (ii) On 19 September 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. • <u>Raids:</u> <ul style="list-style-type: none"> (i) At 20:35 Israeli forces raided Hizma village, demolished and confiscated caravans used to exhibit cars owned by civilian Jareh Farouk Salaheddin, and demolished a gas station owned by civilian Mustafa Hassan, searched dozens of civilian homes, arrested 14 civilians (including 1 child and closed all entrances to the village, and are present in the village until the time of preparation of this report. (ii) At 01:30, Israeli forces raided and patrolled Anata town. (iii) At 03:10, Israeli forces raided Qalandia refugee camp, closed all entrances to it and searched the home of prisoner Nidal Samara. • <u>Arrests:</u> <ul style="list-style-type: none"> (i) At 13:00, Israeli forces arrested lawyer Tareq Barghout in Jerusalem. (ii) At the 14 civilians arrested in Hizma are: Ismail Abed Rabbo Al-Khatib, 15, Ahmad Odeh Askar, 55, Jaber Mohareb Salaheddin, 72, Arwa Ahmad Askar, Rajai Jaber Mohareb Salaheddin, Fadi Mohammad Najeeb, Daoud

	<p>Mohammad Najeeb, Abdallah Abed Rabbo Al-Khatib, Mohammad Ali Al-Khatib, Usama Ali Al-Khatib, Usay Abed Rabbo Al-Khatib, Rashed Mohammad Salaheddin, Kifah Sleiman Rizek and Jihad Mubarak Salaheddin.</p> <ul style="list-style-type: none"> • <u>Attacks:</u> <ul style="list-style-type: none"> (i) At 19:00, Israeli forces near Maqassed Hospital on Mt. Of Olives in Jerusalem fired tear gas canisters at civilians for alleges stoning and injured a female civilian and a child. Two gas canisters fell inside the ICU and children wing in the hospital. (ii) At 21:00, Israeli forces fired tear gas canisters towards civilians in the Old City of Jerusalem for alleged stoning. • <u>Home Demolition:</u> At 07:40 on 01 December 2015, Israeli forces demolished in Ashqariyye neighbourhood in Beit Hanina in Jerusalem 2 homes under the pretext of unlicensed construction owned by Fawaz and Rasem Al-Rajabi. • <u>Attacks on Places of Worship:</u> At 08:00, Jewish settlers backed up by Israeli forces raided Al-Aqsa Mosque compound and provoked worshippers. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.
<p>RAMALLAH & AL BIREH</p>	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and ‘Ein Samiya villages (ii) On 3 October 2015, Israeli forces closed the main road located near “Bet El” settlement and leading to Al-Jalazoun camp with cement blocks. (iii) On 24 November 2015, Israeli forces closed the main entrance gate leading to Sinjil and the east entrance of Mughier with cement blocks. • <u>Checkpoints:</u> At 13:50, Israeli forces closed Al-Mahkama checkpoint north of Al-Bireh and impeded free flow of traffic until 17:00 • <u>Flying Checkpoints:</u> <ul style="list-style-type: none"> (i) At 12:55 and 18:25, Israeli forces set up a checkpoint at the entrance of Beit Ur Al-Foqa and searched residents and vehicles until 23:00. (ii) At 22:20, Israeli forces set up a checkpoint in Ein Ayoub area near Deir Ammar village and searched residents and vehicles until 00:40. • <u>Raids:</u> <ul style="list-style-type: none"> (i) At 23:35, Israeli forces raided Al-Bireh city and opened fire towards Al-Soudani building (under construction) and patrolled the area until 24:00. (ii) At 03:40, Israeli forces raided Deir Ammar refugee camp, clashed with civilians, stormed into civilian homes, arrested 3 civilians and withdrew at 04:55. • <u>Arrests:</u> The three civilians arrested in Deir Ammar refugee camp are Sami Mohammad Asi, Rajai Hussein Abdel Qader and Looui Al-Khalidi Safi. • <u>Attacks:</u> <ul style="list-style-type: none"> (i) At 13:05, Israeli forces positioned at Al-Mahkama checkpoint near bet El settlement north of Ramallah fired rubber coated steel bullets, stun and tear gas grenades towards several residents (who were protesting against the continued Israeli Military and Settler assault on Al-Aqsa mosque compound) for alleged stoning. (ii) At 14:05, Israeli forces positioned near the entrance of Silwad town fired stun and tear gas grenades towards several residents for alleged stoning.

	<p>road leading to the town of ‘Arraba east of the illegal settlement Dotan.</p> <ul style="list-style-type: none"> • <u>Flying Checkpoints:</u> At 17:20, Israeli forces set up a checkpoint at the junction of Rumana village and searched civilians and vehicles. • <u>Raids:</u> At 04:10 on 1 December 2015, Israeli forces raided Qabatia town and arrested 1 civilian. • <u>Arrests:</u> The civilian arrested in Qabatia is Amjad Saleh Al-Nobani. • <u>Wall Gates:</u> Israeli forces continue to close the wall gate and only allow those holding special permits to enter through it.
TULKAREM	<ul style="list-style-type: none"> • <u>Checkpoints:</u> At 23:45, Israeli forces continue to intensify their restrictions at “Eniv” checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic. • <u>Flying Checkpoints:</u> <ul style="list-style-type: none"> (i) At 08:45, Israeli forces set up a checkpoint near the junction of Shofa village and searched civilians and vehicles until 11:15. (ii) At 15:20, Israeli forces set up a checkpoint at the junction of Safarin village and searched civilians and vehicles. • <u>Killing:</u> At 09:55, female civilian Maram Ramez Hassouneh from Nablus was shot dead by Israeli forces at Einav checkpoint for allegedly stabbing an Israeli soldier. • <u>Attacks:</u> At 12:25, Israeli forces positioned at gate 104 near the Separation Wall west of Tulkarem fired rubber coated bullets, tear gas canisters and stun grenades towards civilians for alleged stoning and injured several university students from Kadouri University including a student called Anas Mousa Ismail from Dura in Hebron. The Israeli forces arrested 1 university student. • <u>Arrests:</u> The civilian arrested during clashes at Gate 104 west of Tulkarem is a university student called Abdel Rahim Fathi Abu Kamle from Anabta.
QALQILIYA	<ul style="list-style-type: none"> • <u>Closure of Roads:</u> <ul style="list-style-type: none"> (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) Since 10:40 on 1 September 2015, Israeli forces closed an agricultural road leading to Far’ata village which is located near “Gillad” settlement with a steel gate. • <u>Flying Checkpoints:</u> <ul style="list-style-type: none"> (i) At 22:10, Israeli forces set up a checkpoint on the main Qalqilya-Nablus road and searched civilians and vehicles until 22:55. (ii) At 23:55, Israeli forces set up a checkpoint near Hijje village and searched civilians and vehicles until 01:30. • <u>Raids:</u> <ul style="list-style-type: none"> (i) At 12:50, Israeli forces raided Nabi Elias village and stormed into several commercial stores. (ii) At 22:10, Israeli forces raided Imatin village, stormed into 2 barracks and fired illumination bombs and combed the area under the pretext of throwing Molotov cocktail at a settlers’ vehicle on Qalqilya-Nablus main road. Israeli forces withdrew at 00:10. • <u>Temporary Detention:</u> At 16:00, Israeli forces detained 3 children near Jaljoulia checkpoint southeast Qalqilya: Ahmad Ghassan Atawneh, 15, Izzedin Youssef Wael Youssef Nofal, 12, and Yazan Hassan Rahayleh, 10, and released them at a later time. • <u>Attacks:</u> At 13:30, Israeli forces guarding the Separation Wall alongside the west side of Qalqilya city fire rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning. Gas canister fell inside the home of

Israeli forces also raided the city and fired tear gas canisters inside Al-Awda School for Girls suffocating a pupil called Ala' Said Qashmar, 12, and injuring 3 civilians including 1 child) called Abdallah Mohammad Al-Basha, 15, Abdallah Mohammad Bani Odeh and Shukri Mohammad Lutfi Daoud.</p> <ul style="list-style-type: none"> • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
NABLUS	<ul style="list-style-type: none"> • <u>Closure:</u> Since 17 December 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut. (iii) At 06:30 on 22 November 2015, Israeli forces closed the road connecting Aqraba town with Yanun village with dirt mounds. (iv) On 29 November 2015, Israeli forces closed the entrance of Bourin, Awarta and Osrin villages and the agricultural road connecting Aqraba and Qabalan with dirt mounds. (v) At 13:00 on 1 December 2015, Israeli forces closed the road connecting Tel village with the bypass road alongside Yitzhar settlement and installed a steel gate in the place. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) At 07:30 on 1 December 2015, Israeli forces intensified restrictions at Beit Furiq checkpoint and impeded the free flow of traffic. (ii) At 18:00, Israeli forces intensified restrictions at Huwara checkpoint and impeded free flow of traffic. • <u>Raids:</u> <ul style="list-style-type: none"> (i) At 08:50, Israeli forces raided and patrolled Beit Fourik village, clashed with civilians, and withdrew at 09:45. (ii) At 01:50, Israeli forces raided Askar refugee camp in Nablus, clashed with civilians during house raid and arrested 1 civilian. (iii) At 02:00, Israeli forces raided Rafidya, clashed with civilians, stormed into and searched the home of martyr Maram Hassouna (killed at Einav checkpoint in Tulkarem) and withdrew at 04:55. • <u>Arrests:</u> The civilian arrested in Askar refugee camp is Hazem Al-Nadi. • <u>Attacks:</u> At 10:20, Israeli forces positioned in the vicinity of Beit Fourik town and Beit Djin village and rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning. • <u>Settler Violence:</u> At 22:30, Israeli settlers raided a deserted house on Awarta village and were forced to leave by Israeli forces.

At 17:00, Israeli forces intensified restrictions at the checkpoint and impeded traffic. • Temporary detention: At 18:40, Israeli forces detained at Al-Karama Crossing civilian Iyad Mahmoud Qabalan Abu Jarrar from Jericho during his trip to Jordan, released him later but prevented him from travelling to Jordan.

(ii) At 03:05, Israeli forces raided Doha town, clashed with civilians during search of the family of martyr Ma'moun Al-Khatib, 16, (killed in Kfar Etzyon by Israeli forces) and withdrew at 04:50. • <u>Killing:</u> At 08:00 child Ma'moun Al-Khatib, 16, from Doha town was shot dead by Israeli forces for alleged stabbing of a Jewish settler near Kfar Etzyon settlement. • <u>Attacks:</u> At 14:20, Israeli forces positioned in the vicinity of Aida refugee camp located in North Bethlehem fired live ammunition and rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning. • <u>Arrests:</u> <ul style="list-style-type: none"> (i) On 29 November 2015, Israeli forces arrested civilian Mohammad Mahmoud Hussein Al-Sharif from Dheisheh refugee camp. (ii) At 12:00, Israeli forces positioned near Al-Nashash junction south of Bethlehem arrested a female civilian called Sabrin Hussein Sanad, 14, from Artas. (iii) The civilian arrested at the container checkpoint is Abdelrahim Al-Tamimi. • <u>Temporary Detention:</u> At 22:50, Israeli forces detained 2 female civilians after reporting to the military intelligence in Kfar Etzyon settlement and released them at a later time. The civilians are: Nashed Youssef Jubran and Suha Hanna Qumsieh. • <u>Home Occupation:</u> At 08:00, Israeli forces occupied the rooftop of the civilian home of Saleh Abdelnabi Saleh in Batir village and converted it into a military post.
<p style="text-align: center;">HEBRON</p>	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Karmil villages. (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City. (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town. (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks. (v) On 15 November 2015, Israeli forces closed the entrances of Khilet Al-Mayye and Al-Deirat villages east of Yatta with cement blocks.
