## WEST BANK

JERUSALEM	<ul style="list-style-type: none"> <li>• <b>Closure:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to intensify its restrictions at checkpoints located at the entrances to the city of Jerusalem. The Israeli army also continues to close the entrances to Al Aqsa Mosque compound in the old city of Jerusalem and impede civilian access to the mosque.</li> <li>(ii) On 05 January 2009, the Israeli authorities issued Military Order # S/02/09 on the closure of and denial of civilian access to the "demarcation area" along the Wall in the area surrounding the city of Jerusalem. Accordingly, local residents and civilians holding permits can access this area through crossings and gates set up at the entrances to the city of Jerusalem. (The demarcation area is defined by a set of military orders relating to land confiscation for Wall construction).</li> <li>(iii) The Israeli army continues to impose a blockade and deny civilian access to a hill located in an area between the village of Biddu and Beit Iksa due to its geographical significance as it overlooks the city of Jerusalem.</li> </ul> </li> <li>• <b>Closure of Main Roads:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks and dirt barricades the entrance to the village of Jaba'.</li> <li>(ii) The Israeli army continues to close the iron gate along the Wall section, separating the area of Dahiyat al Bareed from the town of Ar Ram.</li> </ul> </li> <li>• <b>Checkpoint:</b> The Israeli army continues to consider Qalandiya checkpoint a "border crossing point" and has designated a special crossing for holders of Jerusalem IDs and those possessing permits to access the city of Jerusalem.</li> <li>• <b>Raid:</b> On 02 December 2009, the Israeli army raided Shu'fat refugee camp and arrested 2 civilians.</li> <li>• <b>Arrests:</b> At dawn on 03 December 2009, the Israeli army arrested 2 civilians after searching a number of houses in Ash Sheikh Jarrah neighbourhood in the city of Jerusalem: <ul style="list-style-type: none"> <li>(i) Mohammed Abu Jibneh; and</li> <li>(ii) 'Abed Muther an Nashashibi.</li> </ul> The Israeli army arrested 2 civilians in Shu'fat refugee camp: <ul style="list-style-type: none"> <li>(iii) Mohammed Abu 'Assab; and</li> <li>(iv) Yasser Abu 'Assab.</li> </ul> </li> <li>• <b>Wall Gates:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the Wall gate in the town of Abu Dis with cement blocks.</li> <li>(ii) The Israeli army continues to deny civilian access through the Wall gate on Ash Shayyah road in the area between the villages of As Sawahira ash Sharqiya and As Sawahira al Gharbiya, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</li> </ul> </li> </ul>

	<ul style="list-style-type: none"> <li>• <b>Wall Construction:</b> Wall construction continues in the area of Al 'Eizariya to Ash Shayyah, from Beit Surik village to Biddu; in the areas of Al Judeira, Bir Nabala, and Beit Hanina; west of the village of Al Jib; in the vicinity of the village of Qatanna; south of the village of Beit Hanina; and in the area surrounding the checkpoint set up at the entrance to Shu'fat refugee camp.</li> </ul>
<b>RAMALLAH &amp; EL BIREH</b>	<ul style="list-style-type: none"> <li>• <b>Closure of Main Roads:</b> The Israeli army continues to close with dirt barricades and cement blocks the entrances to the town of Sinjil, the village of Saffa; and the junction to the villages of Kafr Malik – 'Ein Samiya.</li> <li>• <b>Raids:</b> <ul style="list-style-type: none"> <li>(i) At 15:00, the Israeli army raided and patrolled the village of Surda.</li> <li>(ii) At 15:15, the Israeli army raided and patrolled the city of El Bireh.</li> </ul> </li> <li>• <b>Wall Construction:</b> Wall construction continues west of 'Abud town and in the areas of Al Midya to Ni'lin and Ni'lin to Deir Qaddis.</li> </ul>
<b>JENIN</b>	<ul style="list-style-type: none"> <li>• <b>Closure of Main Road:</b> The Israeli army continues to close with dirt barricades the road leading to the town of 'Arraba east of the settlement of Dotan.</li> <li>• <b>Raid:</b> At 02:15, the Israeli army raided the town of Qabatiya, searched 3 commercial premises of chemicals and agricultural materials, and withdrew at 03:15.</li> <li>• <b>Wall Gates:</b> Passage through the Wall gates is restricted to civilians granted special Israeli permits, which affects the educational and health conditions of civilians living behind the Wall.</li> </ul>
<b>TUBAS</b>	<ul style="list-style-type: none"> <li>• <b>Checkpoint:</b> Though allowing civilian access to the Northern Jordan Valley between 06:00 and 22:00, the Israeli army continues to intensify its restrictions at Tayasir checkpoint east of the town of Tubas.</li> <li>• <b>Arrest:</b> At 01:15 on 03 December 2009, the Israeli army arrested Mustafa Radhwan Mustafa Daraghmeh during its raid into the city of Tubas, as was reported yesterday.</li> </ul>
<b>TULKAREM</b>	<ul style="list-style-type: none"> <li>• <b>Closure of Main Roads:</b> The Israeli army continues to close with dirt barricades the road connecting the town of Kafr al Labad to the village of Shufa as well as the road connecting the villages of Shufa and 'Izbat Shufa.</li> <li>• <b>Checkpoint:</b> The Israeli army continues to intensify restrictions at 'Einav checkpoint set up on Tulkarem-Nablus main road.</li> <li>• <b>Raids/Confiscation of Property:</b> <ul style="list-style-type: none"> <li>(i) At 01:25, the Israeli army raided Tulkarem refugee camp in the city of Tulkarem, searched 2 houses, confiscated a personal computer, and arrested 1 civilian.</li> <li>(ii) At 01:40, the Israeli army raided the town of 'Attil and arrested 1 civilian.</li> </ul> </li> <li>• <b>Arrests:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army arrested Ahmed Mustafa 'Assas in Tulkarem refugee camp.</li> </ul> </li> </ul>

	<p>(ii) The Israeli army arrested Habbab Munther Ahmed Thafer in the town of 'Attil.</p> <ul style="list-style-type: none"> <li>• <b>Wall Gates:</b> Passage through the wall gates is restricted to civilians granted special Israeli permits.</li> </ul>
QALQILYA	<ul style="list-style-type: none"> <li>• <b>Closure of Roads:</b> The Israeli army continues to close with cement blocks agricultural roads east of the town of 'Azzun.</li> <li>• <b>Flying Checkpoints:</b> <p>(i) At 16:15, the Israeli army set up a flying checkpoint at the entrance to the town of 'Azzun and searched civilians and vehicles.</p> <p>(ii) At 20:40, the Israeli army set up a flying checkpoint at the eastern entrance to the city of Qalqiliya and searched civilians and vehicles.</p> </li> <li>• <b>Raids/Confiscation of Property:</b> <p>(i) At dawn on 03 December 2009, the Israeli army raided the village of Ras 'Atiya, searched 1 house, confiscated accessories of a hunting rifle, and arrested 1 civilian.</p> <p>(ii) At 13:00, the Israeli army raided and patrolled the town of Habla.</p> <p>(iii) At 22:40, the Israeli army raided the villages of Ras Tira and Magharat ad Dab'a and searched 2 houses.</p> </li> <li>• <b>Arrest:</b> The Israeli army arrested Husni Shawahneh in the village of Ras 'Atiya.</li> <li>• <b>Settler Violence:</b> At 10:50, a group of Israeli settlers from the settlement of Karnei Shomron closed the Qalqiliya-Nablus main road near the village of Kafr Laqif. Israeli settlers also threw stones at civilian vehicles travelling along the road. Consequently, the Israeli army evacuated settlers from the area.</li> <li>• <b>Wall Gate:</b> The Israeli army continues to intensify its restrictions at 'Azzun 'Atma Wall gate and to search civilians, including students, with a detector.</li> <li>• <b>Wall Construction:</b> Wall construction continues south of the town of Jayyus as well as near the settlement of Alfei Menashe in the villages of Ras Tira, Magharet ad Dab'a, and Wadi ar Rasha south of the city of Qalqiliya.</li> </ul>
NABLUS	<ul style="list-style-type: none"> <li>• <b>Closure of Main Roads:</b> <p>(i) The Israeli army continues to close the roads of Till-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the southern entrance to the village of Duma; and the northern entrance to the town of Qabalan.</p> <p>(ii) The Israeli army continues to close with an iron gate the western entrance to the village of An Naqura opposite the settlement of Shavei Shomron.</p> </li> <li>• <b>Checkpoints:</b> The Israeli army continues to regulate times for crossing checkpoints set up around the city of Nablus: <p>(i) At Tur neighbourhood checkpoint (set up on Jerzim Mount) is closed on Fridays and Saturdays as well as during Jewish holidays. On all other days, it is open for civilian residents of the neighbourhood only between 07:00 and 02:00.</p> </li> </ul>

	<ul style="list-style-type: none"> <li>(ii) At ‘Awarta commercial checkpoint, civilians are allowed to cross between 05:00 and 20:00, but between 05:00 and 15:00 on Fridays. All civilian vehicles are allowed to access the city of Nablus, but only commercial vehicles and ambulances can leave the city through the checkpoint.</li> <li>• <b>Flying Checkpoint:</b> At 08:55, the Israeli army set up a flying checkpoint in the area between the city of Nablus and the town of ‘Asira ash Shamaliya and searched civilians and vehicles.</li> <li>• <b>Raids/Detentions:</b> <ul style="list-style-type: none"> <li>(i) At 19:10, the Israeli army raided the town of Beit Furik, detained 6 civilians, and released them at a later time.</li> <li>(ii) At 00:40, the Israeli army raided the city of Nablus and provided protection to a group of Israeli settlers, who visited Prophet Joseph’s Shrine.</li> </ul> </li> </ul>
SALFIT	<ul style="list-style-type: none"> <li>• <b>Closure of Main Roads:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with dirt barricades the northern entrance to the city of Salfit.</li> <li>(ii) The Israeli army continues to close with cement blocks and iron gates the northern entrance to the town of Bruqin and the western entrance to the town of Kafr Ad Dik.</li> </ul> </li> <li>• <b>Checkpoint:</b> The Israeli army continues to intensify its restrictions and impede civilian access at the Za’tara junction checkpoint.</li> <li>• <b>Flying Checkpoint:</b> At 18:00, the Israeli army set up a flying checkpoint in the area between the town of Kifl Haris and the village of Haris and searched civilians and vehicles until 21:00.</li> <li>• <b>Raids:</b> <ul style="list-style-type: none"> <li>(i) At 15:40, the Israeli army raided and patrolled the village of Qira.</li> <li>(ii) At 20:10, the Israeli army raided the town of Az Zawiya, searched 1 barracks, and withdrew at 21:30.</li> <li>(iii) At 20:20, the Israeli army raided and patrolled the village of Haris.</li> <li>(iv) At 02:00, the Israeli army raided and patrolled the village of Iskaka.</li> </ul> </li> <li>• <b>Wall Construction:</b> Wall construction continues in the area northwest of the city of Salfit, and in the village of Marda and the town of Kifl Haris north of the settlement of Ariel.</li> </ul>
JERICHO	<ul style="list-style-type: none"> <li>• <b>Closure:</b> The Israeli army continues to close Road # 90 between the city of Jericho and the village of Al ‘Auja with cement blocks and to prevent farmers not holding Jericho Governorate IDs from reaching their land, forcing them to apply for access permits. The Israeli army also continues to deny access to the city to holders of Israeli IDs.</li> <li>• <b>Checkpoints:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to intensify its restrictions at Al Hamra checkpoint set up along Al Badhan road connecting the districts of Jericho and Nablus. However, the Israeli army allows civilian access between 06:00 and 22:00.</li> </ul> </li> </ul>

	<p>(ii) The Israeli army continues to intensify its restrictions at the checkpoint set up on the junction to the village of Al ‘Auja along Al-Mu’arrajat road that connects the districts of Jericho and Ramallah, only allowing access to civilians whose IDs indicate that their place of residence of the district of Jericho as well as to others holding access permits.</p> <ul style="list-style-type: none"> <li>• <b>Raid:</b> At 19:00, the Israeli army raided and patrolled the village of Fasayil.</li> </ul>
<b>BETHLEHEM</b>	<ul style="list-style-type: none"> <li>• <b>Closure:</b></li> <li>(i) The Israeli army continues to close the roads to the village of An Nu’mān, with the exception of the road leading to the Wall gate in the south-eastern area of the village.</li> <li>(ii) According to Military Order # 07/02/S, the Israeli army has continued since 15 September 2007 to deny civilian access to an area measuring 22 <i>dunums</i> (5.436 acres) of land in the area of Mazmuriya in the cities of Beit Sahur and Bethlehem. The land was confiscated pursuant to Military Order # 07/31/T.</li> <li>• <b>Closure of Main Roads:</b> The Israeli army continues to close with dirt barricades the road of Beit Jala-Wadi Ahmad as well as a detour road east of the town of Beit Fajjar.</li> <li>• <b>Flying Checkpoints/Detentions:</b></li> <li>(i) At 09:25, and again at 13:25, the Israeli army set up a flying checkpoint on the junction to the area of An Nashash (the southern entrance to the city of Bethlehem) and searched civilians and vehicles.</li> <li>(ii) At 09:40, the Israeli army set up a flying checkpoint at the entrance to the town of Beit Fajjar, detained 7 civilians, and released them at a later time. At 20:15, the Israeli army set up a flying checkpoint at the entrance to the village of Husan and searched civilians and vehicles.</li> <li>• <b>Raid:</b> At 21:20, the Israeli army raided and patrolled the village of Husan.</li> <li>• <b>Wall Construction:</b> Wall construction continues in the area northwest of the town of Al Khadr; northwest of the city of Beit Jala; in the area of Wadi Rahhal east of Ifrat settlement; and in the area surrounding the village of Al Walaja.</li> </ul>
<b>HEBRON</b>	<ul style="list-style-type: none"> <li>• <b>Closure:</b></li> <li>(i) The Israeli army continues to close the following locales in the old city of Hebron: Ash Shuhada’ Street and the area of As Sahleh with cement blocks and barbed wire; the old gold market with an iron gate; the area of Khuzq al Far near the settlement of Abraham Avino with a dirt barricade and an iron gate; and the entrance to the area of Al Khan with an electronic gate, isolating the area from Al Laban Market and the area of As Sahleh. The Israeli army also continues to install an iron gate at the entrance to the area of Al Hisba (the fruits and vegetables market) in the old city of Hebron, thereby controlling civilian access in the area.</li> <li>(ii) On 05 January 2009, the Israeli army issued Military Order # 09/06/S for closure of the area located along the Green Line south of the town of Yatta, evacuation of civilian residents, and prevention of civilian access to the area. According to Military Orders # 05/03/T and 05/04/T, land in this area was confiscated for Wall construction.</li> </ul>

- **Closure of Main Roads:**
  - (i) The Israeli army continues to close with cement blocks the entrance to the town of As Samoa'; the road connecting the town of Surif to the village of Al Jab'a; the eastern entrance to the village of Kharsa; the entrance to the Al Qeisi neighbourhood in the old city of Hebron; as well as the entrances to Al 'Arrub refugee camp, the area of Al Hawawir, the village of At Tuwani, and the town of Adh Dhahiriya.
  - (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along Ash Shalala Old Street in the old city of Hebron.
  - (iii) The Israeli army continues to close with dirt barricades the road between the villages of Al Karmil and At Tuwani and all roads leading to Road # 60.
- **Flying Checkpoints:**
  - (i) At 09:00, the Israeli army set up a flying checkpoint at the entrance to the area of Al Fahs south of the city of Hebron and searched civilians and vehicles.
  - (ii) At 13:20, the Israeli army set up a flying checkpoint at the entrance to the town of Idhna and searched civilians and vehicles.
  - (iii) At 16:40, the Israeli army set up a flying checkpoint on the junction to the village of Kharsa and searched civilians and vehicles.
  - (iv) At 17:10, the Israeli army set up a flying checkpoint on Al Fawwar junction and searched civilians and vehicles.
- **Raids/House Occupations:**
  - (i) At 13:20, the Israeli army raided and patrolled the town of Tarqumiya.
  - (ii) At 21:30, the Israeli army raided Al 'Arrub refugee camp, occupied the roofs of 2 houses, and converted them into military posts. The Israeli army also set up a checkpoint and searched civilians and vehicles.
  - (iii) At 02:00, the Israeli army raided the town of Beit Ummar and arrested 1 civilian.
- **Arrest:** The Israeli army arrested Thaer Sa'id Abu 'Ayyash in the town of Beit Ummar.
- **Provocation of Palestinian Forces:** At 10:20, the Israeli army detained a Palestinian National Security vehicle transporting 4 officers, who were in possession of 2 Kalashnikov rifles and 1 pistol. Following coordination with the Israeli authorities (through the DCO), the Israeli army released the vehicle and officers.
- **Wall Construction:** Wall construction continues in the section of Tarqumiya checkpoint terminal; in the area surrounding the settlement of Eshkolot near the town of Adh Dhahiriya; and in the area between the villages of 'Arab ar Ramadin and Imneizil.

At a later time on the same day, armed Palestinian groups announced an agreement to cease fire for a week. Later, armed Palestinian groups extended the ceasefire until 05 February 2009. Despite the fact that the extension period expired, the ceasefire continues to hold pending negotiations carried out by Egypt.</li> <li>• <b>Violation of the Ceasefire:</b> The Israeli army raided Palestinian territory and opened intensive fire in the district of Rafah. The Israeli army also fired a number of tank shells towards Palestinian territory from its location east of Gaza city.</li> </ul>
<p style="text-align: center;"><b>NORTHERN GAZA</b></p>	<ul style="list-style-type: none"> <li>• <b>Closure of Crossing Point:</b> Beit Hanun (Erez) Crossing is partially open for previously coordinated humanitarian cases and foreign nationals.</li> </ul>
<p style="text-align: center;"><b>GAZA</b></p>	<ul style="list-style-type: none"> <li>• <b>Closure of Crossing Points:</b> <ul style="list-style-type: none"> <li>(i) Al Muntar (Karnei) Crossing is partially open for transportation of wheat and animal feed.</li> <li>(ii) Ash Shuja'iyah (Nahal 'Oz) Crossing is closed.</li> </ul> </li> <li>• <b>Attack:</b> At dawn on 04 December 2009, the Israeli army fired a number of tank shells from its location on the Green Line towards vacant and agricultural land east of Gaza city.</li> </ul>
<p style="text-align: center;"><b>CENTRAL GAZA</b></p>	<ul style="list-style-type: none"> <li>• Activities not reported.</li> </ul>
<p style="text-align: center;"><b>KHAN YUNIS</b></p>	<ul style="list-style-type: none"> <li>• Activities not reported.</li> </ul>
<p style="text-align: center;"><b>RAFAH</b></p>	<ul style="list-style-type: none"> <li>• <b>Closure of Crossing Points:</b> <ul style="list-style-type: none"> <li>(i) Yasser 'Arafat International Airport remains closed.</li> <li>(ii) Rafah (Al 'Awdah) Crossing is open on an exceptional basis to allow access a group of pilgrims, who have returned from Saudi Arabia.</li> <li>(iii) Sufa Crossing is closed.</li> <li>(iv) Karm Abu Salim (Karem Shalom) Crossing is partially open for transportation of food supplies and humanitarian aid.</li> </ul> </li> <li>• <b>Raid/Air Patrol/Attack/Land Levelling:</b> In the morning of 03 December 2009, the Israeli army, including several armoured vehicles and 1 bulldozer covered by reconnaissance aircraft, raided 300 metres into the area of Abu Mu'ammara northeast of the city of Rafah. The Israeli army also opened fire towards agricultural land and civilian houses and levelled land.</li> </ul>
