WEST BANK

JERUSALEM

- **Closure:**
 - (i) On 28 November 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound.
 - (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem according to Military Order 09/02S and restricts access to local residents as well as to civilians holding special permits.
 - (iii) Israeli forces continue to close the hill between Biddo and Beit Iksa villages and deny civilian access.
- **Closure of Main Roads:**
 - (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village.
 - (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.
 - (iii) On 16 November 2015, Israeli forces closed the southern entrance of Jabal Al-Mukabir neighbourhood leading to Armon Hanatsif settlement with cement blocks.
- **Checkpoints:**
 - (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
 - (ii) On 19 September 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall.
- **Flying Checkpoints:**
 - (i) At 12:00, Israeli forces set up a checkpoint at the north and west entrances of Hizma village and searched civilians and vehicles, and denied civilian access.
 - (ii) At 14:55, Israeli forces set up a checkpoint at the entrance of Bir Nibala town and searched civilians and vehicles.
 - (iii) At 15:50, Israeli forces set up a checkpoint at the roundabout of Jabaa town, and searched civilian and vehicles until 16:55.
 - (iv) At 20:20, Israeli forces set up a checkpoint at the entrance of Hizma village, and searched civilians and vehicles until 01:40.
- **Raids:** At 01:40, Israeli forces raided and patrolled Abu Dis town.
- **Arrests:** On 11 December 2015, Israeli forces arrested civilian Hazem Sandouka in the old city of Jerusalem.
- **Attacks:**
 - (i) At 12:30, Israeli forces positioned in Ras Al-Amud neighbourhood fired tear gas canisters and stun grenades towards civilians for alleged stoning, and arrested 1 civilian.
 - (ii) At 12:30, Israeli forces in Abu Dis town fired tear gas canisters and stun grenades towards civilians during a demonstration requesting the return of for the dead bodies of martyrs withheld by the Israeli authorities.
- **Wall Gates:**
 - (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
 - (ii) The Israeli army continues to deny civilian access through the Wall gate on

	<p>Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Sawahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</p>
<p>RAMALLAH & AL BIREH</p>	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and ‘Ein Samiya villages (ii) On 3 October 2015, Israeli forces closed the main road located near “Bet El” settlement and leading to Al-Jalazoun camp with cement blocks. (iii) On 24 November 2015, Israeli forces closed the main entrance gate leading to Sinjil and the east entrance of Mughier with cement blocks. • <u>Flying checkpoints:</u> At 15:20 and 23:10, Israeli forces set up a checkpoint near Attara Bridge and searched civilians and vehicles, arrested 1 civilian, confiscated 1 civilian vehicle and then withdrew at 23:40. • <u>Raids:</u> <ul style="list-style-type: none"> (i) At 01:05, Israeli forces raided and patrolled Al-Janiya village. (ii) At 02:015, Israeli forces raided Ramallah city, clashed with civilians, stormed into a store for selling scientific equipment and confiscated equipment and then withdrew at 04:15. • <u>Arrests:</u> The civilian arrested near Attara Bridge flying checkpoint is Abdel Karim Husni Abu Irmeileh from Attara. • <u>Attacks:</u> <ul style="list-style-type: none"> (i) At 12:35, Israeli forces positioned near the entrance of Aboud town fired live ammunition and rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning, injuring 2 civilians: Karim Izzat Ibrahim Jaber and Usama Bassam Mohammad Dar Salah. (ii) At 12:40, Israeli forces near Turmusayya town fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning. (iii) At 13:00, Israeli forces near the entrance of Silwad town fired rubber coated steel bullets, stun and tear gas grenades towards civilians during a demonstration requesting for the return of the dead bodies of martyrs withheld by Israeli authorities, injuring 21 civilians (including 1 child, 1 journalist and 1 woman. Those identified are: Nouredin Nidal Hammoud Ayyad, 17, journalist Raghda Itmeh, Sabrin Ali Hamed, Muawiyya Mohammad Ayyad, Abdel Qader Bassem Hammad, Imad Khalil Hammad, Abdellatif Saed Hammad and Aysar Ghassan Hammad. (iv) At 13:15, Israeli forces near Safa village fired stun grenades and tear gas canisters towards civilians for alleged stoning. (v) At 14:40, Israeli forces positioned near the entrance of Al-Mughier village fired stun grenades and tear gas canisters towards civilians for alleged stoning. (vi) At 14:50, Israeli forces near Al-Jalazoun refugee camp fired stun grenades and tear gas canisters towards civilians for alleged stoning, injuring child Ala’ Mohammad Nakhleh, 16. (vii) At 16:00, Israeli forces at the entrance of Sinjil town fired stun grenades and tear gas canisters towards civilians for alleged stoning. (viii) At 16:00, Israeli forces positioned in the vicinity of Ofer camp fired stun grenades and tear gas canisters towards civilians for alleged stoning, injuring 6 civilians. (ix) At 16:00, Israeli forces near the entrance of Nabi Saleh village fired stun grenades and tear gas canisters towards civilians for alleged stoning. (x) At 16:00, Israeli forces near the entrance of Al-Janiya village fired stun grenades and tear gas canisters towards civilians for alleged stoning. (xi) At 16:00, Israeli forces positioned in the vicinity of Pisgot settlement east of Al-Bireh city fired stun grenades and tear gas canisters towards civilians for alleged stoning.

	<ul style="list-style-type: none"> • <u>Temporary Detention:</u> At 10:00, Israeli forces detained child Jihad Mohammad Al-Mazloun, 12, from Al-Janiya village and released him at a later time after the intervention of Palestinian military at 18:00. • <u>Demonstrations:</u> <ul style="list-style-type: none"> (i) At 12:35, civilians and international activists went out on a demonstration in Mil'in village in protest of the apartheid Wall, Clashed broke out between protestors and Israeli forces resulting in the injury of several civilians and the suffocation of others as a result of tear gas inhalation. (ii) At 12:35, civilians and international activists went out on a demonstration in Bil'in village in protest of the apartheid Wall, Clashed broke out between protestors and Israeli forces resulting in the injury of two civilians (including one journalist): Journalist Hamdi Abu Rahmeh and Kifah Mansour, and the suffocation of others as a result of tear gas inhalation.

TULKAREM	<ul style="list-style-type: none"> • <u>Checkpoints:</u> Israeli forces intensified restrictions at "Eniv" checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic. • <u>Flying checkpoints:</u> <ul style="list-style-type: none"> (i) At 15:05, Israeli forces set up a checkpoint at the junction of Beit Lid and searched civilians and vehicles until 15:20. (ii) At 17:30, Israeli forces set up a checkpoint at the entrance of Al-Jaroushiyye village and impeded free flow of traffic. • <u>Raids:</u> <ul style="list-style-type: none"> (i) At dawn on 11 December 2015, Israeli forces raided Safarin village and arrested 2 brothers. (ii) At 18:00 and 03:30, Israeli forces raided Tulkarem city and clashed with civilians during patrol, stormed into 1 building and 1 civilian home, arrested 2 civilians, confiscated 1 computer device and cellular. • <u>Arrests:</u> <ul style="list-style-type: none"> (i) On 10 December 2015, Israeli forces arrested at Al-Taybeh Crossing civilian Amjad Mahmoud Salim Yihya from Tulkarem (ii) At 03:35 on 11 December 2015, in correction of what has been reported in the last report, the civilian reported to be arrested by Israeli forces during a raid on Tulkarem and Tulkarem refugee camp was in fact not arrested but had his home searched by Israeli forces. (iii) At 03:35 on 11 December 2015, Israeli forces arrested three civilians during a raid on Tulkarem city and Tulkarem refugee camp: Hamze Shawqi Mohammad Youssef Salit, Rami Khalil Khader Hamshari and Ahmad Adel Mahmoud Shalabi. (iv) The two arrested in Safareen were rami Salem and his brother Sameh. (v) The two arrested in Tulkarem were loa'i Abu Hania, and Abed Elhameed bani Odeh. • <u>Attacks:</u> At 15:50, Israeli forces positioned near the Apartheid Wall alongside Shweiki suburb fired rubber coated steel bullets, stun grenades and tear gas canisters towards civilians for alleged stoning.

(ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) Since 10:40 on 1 September 2015, Israeli forces closed an agricultural road leading to Far'ata village which is located near "Gillad" settlement with a steel gate. • <u>Flying Checkpoints:</u> At 17:10, Israeli forces set up a checkpoint at the entrance of Izbit Al-Tabib village and searched civilians and vehicles. • <u>Raids:</u> At 17:15 and 24:00, Israeli forces raided Habla Qalqilya, clashed with civilians during patrol and arrested 2 civilians (including 1 child). • <u>Arrests:</u> The 2 civilians arrested in Qalqilya city are: Ziyad Nassr Nofal, 17, and Malik Saleh Al-Aqra'. • <u>Attacks:</u> <ul style="list-style-type: none"> (i) At 14:10, Israeli forces positioned at the entrance of Azzun town fired rubber coated steel bullets, stun grenades and tear gas canisters towards civilians for alleged stoning causing severe damage to 1 civilian vehicle owned by Abed Ahmad Ali Jeer. 12 civilians were suffocated as a result of tear gas inhalation. (ii) At 14:30, Israeli forces guarding the Apartheid Wall alongside Jayyous town fired stun grenades and tear gas canisters towards civilian for alleged stoning. • <u>Demonstrations:</u> At 12:15, a demonstration set out in Kafr Qaddoum village in protest of the continuous closure of the east entrance of the village. Israeli forces fired live ammunition, and rubber coated steel bullets, tear gas canisters and stun grenades at protestors, injuring 4 civilians: Murad Mahmoud Abdel Qader Shteiwi, Aus Abdel Razek Mahmoud Amer, Subhi Ahmad Abdelrahman Shteiwi and Nasser Darwish Bakr Barham. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
<p style="text-align: center;">NABLUS</p>	<ul style="list-style-type: none"> • <u>Closure:</u> Since 17 December 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut. (iii) At 06:30 on 22 November 2015, Israeli forces closed the road connecting Aqraba town with Yanun village with dirt mounds. (iv) On 29 November 2015, Israeli forces closed the entrance of Bourin, Awarta and Osrin villages and the agricultural road connecting Aqraba and Qabalan with dirt mounds. (ii) Since 30 July 2012, Israeli forces have closed two roads leading to Abu Naser and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks. • <u>Checkpoints:</u> Israeli forces continued to intensify restrictions at Za'tara checkpoint and impeded the free flow of traffic. • <u>Attacks:</u> At 14:10, Israeli forces positioned at the north entrance of Salfit city fired tear gas bombs and stun grenades towards civilians for alleged stoning.

BETHLEHEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village. (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunums of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities. • <u>Closure of Main Roads:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala; Wadi Rahal road near "Ifrat" settlement, the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds. - (v) At 15:30 on 20 November 2015, Israeli forces closed eastern entrance of Jinana town with dirt mounds.
- (vi) At 13:10, on 22 November 2015, Israeli force closed the entrance of Marah Rabah town with dirt mounds.
- (vii) At 18:00 on 27 November 2015, Israeli forces closed Barbara junction in Beit Jala with cement blocks.
- (viii) At 14:50 on 28 November 2015, Israeli forces closed the entrance to Um Rukba area in Al-Khader with cement blocks.
- **Raids:**
 - (i) At dawn on 11 December 2015, Israeli forces raided Aida refugee camp in Bethlehem and arrested 1 civilian.
 - (ii) At 01:25, Israeli forces raided Bethlehem city, stormed into a charity society and infirmary, confiscated computers and files, stormed into the civilian home of Ali Nasser Ali Muslem and inflicted material damage to his home.
 - (iii) At 01:30, Israeli forces raided Al-Khader town and delivered a notification to civilian Ali Mustafa Salah to report to the military intelligence.
- **Arrests:** The civilian arrested in Aida refugee camp in Bethlehem is Hamza Ibrahim Mohammad Al-Okal.
- **Attacks:**
 - (i) At 11:40, Israeli forces positioned at the west entrance of Beit Fajjar town fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
 - (ii) At 12:30, Israeli forces positioned at the west entrance of Teqoa town fired rubber coated steel bullets, stun and tear gas grenades towards civilians for alleged stoning.
 - (iii) At 12:40, Israeli forces positioned in the vicinity of Bilal Ben Rabah Mosque alongside Aida refugee camp north of Bethlehem fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning, injuring 14 civilians (including 2 children, and 1 journalist). Those identified are: Ahmad Jamal Awwad, 14, Ibrahim Hassan Ismail, 17, journalist Rahab Mahmoud Nazzal, Ali Khalil Mohammad Ismail and Mohammad Asad Ibrahim Saleh. Several civilians were suffocated as a result of tear gas inhalation.
 - (iv) At 13:05, Israeli forces in the area of Um Rukba in Al-Khader town At 16:50, Israeli forces positioned at the western entrance of Teqoa town fired rubber coated steel bullets, stun and tear gas grenades towards civilians for alleged stoning.
 - (v) At 16:15, Israeli forces near the entrance of Husan town At 16:50, Israeli forces positioned at the western entrance of Teqoa town fired rubber coated steel bullets, stun and tear gas grenades towards civilians for alleged stoning, injuring 1 civilian.
- **Temporary Detention:** At 13:55, Israeli forces detained 2 children from Nahalin town: Mousa Mahmoud Hassan Shakarneh, 10, and Saleh Mahmoud Izzat Shakarneh, 13 and released them at 18:00.

HEBRON

- **Closure:**
 - (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
 - (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.
- **Closure of Main Roads:**
 - (i) The Israeli army continues to close the entrances to Al-Karmil villages.
 - (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
 - (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
 - (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
 - (v) On 15 November 2015, Israeli forces closed the entrances of Khilet Al-Mayye and Al-Deirat villages east of Yatta with cement blocks.
 - (vi) At 14:10 on 23 November 2015, Israeli forces closed of Al-Kom village north of Beit Awwa with cement blocks.
