WEST BANK

• Closure:

- (i) On 28 November 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem according to Military Order 09/02S and restricts access to local residents as well as to civilians holding special permits.
- (iii) Israeli forces continue to close the hill between Biddo and Beit Iksa villages and deny civilian access.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Oalandiya checkpoint.
- (iii) On 16 November 2015, Israeli forces closed the southern entrance of Jabal Al-Mukabir neighbourhood leading to Armon Hanatsif settlement with cement blocks.

• Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
- (ii) On 19 September 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.
- (iii) At 20:30, Israeli forces closed Jabaa checkpoint on the road connecting Jerusalem, Ramallah and Jericho and denied civilian access under the pretext of Molotov cocktail throwing near Adam settlement. The checkpoint was reopened at a later time.

• Flying Checkpoints:

- (i) At 12:15, Israeli forces set up a checkpoint at the junction of al-Ram town and searched civilians and vehicles until 16:45.
- (ii) At 12:15, Israeli forces set up a checkpoint at the junction of Hizma village and searched civilians and vehicles until 16:45.

• Raids:

- (i) At 15:40, Israeli forces raided Beit Sourik village and arrested 1 civilian.
- (ii) At 23:00, Israeli force raided and patrolled Dahiat Al-Aqbat in Al-Ram town.

• Arrests:

- (i) On 12 December 2015, Israeli forces arrested civilian Mousa Dirbas from Isawiyye village.
- (ii) The civilian arrested in Beit Sourik village is Ahmad Mohammad Khalil al-Jamal.
- <u>Attacks:</u> At 18:00, Israeli forces in Abu Dis town fired tear gas canisters and stun grenades towards civilians for alleged stoning.
- <u>Settler Activities:</u> Israeli authorities approved a plan to build 82 new housing units in Ramat Shlomo settlement north of East Jerusalem on 1 and occupied in 1967.

JERUSALEM

Wall Gates: (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. The Israeli army continues to deny civilian access through the Wall gate on (ii) Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Sawahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices. **Closure of Main Roads:** (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages (ii) On 3 October 2015, Israeli forces closed the main road located near "Bet El" settlement and leading to Al-Jalazoun camp with cement blocks. (iii) On 24 November 2015, Israeli forces closed the main entrance gate leading to Sinjil and the east entrance of Mughier with cement blocks. (iv) At 18:50 on 4 December 2015, Israeli forces closed the entrance of Abboud town with dirt mounds. Checkpoints: at 13:20, Israeli forces closed Al-Mahkama checkpoint near Bet El settlement north of Al-Bireh city and denied civilian access. The checkpoint was reopened at a later time. Flying checkpoints: At 19:25, Israeli forces set up a checkpoint at the entrance of Burga village (i) and searched civilians and vehicles until 22:00. At 19:30, Israeli forces set up a checkpoint at the entrance of Deir Dibwan (ii) town and searched civilians and vehicles. At 22:10, Israeli forces set up a checkpoint near Atara Bridge, physically (iii) assaulted 1 civilian and arrested him. At 20:35, Israeli forces set up a checkpoint near Ein Ayyoub area and (iv) searched civilians and vehicles until 22:00. At 22:30, Israeli forces set up a checkpoint at the roundabout of Ein Sinya (v) village and searched civilians and vehicles until 23:00. **RAMALLAH &** At 01:15, Israeli forces set up a checkpoint at the junction of Surda village and AL BIREH (vi) searched civilians and vehicles until 03:15. At 02:25, Israeli forces set up a checkpoint near the entrance of Al-Jalazoun (vii) refugee camp, arrested 1 civilian and withdrew at 02:45. Raids: (i) At 17:45, Israeli forces raided Lubban Al-Gharbi village and took measure of the home of prisoner Mohammad Abdel Halim Abu Salem. At 19:10, Israeli forces raided Beitello village, stormed and searched the home (ii) of Abdeallah Abdel Qader Ziyade, and withdrew at 21:10. At 00:50, Israeli forces raided Beitunia town, stormed and searched 2 civilian (iii) homes and withdrew at 04:45. **Arrests:** On 11 December 2015, Israeli forces arrested child Mohammad Mustafa (i) Mohammad Zahran, 17, from Deir Abu Mishal village. The civilian arrested near Atara Bridge is Mohammad Abu Al-Jidyan from (ii) Atara town. The civilian arrested near the entrance of Al-Jalzoun refugee camp is Bisan (iii) Saher Dabbour from Al-Jalazoun camp. Attacks: (i) At 10:10, Israeli forces positioned near the entrance of Abboud town fired live ammunition and rubber coated steel bullets, stun and tear gas grenades towards civilians during a march in protest of continuous closure of the

entrance to the town.

At 13:00, Israeli forces positioned in the vicinity of Al-Mahkama checkpoint

- **Raids:** At 20:30, Israeli forces raided Jayyous town and patrolled it until 21:00.
- Arrests: On 10 December 2015, Israeli forces arrested civilian Saji Yasser Othman Daas from Qalqilya city.
- **Demonstrations:** At 14:30, a demonstration set out in Kafr Qaddoum village in protest of the continuous closure of the east entrance of the village. Israeli forces fired live ammunition, and rubber coated steel bullets, tear gas canisters and stun grenades at protestors, injuring child Raed Hussam Hassan Jumaa, 16. Also 15 civilians were suffocated as a result of tear gas inhalation.

• Wall Gates:

- (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access.
- (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
- <u>Closure:</u> Since 17 December 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin.
- (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Oarvut.
- (iii) At 06:30 on 22 November 2015, Israeli forces closed the road connecting Agraba town with Yanun village with dirt mounds.
- (iv) On 29 November 2015, Israeli forces closed the entrance of Bourin, Awarta and Osrin villages and the agricultural road connecting Aqraba and Qabalan with dirt mounds.
- (v) On 1 December 2015, Israeli forces closed the road connecting Tel village with the bypass road alongside Yitzhar settlement and installed a steel gate in the place.
- (vi) On 12 December 2015, Israeli forces closed the road connecting Beita town with Osrin village with dirt mounds.
- (vii) At 13:05 on 12 December 2015, Israeli forces closed the road connecting Aqraba town and Majdal Bani Fasel village with dirt mounds.

• Checkpoints:

- (i) At 13:10, Israeli forces closed Huwara checkpoint and denied civilian access. The checkpoint was reopened at 16:00.
- (ii) At 20:00, Israeli forces intensified restrictions at Beit Fourik checkpoint and impeded free flow of traffic until 20:50.
- **Flying Checkpoints:** At 14:00, Israeli forces set up a checkpoint between Aqraba town and Osrin village and searched civilians and vehicles until 16:25.
- Raids: At 20:55, Israeli forces raided Iraq Bourin village, clashed with civilians during patrol and withdrew at 21:20.
- <u>Attacks:</u> At 13:10, Israeli forces positioned in the vicinity of Huwara checkpoint fired rubber coated steel bullets, tear gas canisters and stun grenades towards civilians for alleged stoning injuring civilian Hamzeh Marwan Saleh Abu Zayye.

- (iii) At 17:15, Israeli forces set up a checkpoint near Harmala village and searched civilians and vehicles.
- (iv) At 18:50, Israeli forces set up a checkpoint at the entrance of Beit Tamor village and detained civilian Murad Daoud Ibayyat, released him at a later time and withdrew at 19:00.

• Raids:

- (i) At 01:05, Israeli forces raided Beit Fajjar town, stormed 2 civilian homes and delivered a notification to civilian Fayez Ali Diriyye to report to the military intelligence.
- (ii) At 01:15, Israeli forces raided Husan village and stormed 3 civilian homes.
- (iii) At 01:35, Israeli forces raided and patrolled Bethlehem city.
- <u>Attacks:</u> At 20:00, Israeli forces positioned at the west entrance of Teqoa town fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.

• Closure:

- (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) On 15 November 2015, Israeli forces closed the entrances of Khilet Al-Mayye and Al-Deirat villages east of Yatta with cement blocks.

(vi) At 14:10 on 23 November 2015, Israeli forces closed of Al-Kom village north of Beit Awwa with cement blocks.

- (vii)At 08:00 on 01 December 2015, Israeli forces closed the checkpoint at the entrance of Shuhada' Street and denied civilian access and changed direction of traffic.
- (viii) At 22:20 on 9 December 2015, Israeli forces closed road in Jaball Jales area in the old city of Hebron ands well as the Kasarat road leading to the bypass road.
- (ix) At 16:00 on 11 December 2015, Israeli forces closed the entrance of Sair town with

- (i) At 14:45, Israeli forces set up a checkpoint at the entrance of bypass road alongside Hagai settlement south of Hebron, impeded free flow of traffic, closed gate and reopened it at 15:15.
- (ii) At 01:05, Israeli forces set up a checkpoint in Khilet Al-Ward area and searched civilians and vehicles.

• Raids:

- (i) At 09:30, Israeli forces raided Surif town and delivered 2 notifications to Rami Ibrahim Hadoush and Waed Arafat Al-Hidmi to report to the military intelligence.
- (ii) At 13:20, Israeli forces raided and patrolled Khilet Al-Ward area in Bani Naim town.
- (iii) At 00:15, Israeli forces raided Yatta town, stormed 1 civilian home and delivered a notification to civilian Mohammad Sleiman Abu Ali to report to the military intelligence and then withdrew at 04:45.
- (iv) At 01:05, Israeli forces raided Khirbet Tawwas area in Dura and patrolled it until 04:45.
- (v) At 02:30, Israeli forces raided Al-Arroub refugee camp and arrested 1 civilian.
- Arrests: The civilian arrested in Al-Arroub refugee camp is Wadi' Abed Al-Oassas, 17.
- Attacks: At 15:30, Israeli forces positioned near Al-Fawwar refugee camp fired tear gas canisters and rubber coated steel bullets and stun grenades towards civilians for alleged stoning.
- **Physical Assaults:** At 20:20, Israeli forces physically assaulted child Mahmoud Ahmad Fayiz Abu Hatta, 13, in the old city of Hebron.
- <u>Demolition of Property:</u> At 14:45, Israeli forces delivered order for the demolition of an artesian well owned by Abdallah Khalil Nassar from Al-Arroub refugee camp.

• Settler Violence:

- (i) At 15:50, Jewish settlers gathered in Shuhada Street in the old city of Hebron and provoked civilians.
- (ii) At 20:15, Jewish settlers from Kiryat Arba' east of Hebron city and stoned civilian vehicles travelling on Road 60 near the settlement.

- At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month.
 - Israeli forces broke the ceasefire agreement by opening fire from their position behind the Green Line towards Northern Gaza, Central Gaza and Khan Younis. In

addition, Israeli navy boats opened fire at fishing boats off Northern and Central
Gaza shores.
