<b>JERUSALEM</b>	<ul style="list-style-type: none"> <li>• <b><u>Closure:</u></b> <ul style="list-style-type: none"> <li>(i) On 14 December 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshippers under the age of 50 from conducting prayers at Al-Aqsa mosque compound which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound.</li> <li>(ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem according to Military Order 09/02S and restricts access to local residents as well as to civilians holding special permits.</li> <li>(iii) Israeli forces continue to close the hill between Biddo and Beit Iksa villages and deny civilian access.</li> </ul> </li> <li>• <b><u>Closure of Main Roads:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village.</li> <li>(ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.</li> <li>(iii) On 16 November 2015, Israeli forces closed the southern entrance of Jabal Al-Mukabir neighbourhood leading to Armon Hanatsif settlement with cement blocks.</li> </ul> </li> <li>• <b><u>Checkpoints:</u></b> <ul style="list-style-type: none"> <li>(i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city. At 22:40, Israeli forces closed Qalandiya checkpoint claiming unidentified persons have opened fire towards Israeli soldiers positioned at the checkpoint.</li> <li>(ii) On 19 September 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall.</li> </ul> </li> <li>• <b><u>Raids:</u></b> <ul style="list-style-type: none"> <li>(i) At 01:00, Israeli forces raided Qalandia refugee camp, clashed with civilians and stormed civilian homes and commercial stores. In two separate incidents, Israeli forces opened fire at a civilian vehicle for allegedly attempting to run over Israeli soldiers resulting in the death of a university student from Qalandia refugee camp and a civilian from Al-Bireh city in Ramallah. Also four civilians were injured during confrontations of whom were known Maher Mousa Abu Issa and Zaki Naim Abdallah. In addition, Israeli forces arrested 2 civilians (including a military officer from customs police), caused material damage to civilian home of Dr. Ala Al-Zeer and withdrew at 04:30.</li> <li>(ii) At 04:00, Israeli forces raided Beit Daqo village, arrested 1 civilian and</li> </ul> </li> </ul>

	<p>withdrew at 04:40.</p> <ul style="list-style-type: none"> <li>• <b><u>Killings:</u></b> The 2 civilians killed in Qalandia refugee camp are: Ahmad Hassan Jahajha (university student) from Qalandia refugee camp and Hikmat Hamdan from Al-Bireh in Ramallah.</li> <li>• <b><u>Arrests:</u></b> <ul style="list-style-type: none"> <li>(i) At 15:00, Israeli forces arrested female civilian Ataya Khalil Abu Aishah, 28, from Kafr Aqab village in Salaheddin Street in Jerusalem for alleged possession of a knife.</li> <li>(ii) At 19:00, Israeli forces arrested civilian Mohammad Bilal Shamasneh from qatanna village.</li> <li>(iii) The 2 civilians arrested in Qalandia refugee camp are: military Mahmoud Nayef Abu Latife and Diya' Abdel Qader.</li> <li>(iv) The civilian arrested in Beit Daqo village is Karam Mohammad Karam.</li> </ul> </li> <li>• <b><u>Deportation:</u></b> On 15 December 25, Israeli military authorities issued an order to deport civilian Abada Najeeb, 18, from the old city of Jerusalem for 4 months.</li> <li>• <b><u>Attacks:</u></b> At 16:00, Israeli forces positioned at the entrance of Isawiyye village fired tear gas canisters and stun grenades towards civilians for alleged stoning.</li> <li>• <b><u>Home Demolition:</u></b> <ul style="list-style-type: none"> <li>(i) On 15 December 2015, Israeli forces served order for the demolition of a 3-storey building in Jabal Al-Mukaber neighbourhood. The family of martyr Baha Ilayyan lives on the 2<sup>nd</sup> floor.</li> <li>(ii) In the morning of 16 December 2015, Israeli forces demolished in Sheikh Jarrah area a home (85 square meters) owned by civilian Ibrahim Dhiab under the pretext of unlicensed construction.</li> </ul> </li> <li>• <b><u>Attacks on Places of Worship:</u></b> At 09:00, Jewish settlers backed up by Israeli forces raided the compound of Al-Aqsa Mosque and provoked worshippers.</li> <li>• <b><u>Wall Gates:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.</li> <li>(ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Sawahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</li> </ul> </li> </ul>
