• Closure:

- On December 17th 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound, which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound.
- The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.
- On November 16th 2015, Israeli forces closed the south entrance of Jabal Al-Mukabir neighbourhood in Jerusalem, which leads to "Armon Hantsiv" settlement with cement blocks.

• Checkpoints:

- Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
- On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.
- <u>Detention:</u> At 15:30, Israeli forces detained three residents: Mohammad Amin Al-Khatib, Ashraf Mohammad Kan'an and Mohammad Al-Dibwani (All residents of Hizma village).
- Expulsion: On December 17th 2015, Israeli Authorities served a Military order to Khadija Kahyous (A resident of Jerusalem) which prevents her from entering the old city of Jerusalem and travelling abroad for a period of 6 months from December 16th 2015 until June 15th 2016.

• Attack:

At 11:00, Israeli forces fired rubber coated steel bullets, stun and tear gas grenades towards several residents in the village of Kufer Aqabfor alleged Stoning.

- <u>Seizure of Home:</u> On December 17th 2015, Israeli Authorities served court orders to 4 families: Castro, Hashmiyah, Al- Saydawi and Masawdah in order to seize their homes located in Aqbat Al-Khaldiya area in the old city of Jerusalem stating that the home is owned by a group of Israeli settlers before 1948 after the court ruled in favor of the Israeli settlers.
- <u>Assault on Places of Worship:</u> At 09:00, a group of Israeli settlers under the protection of Israeli Military and Police forces stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshipers.

• Wall Gates:

The Israeli army continues to close with cement blocks the Wall gate in Abu Dis

The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

- <u>Attack:</u> At 19:15, Israeli forces positioned near the wall gate in Jayyous fired stun and tear gas grenades towards several residents for alleged stoning.

• Wall Gates:

- (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access.
- (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
- <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin.
- (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut.
- (iii) At 06:30 on November 22nd 2015, Israeli forces closed the main road connecting Aqraba and Yanoun village with dirt mounds.
- (iv) On November 29th 2015, Israeli forces closed the entrance of Burin, Awarta and Osirin as well as the agricultural bypass road connecting Aqraba and Qabalan village with dirt mounds.
- (v) At 13:00 on December 1st 2015, Israeli forces closed the main road connecting Tel village and the bypass road near "Yitsahar" settlement and installed a steel gate in the area.
- **Flying Checkpoint:** At 18:30, Israeli forces set up a checkpoint at Beit Furiq junction then searched residents and vehicles until 19:30.

• <u>Raid:</u>

- (i) At 02:00, Israeli forces raided Nablus, detained a resident then withdrew at 02:45.
- (ii) At 04:30, Israeli forces raided Beit Furiq, stormed and searched 4 homes then withdrew at 05:30.
- Detention: Israeli forces detained Ahmad Samir Nayef Shan'iya.
- <u>Killing:</u> At 10:45, the child Abdallah Hussien Ahmad Nassasrah (16 years old) {a resident of Beit Furiq} was killed after Israeli forces opened fire towards him near Huwara checkpoint for allegedly attempting to stab an Israeli soldier {as alleged by the Israeli Military}.
- <u>Temporary Detention:</u> At 15:00, Israeli forces positioned at Beit Furiq checkpoint temporarily detained 3 residents including a National Security Force Officer: Adnan Najeh Awad, Raed Issam Miflih Hanini and Loai Assad Khattabah.

• Attack:

(i) At 14:20, Israeli forces positioned near the entrance of Al-Labban Al-Sharqiya fired live ammunition; rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result

- (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities.

• Closure of Main Roads:

- (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala; Wadi Rahal road near "Ifrat" settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds.
- (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks.
- (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla.
- (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
- (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.

(vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.

- (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds.
- (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.
- (ix) Since 10:45 on September 8th 2015, Israeli forces closed the agricultural road located in Arab Al-Rashaydeh village located near "Malee Amous" settlement with dirt mounds.
- (x) At 15:30 on November 20th 2015, Israeli forces closed the east entrance of Jinata and the entrance of Marah Rabah village with dirt mounds.
- (xi) At 13:10 on November 22nd 2015, Israeli forces closed the entrance of Marah Rabah village with dirt mounds.
- (xii) At 18:00 on November 27th 2015, Israeli forces closed Bararat junction located in Ras area in Beit Jallah with cement blocks.
- (xiii) At 14:50 on November 28th 2015, Israeli forces closed the entrance of Um Al-Raqaba area located in Al-Khader with cement blocks.

• Flying Checkpoint:

- (i) At 10:10, Israeli forces set up a checkpoint at the entrance of Dar Salah village and at the east entrance of Beit Sahour then searched residents and vehicles.
- (ii) At 13:20, Israeli forces set up a checkpoint near Um Salmounah village as they searched residents and vehicles until 17:55.
- (iii) At 18:40, Israeli forces set up a checkpoint at the entrance of Jurat Al-

BETHLEHEM

Sham'a village then searched residents and vehicles until 22:30.

(iv) At 22:25, Israeli forces set up a checkpoint at the west entrance of Taqou' then searched residents and vehicles until 00:25.

• Raid:

- (i) At 10:25, Israeli forces raided Al-Khader and served a military order to the administration of the local school warning them of closing down the school in the event of stoning incidents against Israeli forces from school student.
- (ii) On the afternoon of December 17th 2015, Israeli forces raided Um Salmuna village and forced merchant shop owners to close down their shops because of alleged stoning in the area.
- (iii) At 02:30, Israeli forces raided Bethlehem until 05:20.
- (iv) At 02:55, Israeli forces raided Al-Assakra village, stormed and searched several homes and detained 2 residents.
- <u>Detention:</u> Israeli forces detained 2 residents: Awwad Mohammad Awwad Assakra and Hamza Ibrahim Hamdan Jabril in Asakra village.

Attack:

- (i) At 11:20, Israeli forces positioned near the North entrance of Taqou' fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 21:25, Israeli forces positioned near the entrance of Um Salmona village forced stun and tear gas grenades towards several residents for alleged stoning.
- <u>Land Confiscation:</u> On December 16th 2015, Israeli forces served a military order for the confiscation of a plot of land approximately 101.559 Dunumes/Acres located in the area between Beit Sahour and Beit Jallah for a period of 10 years for alleged military purposes because of its location near the Wall.

• Closure:

- (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) At 05:50 on November 5th 2015, Israeli forces closed the entrance leading Farsh Al-Hawa area in Hebron with Cement blocks.
- (vi) At 10:30 on November 8th 2015, Israeli forces closed the junction located near "Hagi" settlement located in south Hebron with cement blocks.
- (vii)At 21:00 on November 11th 2015, Israeli forces closed the main road connecting Beit

Awwa and Al-Majd village with cement block and dirt mounds.

- (viii) At 15:45 on November 15th 2015, Israeli forces closed Al-Samiya village junction located at the west entrance of Al-Samou' with cement blocks.
- (ix) On November 15th 2015, Israeli forces closed the entrances of Khliat Al-Miya and Al Dirat and the two bypass roads leading east Yatta with cement blocks.
- (x) On November 23rd 2015, Israeli forces closed the entrance of Al-Qom village located in North Beit Awwa with Cement blocks.
- (xi) On December 1st 2015, Israeli forces closed a checkpoint located along Al-Shuhada road located in the old city of Hebron and prevented residents from passing through the checkpoint and redirected traffic through a road near the entrance of Jabal Al-Rahma.
- (xii)On December 9th 2015, Israeli forces closed a road near Jabal Jallis area located in the old city of Hebron and closed the bypass road.
- (xiii) On December 11th 2015, Israeli forces closed the entrance of Sa'ir located near road (60) with dirt mounds.
