JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city for the alleged stabbing of an Israeli settler. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and closed the checkpoint at 01:20 and impeded the free flow of traffic until 04:05. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. • <u>Raids:</u> At 22:10, Israeli forces raided and patrolled Al-Ram. • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 10:30, Israeli forces detained 3 (incl. 2 children) in Jerusalem: Mohammad Mustafa Al-Natsheh, 16, Mouayyad Shaher Salaymeh, 16, and Rami Zaki Bayouni. (ii) At 10:30, Israeli forces near detained Imad Ahmad Hamayel a resident of Beit Iksa. • <u>Attacks:</u> At 17:25, Israeli forces guarding the Apartheid Wall alongside Anata town fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning injuring Louay Saleh Nimer Abdel Jawad. • <u>Home Demolition:</u> On the morning of 30 December 2014, Israeli forces demolished in Jabal Al-Mukaber 2 civilian homes owned by Khaled Halaseh and Imad Abu Mayale for alleged unlicensed construction. • <u>Assault on Places of Worship:</u> At 08:30, settlers protected by Israeli forces stormed Al-Aqsa Mosque and provoked worshippers. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.

	<p>(ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</p>

(iii) At 22:30 on November 28th 2014, Israeli forces closed the entrance of Beit Illu village with cement blocks. • <u>Flying checkpoints:</u> At 08:55, Israeli forces set up a checkpoint at the entrance of Deir Abu Mashal and searched vehicles and civilians until 12:00 • <u>Raids:</u> <ul style="list-style-type: none"> (i) At 03:00 on 28 December 2014, Israeli forces raided Beit Illu village and detained 1 civilian. (ii) At 10:55, Israeli forces raided and patrolled Bitin village until 12:50. (iii) At 03:55, Israeli forces raided Sinjil, stormed several civilian homes and arrested 8 civilians and detained 5 civilians who were released at a later time: Ribhi Ghafri, Sami Ghafri, Nabil Ghafri, Mohammad Shabane, Sameh Ghafri. • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 08:50 on 28 December 2014, Israeli forces detained Yasser Abu Zeineh from Silwad (settlers force him to get off his truck, physically attacked him and handed him over to the Israeli forces). (ii) The 8 civilians arrested in Sinjil are Fadi Masalme, Shadi Masalme, Iyad Khalil, Iyad Abdallah, Azem Masalme, Mohammad Ghafri, Ahmad Tawaqshe and Islam Sami Tawaqshe. (iii) The civilian detained in Beit Illu is Adel Abdellatif Abdelqader Bazar. • <u>Temporary Detention:</u> At 20:20, Israeli forces temporarily detained 4 children from Turmus Ayya after chasing a car they were driving and released them at a later time: Rateb Abu Awwad, 15, Mahmoud Jabara, 15, Hamze Abu Awwad, 15, Mohammad Taha Sleiman, 16. • <u>Attacks:</u> <ul style="list-style-type: none"> (i) At 09:00, Israeli forces positioned near Pisgot settlement east of Al-Bireh fired tear gas canisters and stun grenades at civilians for alleged stoning. (ii) At 09:55, Israeli forces near bypass road alongside Beitunia fired tear gas canisters and stun grenades at civilians for alleged stoning. (iii) At 10:15, Israeli forces near the western entrance of Silwad fired tear gas canisters and stun grenades at civilians for alleged stoning. (iv) At 11:00, Israeli forces near the entrance of Deir Nizam fired tear gas canisters and stun grenades at civilians for alleged stoning. (v) At 14:45, Israeli forces near the entrance of Nabi Saleh village fired tear gas canisters and stun grenades at civilians for alleged stoning. • <u>Settlement Activities:</u> At 16:15, Israeli forces near Deir Nizam village razed land for the construction of a new military watch tower on land owned by Mohammad Abdel Hadi Masad.

(ii) At 01:10, Israeli forces raided Faraa refugee camp and stormed 4 civilian homes. • Confiscation of Property: At 12:40, Israeli forces in Safeh area east of Tayasir village confiscated 6 roll of wire used for fencing land and other equipment owned Anan Ahmad Ibrahim Daraghme and his brother Muhsen. Israeli forces detained the brothers and released them at 17:00. • Demolition of Property: At 09:40, Israeli forces caused severe material damage to crops during military training on land near Bardala village. The land is owned by Mohammad Nasser Fuqha and Ziyad Abdel Karim Fuqha.

(ii) The Israeli army continues to close with dirt mounds the detour road leading to Ramin village along the Tulkarem-Nablus main road. • Checkpoints: At 12:30, Israeli forces continue to intensify their restrictions at “Eniv” checkpoint and impeded the free flow of traffic until 21:45.
QALQILIYA	<ul style="list-style-type: none"> • Closure of Roads: <ul style="list-style-type: none"> (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) At 16:55 on 18 December 2014, Israeli forces closed agricultural road in Farata village near Gilead settlement with dirt mounds. • Flying Checkpoints: <ul style="list-style-type: none"> (i) At 17:00, Israeli forces set up 2 checkpoints at the eastern entrance of Qalqilya and searched vehicles and civilians. (ii) At 23:30, Israeli forces set up a checkpoint on the entrance of Sir until 01:40. • Raids: At 10:10, Israeli forces raided Jayyous, clashed with school children, detained 2 pupils and released them at a later time: Ala’ Jamil Salim 14, and Hassan Wael Hassan Shamasneh, 15. In addition, Israeli forces detained a civilian vehicle owned by Mohammad Youssef Kharbashe and damaged its lights and then withdrew at 11:00. (i) Attacks: At 17:05, Israeli forces east of Kafr Qaddoum village fired tear gas canisters and stun grenades at civilians for alleged stoning. • Wall Gates: <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at ‘Azzun ‘Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya, the Israeli army only allows students to cross to their schools outside the village through the Habla gate.

At 14:20, Israeli forces closed the checkpoint and opened fire at children in Tella area located between Beta and the checkpoint killing 1 child and injuring another.
