#### • Closure:

- (i) On December 29<sup>th</sup> 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound, which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

## • Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

## • Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and at 21:00 closed the checkpoint after alleged shooting incident towards the checkpoint(as alleged by the Israeli military) then reopened it at 23:15.
- (ii) On September 19<sup>th</sup> 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

#### • Flying Checkpoint:

- (i) At 16:15, Israeli forces set up a checkpoint at the entrance of Hizma village then searched residents and vehicles.
- (ii) At 16:15, Israeli forces set up a checkpoint at the entrance of Anata then searched residents and vehicles.

#### • Raid:

- (i) At 11:00, Israeli forces raided Al-Eisawiya village and detained a child.
- (ii) At 21:50, Israeli forces raided Beit Duqqu village (for the alleged shooting incident towards a bus carrying Israeli settlers along road 443 near Al-Tireh village), clashed with several residents and as a result injured 3 residents: Daoud Mohammad Khalil Rayan, Ahmad Abdallah Rayan and Mohammad Imad Rayan and also detained 2 residents including an injured resident and again at 04:30 raided Beit Duqqu village and stormed several homes.
- (iii) At 01:40, Israeli forces raided Shu'fat camp, clashed with several residents then withdrew at 02:15.

#### • Attack:

(i) At 10:30, Israeli forces positioned near Al-Quds University junction in Abu Dis fired stun and tear gas grenades towards several residents for alleged stoning.

#### **JERUSALEM**

- (ii) At 16:00, Israeli forces positioned near the wall gate in Qutna village fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured Rami Sami Tabanjat.
- (iii) At 21:30, Israeli forces positioned in Abu Dis fired, stun and tear gas grenades towards several residents for alleged stoning and as a result injured five residents and left 19 others suffocated from tear gas inhalation.

#### • Detention:

- (i) At 10:25, Israeli forces positioned near Anata detained Osama Muhsien (A Civil Defence force officer).
- (ii) At 21:30, Israeli forces positioned in Jerusalem detained Samir Mohammad Issa Ismail (A resident of Jurat Al-Sham'a village in Bethlehem).
- (iii) Israeli forces detained the child Mahmoud Saher Darwish (14 years old).\
- (iv) Israeli forces detained Daoud Mahmoud Khalil Rayan (injured) and Mohammad Shafiq Kamil Marar in Beit Duqqu village.
- **Physical Assault:** At 10:40, Israeli forces positioned at Jaba' village roundabout assaulted Abdallah Wajeeh Tawam.
- Assault on Places of Worship: At 10:00, a group of Israeli settlers under the protection of Israeli Military and Police forces stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshipers.

#### • Wall Gates:

- (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

#### • Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages
- (ii) . On October  $3^{\rm rd}$  2015, Israeli forces closed the main road located near "Bet El" settlement and leading to Al-Jalazoun camp with cement blocks.
- (iii) Since November 24<sup>th</sup> 2015, Israeli forces closed the main entrance of Sinjil and the east entrance of Al-Mughier village with cement blocks.
- (iv) On December 15<sup>th</sup> 2015, Israeli forces closed the West entrance of Al-Labban Al-Gharbi village with cement blocks.
- (v) At 10:25 on December 27<sup>th</sup> 2015, Israeli forces closed the west entrance of Silwad with cement blocks.

#### • Flying Checkpoint:

- (i) At 08:35, Israeli forces set up a checkpoint near "Halamish" settlement junction then searched residents and vehicles until 09:10.
- (ii) At 09:05, Israeli forces set up a checkpoint near Atarah Village Bridge then searched residents and vehicles until 11:00.
- (iii) At 19:30, Israeli forces set up a checkpoint at Ein Sinya village roundabout then searched residents and vehicles.

## **QALQILIYA**

- (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village.
- (iii) Since 16:55 on December 18<sup>th</sup> 2014, Israeli forces closed an agricultural road leading to Far'ata village which is located near "Gillad" settlement with dirt mounds
- (iv) Since 10:40 on September 1<sup>st</sup> 2015, Israeli forces closed an agricultural road leading to Far'ata village which is located near "Gillad" settlement with a steel Gate

#### • Flying Checkpoint:

- (i) At 09:20, Israeli forces set up a checkpoint at the entrance of Azzun then searched residents and vehicles.
- (ii) At 19:50, Israeli forces set up a checkpoint at the east entrance of Qalqiliya then searched residents and vehicles until 23:00.

#### • Raid:

- (i) At 02:00, Israeli forces raided Qalqiliya, detained a resident then withdrew at 06:30.
- (ii) At 02:05, Israeli forces raided Azzun, detained 3 residents then withdrew at 02:25.

#### • Detention:

- (i) At 10:30, Israeli forces detained Mohammad Abed Qashta (A resident of Qalqiliya).
- (ii) Israeli forces detained Muhsien Ibrahim Sharim in Qalqiliya.
- (iii) Israeli forces detained three residents: Ma'moun Farouq Sa'id Abu Haniya, Wael Mohammad Hassan Hussien and Adham Mohammad Hamad Saleem in Azzun.

#### • Attack:

- (i) At 12:05, Israeli forces positioned near the entrance of Azzun fired live ammunition; rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 16:45, Israeli forces positioned in Al-Mantar area located in North Azzun fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.

#### • Wall Gates:

- (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access.
- (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya, the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
- <u>Closure:</u> Since December 17<sup>th</sup> 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area.

## • Closure of Main Roads:

- (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin.
- (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut.

#### **NABLUS**

- (iii) At 06:30 on November 22<sup>nd</sup> 2015, Israeli forces closed the main road connecting Aqraba and Yanoun village with dirt mounds.

  (iv) On November 29<sup>th</sup> 2015, Israeli forces closed the entrance of Burin, Awarta and Osirin as well as the agricultural bypass road connecting Aqraba and Qabalan village with dirt mounds.

  (v) At 13:00 on December 1<sup>st</sup> 2015, Israeli forces closed the main road connecting Tel village and the bypass road near "Yitsahar" settlement and installed a steel gate in the area.
  - <u>Checkpoints:</u> At 17:40, Israeli forces intensified their restrictions at Beit Furiq checkpoint and impeded the free flow of traffic until 19:00.

## • Flying Checkpoint:

- (i) At 08:35, Israeli forces set up a checkpoint along the main road connecting Nablus and Qalqiliya searching residents and vehicles until 11:10.
- (ii) At 17:25, Israeli forces set up a checkpoint at Deir Sharaf village junction along the main road connecting Nablus and Tulkarem searching residents and vehicles until 18:40.
- (iii) At 21:05, Israeli forces set up a checkpoint at the entrance of Duma village searching residents and vehicles.
- (iv) At 21:35, Israeli forces set up a checkpoint in the area between Aqraba and Osirin village searching residents and vehicles until 23:00.
- (v) At 22:20, Israeli forces set up a checkpoint at Beita junction searching residents and vehicles.

#### Raid

- (i) At 15:15, Israeli forces raided Osirin village then stormed and searched a home.
- (ii) At 02:00, Israeli forces raided Beit Furiq, stormed and searched several homes then withdrew at 05:50.
- (iii) At 02:35, Israeli forces raided Nablus until 05:50.
- <u>Detention:</u> At 01:30 on December 29<sup>th</sup> 2015, Israeli forces detained Ameer Astita during their raid into Nablus as mentioned in the previous report.

## • Temporary Detention:

- (i) At 12:25, Israeli forces positioned near Qusra village temporarily detained Ghassan Daghlas and A Palestine Television news crew then released them later.
- (ii) At 13:00, Israeli forces positioned at Beir Furiq checkpoint temporarily detained Ibrahim Abdel-Rahman Hafith Khatatbah (A Palestinian Intelligence force officer) then released him at 15:45.
- Land Confiscation: On December 29<sup>th</sup> 2015, Israeli forces served a military order for the confiscation of 500 Dunumes of Agricultural land in Qusra and Jurish villages, which is located near "Migdolim" settlement.

## • Closure of Main Roads:

# (i) The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland.

- (ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian, which was closed since the year 2000 and prevented access from 08:00 until 09:20.
- (iii) Since 11:00 on July 30<sup>th</sup> 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks.

- (x) At 15:30 on November 20<sup>th</sup> 2015, Israeli forces closed the east entrance of Jinata and the entrance of Marah Rabah village with dirt mounds.
- (xi) At 13:10 on November 22<sup>nd</sup> 2015, Israeli forces closed the entrance of Marah Rabah village with dirt mounds.
- (xii) At 18:00 on November 27<sup>th</sup> 2015, Israeli forces closed Bararat junction located in Ras area in Beit Jallah with cement blocks.
- (xiii) At 14:50 on November 28<sup>th</sup> 2015, Israeli forces closed the entrance of Um Al-Raqaba area located in Al-Khader with cement blocks.

#### • Flying Checkpoint:

- (i) At 08:45 and again at 20:45, Israeli forces set up a checkpoint near Dar Salah village located at the east entrance of Beit Sahour then searched residents and vehicles until 23:20.
- (ii) At 18:30, Israeli forces set up a checkpoint at the entrance of Jinata then searched residents and vehicles until 21:00.
- Raid: At dawn on December 29<sup>th</sup> 2015, Israeli forces raided Za'tara and detained two residents.
- <u>Attack:</u> At 09:45, Israeli forces positioned near Al-Ayda camp in North Bethlehem fired stun and tear gas grenades towards several residents for alleged stoning.
- <u>Detention:</u> Israeli forces positioned at Za'tara checkpoint detained two residents: Talhat Hassan Ahmad Danoun and Musa Ali Musa Abu Nimrat.
- Assault on Property: On December 29<sup>th</sup> 2015, Israeli stormed Betar village and served military orders for the demolition of 15 homes owned by the following: Fadi Khalil Al-Qaisi, Fadi Jamil Obeidallah, Ibrahim Ali Al-Najjar, Yasser Mahmoud Qatoush, Hazim Ahmad Abdel-Wahab, Hazem Adnan Al-Shouli, Mohammad Hassan Al-Shami and Hamza Yacoub Hamaydat for allegedly being built without a licence.

#### Closure:

- (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

#### **Closure of Main Roads:**

- (i) The Israeli army continues to close the entrances to Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) At 05:50 on November 5<sup>th</sup> 2015, Israeli forces closed the entrance leading Farsh Al-Hawa area in Hebron with Cement blocks.
- (vi) At 10:30 on November 8th 2015, Israeli forces closed the junction located near "Hagi" settlement located in south Hebron with cement blocks.
- (vii)At 21:00 on November 11th 2015, Israeli forces closed the main road connecting Beit Awwa and Al-Majd village with cement block and dirt mounds.

- (ix) On November 15<sup>th</sup> 2015, Israeli forces closed the entrances of Khliat Al-Miya and Al Dirat and the two bypass roads leading east Yatta with cement blocks.
- (x) On November 23<sup>rd</sup> 2015, Israeli forces closed the entrance of Al-Qom village located in North Beit Awwa with Cement blocks.
- (xi) On December 1<sup>st</sup> 2015, Israeli forces closed a checkpoint located along Al-Shuhada road located in the old city of Hebron and prevented residents from passing through the checkpoint and redirected traffic through a road near the entrance of Jabal Al-Rahma.
- (xii)On December 9th 2015, Israeli forces closed a road near Jabal Jallis area located in the old city of Hebron and closed the bypass road.

## **Flying Checkpoint:**

(i) At 08:00, Israeli forces set up a checkpoint at the north entrance of Hebron located along the bypass road (35) near Halhoul Bridge then searched residents and vehicles.
