At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles. Israeli forces broke the cease fire agreement by opening fire towards North Gaza and Khan Yunis. Israeli Naval vessels broke the cease fire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza and injured 2 fishermen including a child. |
