#### **WEST BANK**

#### • Closure:

- (i) On January 18<sup>th</sup> 2013, the Israeli army increased its restrictions at checkpoints located at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

#### • Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close the gate along the Wall section separating the area of Dahiyat Al-Bareed from Al-Ram town.
- (iii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandia checkpoint.

#### • Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
- (ii) On September 19<sup>th</sup> 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.
- (iii) At 10:00, Israeli forces intensified their restrictions at Jaba' checkpoint located on the main road connecting Jerusalem, Ramallah and Jericho and impeded the free flow of traffic.
- Raid: At 02:00, Israeli forces raided "Bab Al-Qarama village" located in south Beit Iksa village which was set up by demonstrators to protest settlement construction in the area; removed 4 protest tents and demolished a mosque built in the area, temporarily detained several demonstrators and released them at a later time.

#### Attack:

- (i) On the evening of January 20<sup>th</sup> 2013, Israeli forces positioned at a checkpoint located near Beit Iksa, fired tear gas grenades and rubber coated steel bullets towards residents as they were heading towards "Bab Al-Qarama village" and as a result injured Mohammad Hammadin and Mohammad Shamashna.
- (ii) At 20:00, Israeli forces positioned at Qalandiya checkpoint fired tear gas grenades towards several residents for alleged stoning.
- <u>Settlement Activity:</u> On January 20<sup>th</sup> 2013, Israeli military bulldozers began levelling agricultural in Shu'fat area in Jerusalem for the purpose of paving road (21) near "Zaif" settlement for the purpose of connecting Jerusalem city center with "Ramat Shlomo" and "Ramout" settlements.

# At 21:00 on November 21<sup>st</sup> 2012, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. On November 14<sup>th</sup> 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24<sup>th</sup> 2012, Israeli forces imposed floating marks of 6 miles. Israeli Naval vessels broke the ceasefire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza.
