(ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Ikksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Ikksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. (iii) On the morning of January 27th 2015, Israeli forces closed the north entrance of Al-Ram with cement blocks • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 09:20, Israeli forces set up a checkpoint at the entrance of Al-Tur neighbourhood. (ii) At 09:30, Israeli forces set up a checkpoint along the road leading to Beit Hanina. (iii) At 01:00, Israeli forces set up a checkpoint at the entrance of Biddu. • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 09:00, Israeli forces positioned near Bab Al-Sahara gate in the old city of Jerusalem detained Mahmoud Tufaha (A resident of the old city of Jerusalem). (ii) At 09:05, Israeli forces positioned in Silwan neighbourhood detained two residents: Jamal Al-Awar and Mohammad Al-Awar. (iii) At 09:10, Israeli forces positioned at Jaba’ checkpoint located along the main road connecting Jerusalem, Ramallah and Jericho detained Mohammad Al-Sabah (A resident of Al-Jalazoun camp in Ramallah). • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 12:00, Israeli forces positioned near Al-Ram north junction fired rubber coated steel bullets stun and tear gas grenades towards several residents for alleged stoning. 	<p>(v) At 22:00, Israeli forces positioned in the old city of Jerusalem fired stun and tear gas grenades towards several residents for alleged stoning.</p> <ul style="list-style-type: none"> • <u>Assault on Places of Worship:</u> At 09:00, a group of Israeli settlers under the protection of Israeli forces and Police stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshippers. • <u>Settler Violence:</u> <ul style="list-style-type: none"> (i) At 08:00, Israeli settlers stormed Al-Thuri neighbourhood in Jerusalem and assaulted the child Ibrahim Ghayth (14 years old) as he was going to school. (ii) At 09:00, an Israeli settler vehicle ran over the child Khaled Suweis (16 years old) along a road in Al-Tur neighbourhood and as a result, left him hospitalised with contusions. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

(ii) At 01:00, Israeli forces raided Sanur village detained a University student then withdrew at 02:00. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
