In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. <u>Closure of Main Roads:</u> (i) The Israeli army continues to close Al-Tuwani and Al-Karmil villages. (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City. (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town. (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks. (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.
HEBRON	 Flying Checkpoint: At 21:40, Israeli forces set up a checkpoint at Halhoul Bridge until 22:55. Raid: On the morning of July 2nd 2015, Israeli forces raided Beit Ummar, clashed with several residents as they stormed and searched several homes and summoned two residents: Sultan Oday and Mohammad Oday to report to Israeli Intelligence for questioning. Detention: (i) At 21:40, Israeli forces positioned near Al-Ibrahimi mosque in the old city of Hebron detained Mahmoud Al-Zarou (A resident of Hebron). (ii) At 22:00, Israeli forces detained Sultan Oday (A resident of Beit Ummar) as he was reporting to Israeli intelligence for questioning based on a prior summon.

ALL DISTRICTS	 At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. Israeli force broke the cease-fire agreement and opening fire towards Central Gaza.
NORTHERN GAZA	 <u>Closure of Crossing Point</u>: Beit Hanun (Erez) is open for the passage of critical patients, journalists, NGO staff, businesspersons and passengers travelling abroad through Al-Karama crossing with previous coordination. <u>Detention</u>: At 20:55 on July 1st 2015, Israeli forces positioned at Beit Hanun (Erez) crossing detained Abdedel-Nasser Assaydeh (A resident of Nablus) as he was returning from visiting his sister in the Gaza strip.

GAZA	 <u>Closure of Crossing Points:</u> (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. (ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision.
CENTRAL GAZA	• <u>Attack:</u> At 18:00, Israeli forces positioned behind the Green Line opened fire towards agricultural land in east Al-Buriej camp.
RAFAH	 <u>Closure of Crossing Points :</u> (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (<i>Al 'Awdah</i>) Crossing is closed. (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is open for the entry of tourist and foreign diplomats and the entry of Humanitarian assistance and construction material funded by UNRWA.
