<b>JERUSALEM</b>	<ul style="list-style-type: none"> <li>• <b>Closure:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to intensify its restrictions at checkpoints located at the entrances to the city of Jerusalem and to set up flying checkpoints in the old city of Jerusalem and around the Al Aqsa Mosque compound.</li> <li>(i) On 05 January 2009, the Israeli authorities issued Military Order # S/02/09 on the closure of and denial of civilian access to the "demarcation area" along the Wall in the area surrounding the city of Jerusalem. Accordingly, local residents and civilians holding permits can access this area through crossings and gates set up at the entrances to the city of Jerusalem. (The demarcation area is defined by a set of military orders relating to land confiscation for Wall construction).</li> <li>(ii) The Israeli army continues to impose a blockade and deny civilian access to a hill between the village of Biddu and Beit Iksa due to its geographical significance as it overlooks the city of Jerusalem.</li> </ul> </li> <li>• <b>Closure of Main Roads:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks and dirt barricades the entrance to the village of Jaba'.</li> <li>(ii) The Israeli army continues to close the iron gate along the Wall section, separating the area of Dahiyat al Bareed from the town of Ar Ram.</li> <li>(iii) On 28 May 2010, the Israeli army closed with an iron gate the eastern entrance to the village of Beit Iksa leading to the city of Jerusalem and reported to civilians that they should cross Qalandiya checkpoint to access the city.</li> </ul> </li> <li>• <b>Checkpoint:</b> The Israeli army continues to consider Qalandiya checkpoint a "border crossing point" and has designated a special crossing lane for holders of Jerusalem IDs and those possessing permits to access the city of Jerusalem.</li> <li>• <b>Raid/House Occupation:</b> At dawn on 14 July 2010, the Israeli army raided the town of 'Anata, occupied the roof of a house, converted it into a military post, took photographs of the town, and patrolled the area.</li> <li>• <b>Wall Gates:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the Wall gate in the town of Abu Dis with cement blocks.</li> <li>(ii) The Israeli army continues to deny civilian access through the Wall gate on Ash Shayyah road in the area between the villages of As Sawahira ash Sharqiya and As Sawahira al Gharbiya, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</li> </ul> </li> <li>• <b>Wall Construction:</b> Wall construction continues in the area of Al 'Eizariya to Ash Shayyah, from Beit Surik village to Biddu; in the areas of Al Judeira, Bir Nabala, and Beit Hanina; west of the village of Al Jib; in the vicinity of the village of Qatanna; south of the village of Beit Hanina; and in the area surrounding the checkpoint set up at the entrance to Shu'fat refugee camp.</li> </ul>

<p style="text-align: center;"><b>RAMALLAH &amp; EL BIREH</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Main Roads:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with dirt barricades and cement blocks the entrances to the town of Sinjil, the village of Saffa; and the junction to the villages of Kafr Malik – 'Ein Samiya.</li> <li>(ii) On 15 March 2010, the Israeli army issued a military order, providing that the area located between civilian houses and the Wall in the town of Ni'lin and the village of Bil'in would be a closed military zone between 08:00 and 20:00 on Fridays for a period of 6 months. To prevent weekly demonstrations against Wall construction, civilian access to the area will be denied except with a special permit.</li> </ul> </li> <li>• <b><u>Flying Checkpoints:</u></b> <ul style="list-style-type: none"> <li>(i) At 08:00, the Israeli army set up a flying checkpoint near the town of Beit Liqya and searched civilians and vehicles.</li> <li>(ii) At 10:30, the Israeli army set up a flying checkpoint at the entrance to the town of Sinjil and searched civilians and vehicles.</li> <li>(iii) At 11:10, and again at 15:30, the Israeli army set up a flying checkpoint on the overpass to the town of 'Atara and searched civilians and vehicles.</li> </ul> </li> <li>• <b><u>Raids:</u></b> <ul style="list-style-type: none"> <li>(i) At 02:40, the Israeli army raided and patrolled the village of Qarawat Bani Zeid.</li> <li>(ii) At 02:40, the Israeli army raided and patrolled the town of Bir Zeit.</li> </ul> </li> <li>• <b><u>Wall Construction:</u></b> Wall construction continues west of the town of 'Abud; in the village of Bil'in; and in the areas of Al Midya to Ni'lin and Ni'lin to Deir Qaddis.</li> </ul>
<p style="text-align: center;"><b>JENIN</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Main Road:</u></b> The Israeli army continues to close with dirt barricades the road leading to the town of 'Arraba east of the settlement of Dotan.</li> <li>• <b><u>Flying Checkpoints:</u></b> <ul style="list-style-type: none"> <li>(i) At 19:15, the Israeli army set up a flying checkpoint on the junction to the village of Sanur and searched civilians and vehicles.</li> <li>(ii) At 19:30, the Israeli army set up a flying checkpoint on the junction to the town of 'Arraba, searched civilian vehicles, arrested a civilian, and withdrew at 20:15.</li> </ul> </li> <li>• <b><u>Arrest:</u></b> Israeli troops positioned at the flying checkpoint set up on the junction to the town of 'Arraba arrested Muhannad Iyad Ghazi Nazzal.</li> <li>• <b><u>Settler Violence:</u></b> At 18:30, a group of Israeli settlers gained access to the evacuated settlement of Homesh. Subsequently, the Israeli army evacuated settlers from the area.</li> <li>• <b><u>Wall Gates:</u></b> Passage through the Wall gates is restricted to civilians granted special Israeli permits, which affects the educational and health conditions of civilians living behind the Wall.</li> </ul>

<p style="text-align: center;"><b>TUBAS</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Checkpoint:</u></b> Though allowing civilian access to the Northern Jordan Valley between 06:00 and 22:00, the Israeli army continues to intensify its restrictions at Tayasir checkpoint east of the city of Tubas.</li> <li>• <b><u>Raids:</u></b> <ul style="list-style-type: none"> <li>(i) At 11:00, the Israeli army raided and patrolled the village of ‘Ein al Beida.</li> <li>(ii) At 02:50, the Israeli army raided the town of Tammun, searched a house, arrested a civilian, and withdrew at 04:30.</li> </ul> </li> <li>• <b><u>Arrest:</u></b> The Israeli army arrested Ahmed Sa’id Ahmed Bisharat in the town of Tammun.</li> </ul>

The Israeli army allows residents to access the village through Gate #109. Having removed the iron gate at the entrance to the village of Ras ‘Atiya, the Israeli army only allows students to cross to their schools outside the village through the Habla gate.</li> </ul> </li> </ul>

On all other days, it is open for civilian residents of the neighbourhood only between 07:00 and 02:00.</li> <li>(ii) At ‘Awarta commercial checkpoint, civilians are allowed to cross between 05:00 and 20:00, but between 05:00 and 15:00 on Fridays. All civilian vehicles are allowed to access the city of Nablus, but only commercial vehicles and ambulances can leave the city through the checkpoint.</li> </ul> </li> <li>• <b>Flying Checkpoints:</b> <ul style="list-style-type: none"> <li>(i) At 17:15, the Israeli army set up a flying checkpoint in the area between the city of Nablus and the town of ‘Asira ash Shamaliya and searched civilians and vehicles.</li> <li>(ii) At 17:20, the Israeli army set up a flying checkpoint near the junction to the village of Deir Sharaf and searched civilians and vehicles.</li> </ul> </li> <li>• <b>Raids/Attack:</b> <ul style="list-style-type: none"> <li>(i) At 19:00, the Israeli army raided the village of Khirbet Tana and arrested a civilian.</li> <li>(ii) At 00:10, the Israeli army raided the town of Beit Furik. While searching a number of houses, the Israeli army fired sound grenades. The Israeli army also arrested 6 civilians, including 2 brothers.</li> </ul> </li> </ul>

BETHLEHEM	<ul style="list-style-type: none"> <li>• <b><u>Closure:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the roads to the village of An Nu'man, with the exception of the road leading to the Wall gate in the south-eastern area of the village.</li> <li>(ii) According to Military Order # 07/02/S, the Israeli army has continued since 15 September 2007 to deny civilian access to an area measuring 22 <i>dunums</i> (5.436 acres) of land in the area of Mazmuriya in the cities of Beit Sahur and Bethlehem. The land was confiscated pursuant to Military Order # 07/31/T.</li> </ul> </li> <li>• <b><u>Closure of Main Roads:</u></b> The Israeli army continues to close with dirt barricades the road of Beit Jala-Wadi Ahmad; a road east of the town of Beit Fajjar; and an agricultural road connecting the town of Tuqu' to the village of Khirbet al Baq'a.</li> <li>• <b><u>Flying Checkpoints:</u></b> At 11:30, and again at 21:25, the Israeli army set up a flying checkpoint at the entrance to the village of Battir and searched security and vehicles.</li> <li>• <b><u>Raids/Physical Assaults:</u></b> <ul style="list-style-type: none"> <li>(i) At 17:00, the Israeli army raided and patrolled the town of Al Khadr.</li> <li>(ii) At 23:30, the Israeli army raided Ad Duheisha refugee camp in the city of Bethlehem and arrested 2 civilians, including a child.</li> </ul> </li> </ul>

	<p>(iii) At 00:20, the Israeli army raided the village of Harmala and searched 2 houses. In addition to closing the entrance to Al Laban Market with iron plates, the Israeli army continues to install an iron gate at the entrance to the area of Al Hisba (the fruits and vegetables market) in the old city of Hebron, controlling civilian access in the area.</li> <li>(ii) Having evacuated civilian residents and denied civilian access, the Israeli army continues to close the area located along the Green Line south of the town of Yatta.</li> </ul> </li> <li>• <b>Closure of Main Roads:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks the entrance to the town of As Samoa'; the eastern entrance to the village of Kharsa; the entrance to the Al Qeisi neighbourhood in the old city of Hebron; the entrances to Al 'Arrub refugee camp, the village of At Tuwani, and the town of Adh Dhahiriya; and the road connecting the town of Surif to the village of Al Jab'a.</li> <li>(ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along Ash Shalala Old Street in the old city of Hebron.</li> <li>(iii) The Israeli army continues to close with dirt barricades the road between the villages of Al Karmil and At Tuwani and all roads leading to Road # 60.</li> </ul> </li> <li>• <b>Flying Checkpoints:</b> <ul style="list-style-type: none"> <li>(i) At 14:55, the Israeli army set up a flying checkpoint on the junction to the village of Kharsa, searched civilian vehicles, and arrested a civilian, allegedly for locating a knife in his possession.</li> </ul> </li> </ul>
