(ii) At 03:40, Israeli fighter jets launched missiles towards agricultural land near Al-Ajrani family home in Khan Yunis and as a result killed two resident and injured three others. (iii) At 07:00, Israeli fighter jets launched missiles towards east Khan Yunis and as a result killed a resident and injured several others. • Killing: (i) Israeli airstrikes killed Subhi Musa (77 years old) in Khan Yunis. (ii) Israeli airstrikes killed two residents: Abdallah Al-Ajrani and Mohammad Sharab. (iii) Israeli airstrikes killed Farid Abu Daqa east Khan Yunis.
	• Palestinian Attack: On July 15 th 2014 and at dawn on July 16 th 2014, Palestinian Gunmen launched several projectiles towards the Green Line.

• Closure of Crossing Points :

- (i) Yasser 'Arafat International Airport remains closed.
- (ii) Rafah (Al 'Awdah) Crossing is open for the entry and exit of residents, students, tourists and businessmen
- (iii) Sufa Crossing is closed.
- (iv) Karm Abu Salem (Karem Shalom) Crossing is open for the passage of critical patients, journalists, NGO staff, executives, and passengers travelling abroad through Al-Karama crossing with previous coordination, diesel fuel for electric generators.

• Attack:

- (i) On July 15th 2014, Israeli forces positioned behind the Green Line launched tank artillery shells towards Yasser 'Arafat International Airport in east Rafah.
- (ii) On July 15th 2014, Israeli Naval vessels launched several missiles towards Rafah beach.

• Air Strike:

Israeli fighter jets launched missiles towards several area in Rafah district which included:

- (i) At 23:00, Israeli fighter jets launched missiles towards a vehicle near Abu Yusef Al-Najjar Hospital in Rafah city and as a result killed three residents and injured two others.
- (ii) At 02:30, Israeli fighter jets launched missiles towards Oda family home West Rafah and as a result killed two residents and injured another
- (iii) At dawn on July 16th 2014, Israeli fighter jets launched missiles towards Al-Sabarin mosque located in Tel Al-Sultan neighbourhood in Rafah city and as a result killed a resident.
- (iv) At 07:30, Israeli fighter jets launched missiles towards a resident near a home located in Al-Shawabra area in Rafah city and as a result killed him.

• Killing:

- (i) Israeli airstrikes killed three residents: Ahmad Al-Nawaj'a, Saleh Dahlis and Yasser Al-Hamoum near Abu Yusef Al-Najjar Hospital in Rafah city.
- (ii) Israeli airstrikes killed two residents: Mohammad Al-Zawahiq and Mohammad Al-Dabari in Rafah city.
- (iii)Israeli airstrikes killed Mohammad Al-Dabari Al-Sabarin mosque located in Tel Al-Sultan neighbourhood in Rafah city.
- (iv)Israeli airstrikes killed Ashraf Abu Shanab in Al-Shawabra area in Rafah city.
- <u>Palestinian Attack:</u> On July 15th 2014 and at dawn on July 16th 2014, Palestinian Gunmen launched several projectiles towards the Green Line.
