### WEST BANK

JERUSALEM	Closure:  (i) On July 17th 2015 the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers from conducting prayers in Al-Aqsa mosque compound except for Women over the age of 60, Permit holders and men ages 55.  (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.  (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.  Closure of Main Roads:  (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.  (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.  Checkpoints:  (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.  (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.  Raid: At 17:50, Israeli forces raided Biddu until 19:00.  Detention: At 23:10, Israeli forces detained positioned at Jaba' checkpoint detained Sa'eb Abbahra (A resident of Jenin).  Wall Gates:  (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.  (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem

	the construction of the wall during which they clashed with Israeli forces and as a result left several residents suffocated from tear gas inhalation.
JENIN	<ul> <li>Closure of Main Road:         <ul> <li>(i) The Israeli army continues to close with dirt mounds the road leading to the town of 'Arraba east of the illegal settlement Dotan.</li> <li>(ii) Since the evening of November 25<sup>th</sup> 2012, Israeli forces closed the western entrance of Ya'bad.</li> </ul> </li> <li>Wall Gates: Israeli forces continue too close the wall gate and only allow those holding special permits to enter through it.</li> </ul>
TULKAREM	• <u>Checkpoint:</u> Israeli forces intensified their restrictions at "Eniv" checkpoint and impeded the free flow of traffic.
QALQILIYA	Closure of Roads:  (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town.  (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village.  (iii) Since 16:55 on December 18th 2014, Israeli forces closed an agricultural road leading to Far'ata village which is located near "Gillad" settlement with dirt mounds  Demonstration: At 17:15, a demonstration took place in Kafr Qaddum against the closure of the east entrance during which they clashed with Israeli forces who tried to disrupt the demonstration who fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards demonstrators who attempted to reach they demonstration site and as a result injured Hikmat Ishtewi and left several others suffocating form tear gas inhalation.  Wall Gates:  (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access.  (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya, the Israeli army only allows students to cross to their schools outside the village through the Habla gate.

SALFIT	(i) The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland.
	(ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city

	to civilian which was closed since the year 2000 and prevented access from 08:00 until 09:20.
	(iii) Since 11:00 on July 30 <sup>th</sup> 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks.
	• <u>Checkpoints:</u> Israeli forces continue to intensify their restrictions at Za'tara checkpoint and imped the free flow of traffic.

	(v) Since June 3 <sup>rd</sup> 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.
	(vi) Since 13:20 on September 29 <sup>th</sup> 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
	(vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds.
	(viii) On January 28 <sup>th</sup> 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.

	• Closure:
	(i) The Israeli army continues to closed Khuzq Al-Far areas, as well as the old gold
	market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi
	neighbourhood, the Israeli army continues to close the entrances to the area of Al-
	Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market
	also remains closed.
	(ii) Since 05 January 2009, the Israeli army has closed the area located along the
	Green Line south of the town of Yatta. Having seized land for Wall construction,
	the Israeli army evicted the Palestinian residents and denied them access to the
	area.
	• Closure of Main Roads:
	(i) The Israeli army continues to close the entrances to Al-Tuwani and Al-Karmil
	villages.
	(ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.

	<ul> <li>Attack: At 05:30, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Al-Sudanitya beach located in West Beit Lahiya.</li> </ul>

GAZA	<ul> <li>(i) Closure of Crossing Points:</li> <li>(ii) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision.</li> <li>(iii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decisions.</li> </ul>
