At 03:00, the Israeli army, including 30 jeeps, raided the town again, opened fire, fired sound grenades, searched a number of houses, and arrested 10 individuals, including 1 child and 1 Palestinian Preventive Security officer. The Israeli army opens the road from 06:00 until 18:00 only.</li> <li>(ii) The Israeli army continues to close the main north-western entrance to the city of Salfit with dirt barricades.
