<b>JERUSALEM</b>	<ul style="list-style-type: none"> <li>• <b><u>Closure:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to intensify restrictions at checkpoints set up at entrances to the city of Jerusalem and Al Aqsa Mosque.</li> <li>(ii) On 05 January 2009, the Israeli army issued military order # S/02/09 closing the seam line area, an extension of the Wall.</li> <li>(iii) The Israeli army continues to impose a blockade and deny civilian access to a hill located in an area between the villages of Biddu and Beit Iksa.</li> </ul> </li> <li>• <b><u>Closure of Main Roads:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks and dirt barricades the entrance to the village of Jaba'.</li> <li>(ii) The Israeli army continues to close the iron gate along the Wall section separating the area of Dahiyat Al Bareed in Jerusalem city from the town of Ar Ram.</li> </ul> </li> <li>• <b><u>Checkpoints:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to consider Qalandiya checkpoint a "border crossing point" and only allows holders of Jerusalem IDs to access the city of Jerusalem.</li> <li>(ii) As of 11 April 2010, the Israeli army continues to close the checkpoint set up near the entrance to Shu'fat refugee camp in the city of Jerusalem and prevent daily civilian traffic access from 23:00 until 05:00. The closure of the checkpoint will continue for a week and half under the pretext of maintenance and setting up an infrastructure between the checkpoint and the road leading to Shu'fat refugee camp.</li> </ul> </li> <li>• <b><u>Arrest:</u></b> At 18:00 on 06 June 2010, the Israeli army arrested at Qalandiya checkpoint the civilian Muhammad Abed Yousef Badran from Qalandiya refugee camp under the pretext of finding a Molotov cocktail bottle in his possession.</li> <li>• <b><u>Wall Gates:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the Wall gate in the town of Abu Dis with cement blocks.</li> <li>(ii) The Israeli army continues to deny civilian access through the Wall gate on al-Shayyah road in the area between the villages of al-Sawahira al-Sharqiya and al-Sawahira al-Gharbiya, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</li> </ul> </li> <li>• <b><u>Wall Construction:</u></b> Wall construction continues in the area of al-'Eizariya to al-Shayyah, from Beit Surik village to Biddu, in the areas of al-Judeira, Bir Nabala, and Beit Hanina, west of al-Jib village, in the vicinity of the village of Qatanna, south of Beit Hanina village, and in the area surrounding the checkpoint set up at the entrance to Shu'fat refugee camp.</li> </ul>

<p style="text-align: center;"><b>RAMALLAH &amp; EL BIREH</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Main Roads:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the entrances to Sinjil village, Safa village and the junction to the villages of Kafr Malik – Ein Samiya.</li> <li>(ii) On 15 March 2010, the Israeli army issued military order declaring the area located between civilian houses and the Wall in the town of Ni’lin and the village of Bil’in as closed military zones from 08:00 until 20:00 every Friday and for a period of 6 months. Civilian access is denied during the mentioned period without a special permit in order to prevent the weekly demonstrations against the Wall.</li> </ul> </li> <li>• <b><u>Flying Checkpoints:</u></b> <ul style="list-style-type: none"> <li>(i) At 09:30, the Israeli army set up a flying checkpoint on the overpass leading to Atara town and arrested 2 civilians.</li> <li>(ii) At 11:00, the Israeli army set up a flying checkpoint at the entrance to the village of Um Safa and searched civilians and vehicles.</li> </ul> </li> <li>• <b><u>Raids:</u></b> <ul style="list-style-type: none"> <li>(i) At 14:30, the Israeli army raided the town of Ebwin and arrested a university student.</li> <li>(ii) At 01:55, the Israeli army raided the city of El Bireh, searched a house and arrested a child.</li> </ul> </li> <li>• <b><u>Arrests:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army arrested on the overpass leading to Atara town the civilians Muhammad Waleed Rabah and Muhammad Rizq Rasheed.</li> <li>(ii) The Israeli army arrested in the town of Ebwin the civilian Malek Muhammad Yousef Zubaidi.</li> <li>(iii) The Israeli army arrested in the city of El Bireh 16-year-old Jamal Saleem Mahmoud Zeid.</li> </ul> </li> <li>• <b><u>Provocation of Palestinian Forces:</u></b> At 09:05, the Israeli army at Al Mahkama checkpoint, near the settlement of Beit El, detained a Civil Police vehicle transporting 2 criminal detainees (despite prior coordination for its passage). The Israeli army allowed it to pass at a later time following DCO intervention.</li> <li>• <b><u>Wall Construction:</u></b> Wall construction continues west of the towns and villages of ‘Abud and Bil’in, and in the areas of al-Midya to Ni’lin and Ni’lin to Deir Qaddis.</li> </ul>
<p style="text-align: center;"><b>JENIN</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Main Roads:</u></b> The Israeli army continues to close with dirt barricades the road leading to ‘Arraba town, east of the settlement of Dotan.</li> <li>• <b><u>Raids:</u></b> <ul style="list-style-type: none"> <li>(i) At 12:35, the Israeli army raided and patrolled the city of Jenin.</li> <li>(ii) At 01:15, the Israeli army raided the village of Sires, opened fire and fired stun grenades while searching 4 houses, detained their residents in open air and conducted field interrogation with them. The Israeli army withdrew at 05:15.</li> <li>(iii) At 04:00, the Israeli army raided the town of Ya’bad, searched 2 houses and arrested a civilian.</li> </ul> </li> <li>• <b><u>Arrest:</u></b> The Israeli army arrested in Ya’bad town Sharif ‘Amarneh.</li> </ul>

	<ul style="list-style-type: none"> <li>• <b>Wall Gates:</b> Passage through the Wall gates is restricted to civilians granted special Israeli permits, which affects the educational and health conditions of civilians living behind the Wall.</li> </ul>
<b>TOUBAS</b>	<ul style="list-style-type: none"> <li>• <b>Checkpoint:</b> The Israeli army continues to intensify restrictions at Tayasir checkpoint, east of the city of Tubas, allowing civilian access from 06:00 to 22:00.</li> <li>• <b>Attack on Property:</b> On 06 June 2010, the Israeli army in the plain of 'Atouf village served notices to 8 civilians raising sheep to evacuate their houses. The Israeli army gave them a notice of 10 days to evacuate the area.</li> </ul>
<b>TULKAREM</b>	<ul style="list-style-type: none"> <li>• <b>Closure of Main Roads:</b> The Israeli army continues to close with dirt barricades the road between the town of Kafr Al Labad and the village of Shofeh and the road between the villages of Shofeh and Izbat Shofeh.</li> <li>• <b>Checkpoints:</b> The Israeli army continues to intensify restrictions at Einav checkpoint that is set up on Tulkarm-Nablus main road.</li> <li>• <b>Raids:</b> <ul style="list-style-type: none"> <li>(i) At 10:20, the Israeli army raided and patrolled Tulkarm city.</li> <li>(ii) At 16:25, the Israeli army raided the village of Ramin and stormed a coffee shop.</li> <li>(iii) At 17:00, the Israeli army raided the town of Anabta and patrolled the area.</li> </ul> </li> <li>• <b>Wall Gates:</b> Passage through the wall gates is restricted to civilians granted special Israeli permits, which affects the educational and health conditions of civilians living behind the Wall.</li> </ul>
<b>QALQILYA</b>	<ul style="list-style-type: none"> <li>• <b>Closure of Roads:</b> The Israeli army continues to close with cement blocks the agricultural roads east of the town of 'Azzun.</li> <li>• <b>Flying Checkpoints:</b> <ul style="list-style-type: none"> <li>(i) At 08:10, the Israeli army set up a flying checkpoint near the entrance to the village of Jinsafut.</li> <li>(ii) At 10:15, the Israeli army set up a flying checkpoint at the entrance to Azzun town. Again at 18:00, the Israeli army set up a flying checkpoint and searched civilians and vehicles.</li> <li>(iii) At 19:00, the Israeli army set up a flying checkpoint at the entrance to the village of Jit and searched civilians and vehicles.</li> <li>(iv) At 19:55, the Israeli army set up a flying checkpoint in the area between the villages of Hajja and Al Funduq and searched civilians and vehicles.</li> </ul> </li> <li>• <b>Raid:</b> At 10:10, the Israeli army raided and patrolled Jayyus town.</li> <li>• <b>Attack:</b> At 00:40, the Israeli army at Wall gate # (109) opened fire towards 4 civilians driving a horse-cart.</li> <li>• <b>Wall Gates:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to intensify its restrictions at 'Azzun 'Atma Wall gate and to search civilians, including students, with a metal detector.</li> </ul> </li> </ul>

	<p>(ii) On 12 May 2010, the Israeli army erected an iron gate at the entrance to the village of Wadi Ar-Rasha (after removing the iron gate erected at the entrance to the village of Ras Atiya), and prevented civilians from the village from passing through it. The Israeli army allows the passage of students to their schools outside the village through Habla town gate, while allowing the passage of civilians through the iron gate # 109.</p>
<p>NABLUS</p>	<ul style="list-style-type: none"> <li>• <b>Closure of Main Roads:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks the roads of Tel-Burin, Beit Furik-Salem, and the eastern entrance to the village of Al Lubban Ash Sharqiya; and with dirt barricades the southern entrance to the village of Duma, the eastern entrance to the village of Al Lubban Ash Sharqiya, the western entrances to the town of Aqraba and the village of Majdal Bani Fadil, the northern entrance to the town of Qabalan, as well as the settler bypass road connecting the village of Deir al-Hatab to Alon Moreh settlement.</li> <li>(ii) The Israeli army continues to close by an iron gate the western entrance to An Naqura village, opposite Shavi Shomron settlement.</li> <li>(iii) The Israeli army continues to close with dirt barricades the southern entrance to the village of Qaryut and the road connecting the town of Aqraba to the village of Osarin.</li> <li>(iv) The Israeli army continues to close with dirt barricades the side road between the town of Qabalan and the village of Osarin.</li> </ul> </li> <li>• <b>Checkpoints:</b> <ul style="list-style-type: none"> <li>(i) At Tur neighborhood checkpoint (set up on Jerzim Mount) is closed on Fridays and Saturdays as well as during Jewish holidays. On other days, it is open for civilian residents of the neighborhood only from 07:00 until 02:00.</li> <li>(ii) Awarta commercial checkpoint is open for civilians from 05:00 until 20:00 and on Friday from 05:00 until 15:00.</li> </ul> </li> <li>• <b>Flying Checkpoint:</b> At 09:30, the Israeli army set up a flying checkpoint on the junction leading to the village of Majdal Bani Fadel and searched civilians and vehicles.</li> <li>• <b>Raids:</b> <ul style="list-style-type: none"> <li>(i) At 01:25, the Israeli army raided and patrolled the village of Beit Imrin.</li> <li>(ii) At 01:30, the Israeli army raided the city of Nablus, searched 3 houses and withdrew at 05:00.</li> <li>(iii) At 01:35, the Israeli army raided and patrolled the town of Asira Ash-Shamaliya.</li> </ul> </li> <li>• <b>Detention:</b> At 16:00, the Israeli army at Huwwara checkpoint detained the civilian Jamal Sadeq Ahmad Hijaz under the pretext of finding a knife in his possession. The Israeli army released him at 17:30.</li> <li>• <b>Settler Violence:</b> At 08:00, a group of Israeli settlers protected by the Israeli army entered the archeological area in the village of Sebastia and withdrew at 15:30.</li> </ul>

<b>BETHLEHEM</b>	<ul style="list-style-type: none"> <li>• <b><u>Closure:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the roads to the village of An Nu'man, with the exception of the road leading to the Wall gate in the south-eastern area of the village.</li> <li>(ii) The Israeli army continues to prevent civilian access to an area that is located in the cities of Beit Sahur and Bethlehem.</li> </ul> </li> <li>• <b><u>Closure of Main Roads:</u></b> The Israeli army continues to close with dirt barricades the roads of Beit Jala-Wadi Ahmad, the sideway east of Beit Fajjar town and the agricultural road that is located between the town of Taqu'a and the village of Khirbet Al Baq'a.</li> <li>• <b><u>Raids:</u></b> <ul style="list-style-type: none"> <li>(i) At 24:00, the Israeli army raided the town of Za'tara, searched a house and served summon to a civilian to report to the Israeli Intelligence agency.</li> <li>(ii) At 00:20, the Israeli army raided the village of Ash-Shawawra and searched a house.</li> <li>(iii) At 01:40, the Israeli army raided and patrolled the city of Beit Jala.</li> </ul> </li> <li>• <b><u>House Demolition:</u></b> On 07 June 2010, the Israeli army served notices in the village of Um Salamuna for demolishing 4 houses belonging to the civilians: Hilmi Talab Abdulhafeez Taqatqah; Muhammad Mahmoud Mousa; Akram Isma'il Abu Rahmah; and Ahmad Talab Abdulhafeez Taqatqah.</li> <li>• <b><u>Wall Construction:</u></b> Wall construction continues in the area northwest of the town of al-Khadr and Beit Jala city; in the area of Wadi Rahhal east of Ephrata settlement; and in the area surrounding al-Walaja village.</li> </ul>
<b>HEBRON</b>	<ul style="list-style-type: none"> <li>• <b><u>Closure:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the following locales in the old city of Hebron: al-Shuhada' Street and the area of al-Sahleh with cement blocks and barbed wire; the old gold market with an iron gate; the area of Khuzq al-Far near the settlement of Abraham Avino with a dirt barricade and an iron gate; and the entrance to the area of al-Khan with an electronic gate, isolating the area from al-Laban Market and the area of al-Sahleh. The Israeli army continues to close the entrance to al Laban Market by iron boards. The Israeli army also continues to install an iron gate at the entrance to the area of al-Hisba (the fruits and vegetables market) in the old city of Hebron, thereby controlling civilian access in the area.</li> <li>(ii) The Israeli army continues to close the area located near the Green Line, south of Yatta town, evacuating the area of those inside it and denying them access to it.</li> </ul> </li> <li>• <b><u>Closure of Main Roads:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks the following locales: the entrance to the town of al-Samoa'; the area of al-Hawawir</li> </ul> </li> </ul>

In the meantime, armed Palestinian groups declared a one-week-long ceasefire. Meanwhile, the ceasefire was extended until 05 February 2009. The ceasefire is holding despite the end of the specified period.</li> </ul>
<p style="text-align: center;"><b>NORTHERN GAZA</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Crossing Point:</u></b> Beit Hanun (Erez) Crossing is partially open for previously coordinated humanitarian cases, foreign nationals and medical supplies donated by the Hashemite Kingdom of Jordan.</li> </ul>



<b>GAZA</b>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Crossing Points:</u></b></li> <li>(i) Al-Muntar (Karni) Crossing is closed.</li> <li>(ii) Al-Shuja'iya (Nahal 'Oz) Crossing for fuel transport is closed since 04 January 2010 by an Israeli unilateral decision.</li> </ul>
<b>CENTRAL GAZA</b>	<ul style="list-style-type: none"> <li>• Activities not reported.</li> </ul>

<b>RAFAH</b>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Crossing Points:</u></b></li> <li>(i) Yasser 'Arafat International Airport remains closed.</li> <li>(ii) Rafah (Al Awdah) Crossing is open for the departure of patients, students and visa holders, and for the entry of civilians and patients who received treatment at Egyptian hospitals, in addition to the entry of humanitarian assistance.</li> <li>(iii) Sufa Crossing is closed.</li> <li>(iv) Karm Abu Salim (Karem Shalom) Crossing is partially open for the transport of food, humanitarian assistance, a quantity of industrial diesel for the electricity plant and cooking gas.</li> </ul>
