JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to intensify restrictions at checkpoints set up at entrances to the city of Jerusalem and Al Aqsa Mosque. (ii) On 05 January 2009, the Israeli army issued military order # S/02/09 closing the seam line area, an extension of the Wall. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill located in an area between the villages of Biddu and Beit Iksa. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt barricades the entrance to the village of Jaba'. (ii) The Israeli army continues to close the iron gate along the Wall section separating the area of Dahiyat Al Bareed in Jerusalem city from the town of Ar Ram. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to consider Qalandiya checkpoint a "border crossing point" and only allows holders of Jerusalem IDs to access the city of Jerusalem. (ii) As of 11 April 2010, the Israeli army continues to close the checkpoint set up near the entrance to Shu'fat refugee camp in the city of Jerusalem and prevent daily civilian traffic access from 23:00 until 05:00. The closure of the checkpoint will continue for a week and half under the pretext of maintenance and setting up an infrastructure between the checkpoint and the road leading to Shu'fat refugee camp. • <u>Raid:</u> At dawn on 08 June 2010, the Israeli army raided Qalandiya refugee camp and arrested a child. • <u>Arrest:</u> The Israeli army arrested in Qalandiya refugee camp 15-year-old Bilal Sami Ahmad Mtair. • <u>Provocation of Palestinian Forces:</u> On 02 June 2010, An Israeli Intelligence officer called "Captain Omar" telephoned Officer Emad Muhammad Zayyoud, a Palestinian National Security officer, and summoned him to Qalandiya checkpoint. The Israeli officer warned the Palestinian officer that he will be arrested if he does not come to see him. He also told him to notify his superiors and give them his telephone number to call him. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the Wall gate in the town of Abu Dis with cement blocks. (ii) The Israeli army continues to deny civilian access through the Wall gate on al-Shayyah road in the area between the villages of al-Sawahira al-Sharqiya and al-Sawahira al-Gharbiya, only allowing civilians

	<p>holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</p> <ul style="list-style-type: none"> • Wall Construction: Wall construction continues in the area of al-‘Eizariya to al-Shayyah, from Beit Surik village to Biddu, in the areas of al-Judeira, Bir Nabala, and Beit Hanina, west of al-Jib village, in the vicinity of the village of Qatanna, south of Beit Hanina village, and in the area surrounding the checkpoint set up at the entrance to Shu’fat refugee camp.
<p>RAMALLAH & EL BIREH</p>	<ul style="list-style-type: none"> • Closure of Main Roads: <ol style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Sinjil village, Safa village and the junction to the villages of Kafr Malik – Ein Samiya. (ii) On 15 March 2010, the Israeli army issued military order declaring the area located between civilian houses and the Wall in the town of Ni’lin and the village of Bil’in as closed military zones from 08:00 until 20:00 every Friday and for a period of 6 months. Civilian access is denied during the mentioned period without a special permit in order to prevent the weekly demonstrations against the Wall. • Flying Checkpoint: At 12:40, the Israeli army set up a flying checkpoint on the overpass leading to Atara town, detained a Civil Police vehicle carrying 3 Police officers transporting Police uniforms from Nablus city to Ramallah city. The vehicle was allowed to pass at a later time after searching it and following DCO intervention. • Raids: <ol style="list-style-type: none"> (i) At 02:00, the Israeli army raided and patrolled the village of Mazari’ An-Nubani. (ii) At 02:00, the Israeli army raided and patrolled El Bireh city. • Settler Violence: <ol style="list-style-type: none"> (i) At 19:00, a group of Israeli settlers torched civilian land planted with olive trees. The land belongs to the town of Al Mazra’a Ash Sharqiya. Consequently, the Israeli army intervened when civilians attempted to confront the settler attack. The Israeli army detain General Intelligence officer Muhammad Shraiteh and severely beat his 14-year-old son Maher who sustained a fracture in the hand and evacuated to hospital for treatment. (ii) At 21:10, a group of Israeli settlers near the settlement of Beit El hurled stones towards civilian vehicles travelling near the settlement. As a result, the vehicle of the civilian Ibrahim Muhammad Abdulqader Al Omari from the city of Bethlehem was damaged. • Wall Construction: Wall construction continues west of the towns and villages of ‘Abud and Bil’in, and in the areas of al-Midya to Ni’lin and Ni’lin to Deir Qaddis.
<p>JENIN</p>	<ul style="list-style-type: none"> • Closure of Main Roads: The Israeli army continues to close with dirt barricades the road leading to ‘Arraba town, east of the settlement of Dotan. • Raid: At 02:00, the Israeli army raided the city of Jenin and its refugee camp, searched 3 houses and arrested 3 civilians.

	<ul style="list-style-type: none"> • Arrests: The Israeli army arrested in the city of Jenin and its refugee camp the civilians: Muhammad Hisham As-Sa'di; Islam Amin Staiti; and Muhammad Hisham Abu Tabikh. • Settler Violence: On 07 June 2010, a group of Israeli settlers from the settlement of Harmish hurled stones towards civilian vehicles travelling near the settlement. As a result, the windshield of a vehicle belonging to the civilian Ahmad Awad Abu Zeid was destroyed. • Wall Gates: Passage through the Wall gates is restricted to civilians granted special Israeli permits, which affects the educational and health conditions of civilians living behind the Wall.
TOUBAS	<ul style="list-style-type: none"> • Checkpoint: The Israeli army continues to intensify restrictions at Tayasir checkpoint, east of the city of Tubas, allowing civilian access from 06:00 to 22:00. • Raid: At 19:20, the Israeli army raided and patrolled Bardala village.
TULKAREM	<ul style="list-style-type: none"> • Closure of Main Roads: The Israeli army continues to close with dirt barricades the road between the town of Kafr Al Labad and the village of Shofeh and the road between the villages of Shofeh and Izbat Shofeh. • Checkpoints: The Israeli army continues to intensify restrictions at Einav checkpoint that is set up on Tulkarm-Nablus main road. • Raid: At 03:00, the Israeli army raided and patrolled Qaffin town. • Demonstration: At 11:30, a sit in demonstration by families of political prisoners took place in the city of Tulkarm opposite the ICRC in solidarity with their children in Israeli jails and demanding their release. • Wall Gates: Passage through the wall gates is restricted to civilians granted special Israeli permits, which affects the educational and health conditions of civilians living behind the Wall.
QALQILYA	<ul style="list-style-type: none"> • Closure of Roads: The Israeli army continues to close with cement blocks the agricultural roads east of the town of 'Azzun. • Flying Checkpoints: <ul style="list-style-type: none"> (i) At 12:50, the Israeli army set up a flying checkpoint at the entrance to the town of Azzun and searched civilians and vehicles. (ii) At 16:10, the Israeli army set up a flying checkpoint at the entrance to the village of Kafr Laqif and searched civilians and vehicles. • Raids: <ul style="list-style-type: none"> (i) At 14:15, the Israeli army raided the village of Azzun Atma and served a notice for demolishing a house belonging to the civilian Samer Muhammad Salah Yunis under the pretext of not having a construction license. (ii) At 19:00, the Israeli army raided and patrolled the village of An Nabi Elias. (iii) At 00:30, the Israeli army raided the city of Qalqiliya and took photographs for all Palestinian security headquarters. (iv) At 07:15, the Israeli army raided and patrolled the town of Azzun.

	<ul style="list-style-type: none"> • <u>Arrest:</u> At 16:15, the Israeli army arrested the civilian Basheer Ahmad Muhammad Rabi' from the village of Hajja while visiting his son (a political prisoner) at Majiddu prison. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to intensify its restrictions at 'Azzun 'Atma Wall gate and to search civilians, including students, with a metal detector. (ii) On 12 May 2010, the Israeli army erected an iron gate at the entrance to the village of Wadi Ar-Rasha (after removing the iron gate erected at the entrance to the village of Ras Atiya), and prevented civilians from the village from passing through it. The Israeli army only allows the passage of students to their schools outside the village through Habla town gate, while allowing the passage of civilians through the iron gate # 109.
NABLUS	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the roads of Tel-Burin, Beit Furik-Salem, and the eastern entrance to the village of Al Lubban Ash Sharqiya; and with dirt barricades the southern entrance to the village of Duma, the eastern entrance to the village of Al Lubban Ash Sharqiya, the western entrances to the town of Aqraba and the village of Majdal Bani Fadil, the northern entrance to the town of Qabalan, as well as the settler bypass road connecting the village of Deir al-Hatab to Alon Moreh settlement. (ii) The Israeli army continues to close by an iron gate the western entrance to An Naqura village, opposite Shavi Shomron settlement. (iii) The Israeli army continues to close with dirt barricades the southern entrance to the village of Qaryut and the road connecting the town of Aqraba to the village of Osarin. (iv) The Israeli army continues to close with dirt barricades the side road between the town of Qabalan and the village of Osarin. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) At Tur neighborhood checkpoint (set up on Jerzim Mount) is closed on Fridays and Saturdays as well as during Jewish holidays. On other days, it is open for civilian residents of the neighborhood only from 07:00 until 02:00. (ii) Awarta commercial checkpoint is open for civilians from 05:00 until 20:00 and on Friday from 05:00 until 15:00. (iii) At 10:15, the Israeli army intensified its restrictions at Huwwara checkpoint and impeded civilian access. • <u>Raids:</u> <ul style="list-style-type: none"> (i) At 23:00, the Israeli army raided and patrolled the village of Sebastia. (ii) At 23:30, the Israeli army raided and patrolled the villages of Qusin and Sarra. (iii) At 23:30, the Israeli army raided and patrolled the town of Aqraba.

	<ul style="list-style-type: none"> (iv) At 01:15, the Israeli army raided the town of Qabalan, searched a number of houses and withdrew at 02:20. (v) At 02:00, the Israeli army raided and patrolled the village of Till. <ul style="list-style-type: none"> • Arrest: At 01:30 on 08 June 2010, the Israeli army arrested during a raid on the city of Nablus, as mentioned in the previous report, officer Omar Ramez Muhammad Tiryaqi from the Palestinian Military Medical Services Apparatus.
SALFIT	<ul style="list-style-type: none"> • Closure of Main Roads: The Israeli army continues to close with dirt barricades the northern entrance to the city of Salfit, and continues to close with cement blocks and iron gates the northern entrance to the town of Bruqin and the western entrance to the town of Kafr Ad Dik. • Checkpoint: The Israeli army continues to intensify its restrictions at Za'tara checkpoint and impede civilian access. • Flying Checkpoint: At 12:10, the Israeli army set up a flying checkpoint in the area between the town of Kifl Hares and the village of Hares. • Raids: <ul style="list-style-type: none"> (i) At 11:30, the Israeli army raided the village of Hares, stormed a shop for car wash and confiscated its wash equipment. The Israeli army also served notices for demolishing 2 houses under the pretext of not having construction licenses and because they are located in area C, which falls under Israeli control. The houses belong to the civilians Raslan Nayef Abdulraheem Souf and Sulaiman Mahmoud Shamlawi. (ii) At 12:40, the Israeli army raided and patrolled Bruqin town. (iii) At 01:00, the Israeli army raided the village of Qarawat Bani Hassan and arrested 2 civilians. (iv) At 01:20, the Israeli army raided and patrolled the village of Farkha until 01:45. • Arrests: The Israeli army arrested in the village of Qarawat Bani Hassan the civilians Aziz Mahmoud Mar'i and Mustafa Amin Mar'i. • Wall Construction: Wall construction continues in the area northwest of the city of Salfit, and in the village of Marda and the town of Kifl Hares north of the settlement of Ariel.
JERICHO	<ul style="list-style-type: none"> • Closure: The Israeli army continues to close Road # 90 between the city of Jericho and the village of al-'Auja with cement blocks. • Checkpoints: <ul style="list-style-type: none"> (i) The Israeli army continues to intensify its restrictions at al-Hamra checkpoint and allow civilian access from 06:00 until 22:00. (ii) The Israeli army continues to intensify its restrictions on the checkpoint set up on the junction to the village of al-'Auja and allow access only to civilians holding Jericho and Jordan Valley IDs and those with permits.
BETHLEHEM	<ul style="list-style-type: none"> • Closure: <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads to the village of An Nu'man, with the exception of the road leading to the Wall gate in the south-eastern area of the village.

	<p>(ii) The Israeli army continues to prevent civilian access to an area that is located in the cities of Beit Sahur and Bethlehem.</p> <ul style="list-style-type: none"> • Closure of Main Roads: The Israeli army continues to close with dirt barricades the roads of Beit Jala-Wadi Ahmad, the sideway east of Beit Fajjar town and the agricultural road that is located between the town of Taqu'a and the village of Khirbet Al Baq'a. • Checkpoint: At 23:00, the Israeli army intensified its restrictions at As Sawahira Ash Sharqiya (the 'Container') checkpoint, searched civilian vehicles using trained police dogs and searched civilians after forcing them to take off their clothes. The taxi driver Muhsen Bassam Badawi Al Hashlamoun was among the civilians who were subjected to such searching. • Flying Checkpoints: <ul style="list-style-type: none"> (i) At 12:50, the Israeli army set up a flying checkpoint on An Nashash area junction (the southern entrance to the city of Bethlehem) and searched civilians and vehicles. (ii) At 13:05, the Israeli army set up a flying checkpoint at the entrance to the village of Al Walaja and searched civilians and vehicles. • Raids: <ul style="list-style-type: none"> (i) At 09:25, the Israeli army raided the town of Al Ubeidiya and searched a house. (ii) At 11:45, the Israeli army raided the village of Al Walaja and leveled some 80 olive trees and forest trees. (iii) At 14:20, the Israeli army raided the village of Husan and stormed a petrol station. (iv) At 05:20, the Israeli army raided the cities of Bethlehem, Beit Sahur and Beit Jala and took photographs for a number of security headquarters and a checkpoint for the Palestinian National Security. • Detentions: <ul style="list-style-type: none"> (i) At 10:50, the Israeli army at the 'Container' checkpoint detained Police officer Ahmad Muhammad Sa'adneh and released him at a later time following DCO intervention. (ii) At 16:00, the Israeli army at the 'Container' checkpoint detained 4 Civil Police officers and released them at a later time following DCO intervention. • Wall Construction: Wall construction continues in the area northwest of the town of al-Khadr and Beit Jala city; in the area of Wadi Rahhal east of Ephrata settlement; and in the area surrounding al-Walaja village.
<p style="text-align: center;">HEBRON</p>	<ul style="list-style-type: none"> • Closure: <ul style="list-style-type: none"> (i) The Israeli army continues to close the following locales in the old city of Hebron: al-Shuhada' Street and the area of al-Sahleh with cement blocks and barbed wire; the old gold market with an iron gate; the area of Khuzq al-Far near the settlement of Abraham Avino with a dirt barricade and an iron gate; and the entrance to the area of al-Khan with an electronic gate, isolating the area from al-Laban Market and the area

	<p>of al-Sahleh. The Israeli army continues to close the entrance to al Laban Market by iron boards. The Israeli army also continues to install an iron gate at the entrance to the area of al-Hisba (the fruits and vegetables market) in the old city of Hebron, thereby controlling civilian access in the area.</p> <p>(ii) The Israeli army continues to close the area located near the Green Line, south of Yatta town, evacuating the area of those inside it and denying them access to it.</p> <ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <p>(i) The Israeli army continues to close with cement blocks the following locales: the entrance to the town of al-Samoa'; the area of al-Hawawir leading to the town of Halhoul; the road connecting the town of Surif to the village of al-Jab'a; and the eastern entrance to the village of Kharsa; the entrance to al-Qeisi neighborhood in the old city of Hebron; the main entrance to al-'Arrub refugee camp; the village of At Tuwani as well as the entrance to the town of Adh Dhahiriya.</p> <p>(ii) The Israeli army continues to prohibit Palestinian vehicles from traveling along Shalala Old Street that leads to the old city of Hebron, only allowing Israeli vehicles as well as Israeli army vehicles to travel along this street.</p> <p>(iii) The Israeli army continues to close with dirt barricades the road between the villages of Al Karmil and At Tuwani and all roads leading to bypass Road # 60.</p> • <u>Flying Checkpoints:</u> <p>(i) At 14:10, the Israeli army set up a flying checkpoint on the overpass leading to Halhul town. Again at 19:30, the Israeli army set up a flying checkpoint and searched civilians and vehicles.</p> <p>(ii) At 18:30, the Israeli army set up a flying checkpoint at the entrance to the town of Beit Kahil.</p> <p>(iii) At 20:30, the Israeli army set up a flying checkpoint at the entrance to the town of Idhna and searched civilians and vehicles.</p> • <u>Raids:</u> <p>(i) At 10:00, the Israeli army raided the city of Hebron, set up a flying checkpoint near the Muqata'a headquarters (the security compound) and patrolled the area. Again at 14:15, the Israeli army raided the area and searched 3 houses.</p> <p>(ii) At 12:30, the Israeli army raided the town of Adh Dhahiriya and arrested a civilian.</p> <p>(iii) At 16:00, the Israeli army raided and patrolled As Samoa' town.</p> <p>(iv) At 17:20, the Israeli army raided and patrolled the town of Sa'ir.</p> • <u>Arrests:</u> <p>(i) At 02:30 on 08 June 2010, the Israeli army arrested during a raid on the city of Hebron, as mentioned in the previous report, the civilian Emad Aziz Muhammad Al Ashqar.</p> <p>(ii) The Israeli army arrested in the town of Adh Dhahiriya the civilian Ibrahim Misbah Al Hawareen.</p>

GAZA STRIP

<p>ALL DISTRICTS</p>	<ul style="list-style-type: none"> • At 02:00 on 18 January 2009, the Israeli army declared a unilateral ceasefire. In the meantime, armed Palestinian groups declared a one-week-long ceasefire. Meanwhile, the ceasefire was extended until 05 February 2009. The ceasefire is holding despite the end of the specified period. • The Israeli army violated the ceasefire by opening fire intensively from its locations on the Green Line in the district of Gaza injuring a civilian. In addition, the bodies of 2 armed Palestinian individuals, missing at sea after Israeli navy boats attacked a Palestinian boat in Central Gaza district, were found. Further to the 4 armed Palestinian individuals who were also killed in the same Israeli attack, as mentioned in the report of 07 June 2010.
<p>NORTHERN GAZA</p>	<ul style="list-style-type: none"> • Closure of Crossing Point: Beit Hanun (Erez) Crossing is partially open for previously coordinated humanitarian cases and foreign nationals. • Demonstration: On 08 June 2010, a mass demonstration, with the participation of international activists, set about north of Beit Hanun town against the buffer zone near the border fence where the Israeli army deny farmers and land owners access and cultivation.
<p>GAZA</p>	<ul style="list-style-type: none"> • Closure of Crossing Points: <ol style="list-style-type: none"> (i) Al-Muntar (Karni) Crossing is partially open for the transport of wheat and fodder. (ii) Al-Shuja'iyah (Nahal 'Oz) Crossing for fuel transport is closed since 04 January 2010 by an Israeli unilateral decision. • Attack: In the afternoon of 08 June 2010, the Israeli army opened fire intensively from its locations on the Green Line towards agricultural land belonging to civilians northeast of Al-Shuja'iyah neighborhood that is located east of Gaza city. As a result, a civilian was injured.
<p>CENTRAL GAZA</p>	<ul style="list-style-type: none"> • Killings: In the afternoon of 08 June 2010, the bodies of 2 armed Palestinian individuals, missing at sea after Israeli navy boats opened machine gunfire and fired missile mortars at their boat, were found and pulled from the sea. They are Ziyad Ahmad Radi and Mahmoud Khalil Radi. Further to the 4 armed Palestinian individuals who were also

	killed in the same Israeli attack, as mentioned in the report of 07 June 2010.
KHAN YOUNIS	<ul style="list-style-type: none"> • Activities not reported.
RAFAH	<ul style="list-style-type: none"> • Closure of Crossing Points: <ol style="list-style-type: none"> (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (Al Awdah) Crossing is open for the departure of 518 patients, students and visa holders, and for the entry of 214 civilians and patients who received medical treatment at Egyptian hospitals. In addition to the entry of 12 Egyptian parliamentarians. (iii) Sufa Crossing is closed. (iv) Karm Abu Salim (Karem Shalom) Crossing is partially open for the transport of food, humanitarian assistance, a quantity of industrial diesel for the electricity plant and cooking gas.
