- (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
- (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds.
- (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.

• Flying Checkpoint:

- (i) At 10:10, Israeli forces set up a checkpoint at the west entrance of Taqou' until 12:10.
- (ii) At 16:35, Israeli forces set up a checkpoint at the entrance of Jinata until 18:30.
- (iii)At 20:45, Israeli forces set up a checkpoint in Ush Al-Ghurab area located in east Beit Sahur until 22:25.
- <u>Detention</u>: On the morning of June 11th 2015, Israeli forces positioned at Al-Container checkpoint detained Khalil (A resident of Beit Ummar in Hebron).
- <u>Attack:</u> At 11:30, Israeli forces opened fire at residents in Aida camp, no injuries reported.
- <u>Destruction of Property:</u> At 14:30, Israeli forces stormed Jorat Al-Sham'a village, served military orders for the destruction of a chicken den owned by Arif Eid for allegedly being built without a license because of its location in area C which is under Israeli Military and administrative control.
- <u>Land Levelling:</u> At 06:30, Israeli forces stormed the area located in North Qadi Fuqin and levelled a plot of agricultural land 20 dunumes(acres) opened by bSabri Manasra during which the fired stun and tear gas grenades towards several residents as they attempted to prevent the land levelling.

• Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit

Annun with cement blocks.

(v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.

• Flying Checkpoint:

- (i) At 11:10, Israeli forces set up a checkpoint along Halhul Bridge until 14:15.
- (ii) At 16:00, Israeli force set up a checkpoint at the entrance of Beit Ummar and detained a resident.

• Raid:

- (i) At 01:00, Israeli forces raided Hebron, stormed two homes, detained a resident and confiscated a cellular telephone owned by Abdallah Al-Jindi then withdrew at 04:10.
- (ii) At dawn on June 11th 2015, Israeli forces raided Beit Ummar, clashed with several residents as they stormed and searched several homes and detained two residents.

Detention:

- (i) At 02:30 on June 10th 2015, Israeli forces detained two residents Waleed Al-Zaghir and Ahmad Al-Dab'at during their raid into Hebron as mentioned in the previous report.
- (ii) Israeli forces detained Ahmad Al-Za'aqiq in Beit Ummar.
- (iii)Israeli forces detained Mahmoud Abu Shikhiduim in Hebron.
- (iv)Israeli forces detained Salah Al-Za'aqiq and Mohamamd Al-Za'aqiq in Beit Ummar.
- <u>Home Demolition:</u> At 09:55, Israeli forces stormed Al-Musafer area located in east Yatta and demolished a residential tent owned by Mohammad Abu Qubayta.
