| | (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and to |

| | to cross to their schools outside the village through the Habla gate. Wall Construction: Wall construction continued in Kafr Laqif village north of Karnei Shomron settlement; in Immatin village northeast of Imanuel settlement; and east of Kafr Thulth town near Ma'ale Shomron settlement. |

| NABLUS | Closure of Main Roads: The Israeli army continues to close the roads of Till-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut. Flying Checkpoint: At 18:00, Israeli forces set up a checkpoint at the entrance of Bata until 20:30. Raids: At 23:30, Israeli forces raided Awarta village. At 00:45, Israeli forces raided Asira Al-Qibliya. |
| SALFIT | Closure of Main Roads: The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland. Since 14 November 2010, the Israeli army has opened the northern entrance to Salfit city to civilian buses only. The entrance had been closed for seven years, and at 11:00, Israeli forces closed the entrance and impeded the free flow of traffic. Checkpoints: The Israeli army continues to restrict access at Za'tara checkpoint and impede the free flow of traffic. Flying Checkpoint: At 16:50, Israeli forces set up a checkpoint near Iskaka Bridge until 17:40. Wall Construction: Wall construction continued in the area north of Deir Istiya town southeast of the illegal settlement. |
| JERICHO | Closure of Main Road: The Israeli army continues to close Road # 90 between Jericho city and Al-Oja village with cement blocks. Checkpoints: Israeli forces continue to restrict access through Al-Hamra checkpoint set up along the road connecting Jericho and Nablus Districts, only allowing access to residents of Jericho District and the Jordan Valley area. Israeli forces continues to intensify its restrictions at the checkpoint set up on the junction to Al-Ouja village, only allowing access to residents of the Jericho District and others with access permits. Flying Checkpoint: At 22:35, Israeli forces set up a checkpoint near Al-Oja village and detained a resident. At 06:25, Israeli forces set up a checkpoint at the southern entrance of Jericho until 07:30. Detention: Israeli forces detained Ayed Milihat in Al-Oja village. Temporary Detention: At 10:20, Israeli forces positioned at Al-Hamra checkpoint temporarily detained Thaer Abu Ira and released him at a later time. |

Closure: The Israeli army continues to close roads to An Nu'man village, with the (i) exception of the road leading to the Wall gate in the south-eastern area of the village. Since 15 September 2007, the Israel army has prevented civilians from (ii) accessing or staying on 22 dunums of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities. **Closure of Main Roads:** (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road east of Beit Fajjar town; the road connecting Tuqu' town to Khirbet al **BETHLEHEM** Bag'a village; and the detour road connecting Wadi Fukin and Al Jab'a villages. (ii) Since 14:30 on January 10th 2012, the Israeli army closed a road leading to Tuqu' with dirt mounds. Flying Checkpoints: At 14:45, Israeli forces set up a checkpoint at the entrance of Al-Khadr. Raids: At 01:35, Israeli forces raided Bethlehem, stormed 2 homes and summoned Khadr Al-Hajj to report to Israeli intelligence for questioning. (i) **Demonstration:** At 13:20, a demonstration took place in Maasra against the Israeli settlements and the separation wall; Israeli forces fired tear gas towards the participants. Wall Construction: Wall construction continued northwest of Beit Jala town. Closure: (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. Since 05 January 2009, the Israeli army has closed the area located along the (ii) Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. **Closure of Main Roads:** The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages. The Israeli army continues to prohibit Palestinian vehicles from travelling (ii) along the old Al-Shalala Street leading to Hebron's Old City. The Israeli army continues to close all roads leading to Road # 60 as well as (iii) detour roads along the settler bypass road leading to Yatta town. The Israeli army continues to close with dirt mounds a detour road leading to (iv) the entrance to Al-Simiya village. Hebron **Flying Checkpoint:** At 13:10, Israeli forces set up a checkpoint at the entrance of Deir Asal village (i) until 14:00. At 13:45, Israeli forces set up a checkpoint at the entrance of Kharsa village (ii) junction. Raids: (i) At 09:00, Israeli forces raided Dura. At 18:20, Israeli forces raided Al-Tabaqa and clashed with residents. (ii)

Detainees Update

• Israeli Military court sentenced Shihab Mizhir, a resident of Bethlehem 9 months in prison and imposed a finacial fine of 3000 NIS approximately \$780.
