TULKAREM	 <u>Checkpoint:</u> Israeli forces intensified their restrictions at "Eniv" checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic. <u>Detention:</u> At 03:30 on June 24th 2015, Israeli forces detained Yazen Abdel-Fatah Abadah during their raid into Dahiyat Irtah area in Tulkarem as mentioned in the previous report.
	Closure of Roads: (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) Since 16:55 on December 18th 2014, Israeli forces closed an agricultural road leading to Far'ata village which is located near "Gillad" settlement with dirt mounds
QALQILIYA	Wall Gates: (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya, the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
	 Closure: Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. Closure of Main Roads: The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut.

At 17:500, Israeli forces set up a checkpoint in the area between Nablus and Assirah Al-Shimaliya until 18:30. At 18:30 and again at 20:40, Israeli forces set up a checkpoint at the entrance of Beit Furiq. At 20:40, Israeli forces set up a checkpoint at the entrance of Beit Dajjan village. Raid: At 20:50, Israeli forces raided Askar camp in Nablus, opened fire towards Omar Sami and as a result left him hospitalized with gunshot wounds then
	withdrew at 21:30. • <u>Detention:</u> At 15:45 on June 23 rd 2015, Israeli forces detained Yunis Qanah.
SALFIT	Closure of Main Roads: The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland. On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city

	to civilian, which was closed since the year 2000 and prevented access from 08:00 until 09:20.
	(iii) Since 11:00 on July 30 th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with
	cement blocks.

- (i) At 16:15, Israeli forces set up a checkpoint near Al-Maqbarah area located in Al-Kahder until 17:45.
- (ii) At 00:25, Israeli forces set up a checkpoint at Al-Nashash junction located in the south entrance of Bethlehem until 01:25.
- <u>Detention:</u> At 01:30, Israeli forces positioned at Billal Bin Rabah Mosque checkpoint located in North Bethlehem detained Muhyi Badarneh and Ali Hamad (both residents of Al-Ayda camp).
- <u>Destruction of Property:</u> At 16:15, Israeli forces stormed Kisan village and served a military order for the demolition of a Green House owned by Ali Abu Diya for allegedly being built without a licence.

• Closure:

- (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.

HEBRON

• <u>Flying Checkpoint:</u> At 09:30, Israeli forces set up a checkpoint at the entrance of Beit Kahil.

• Raid:

- (i) At 00:50 on June 24^{th} 2015, Israeli forces raided Al-Urob camp and clashed with several residents.
- (ii) At 02:15, Israeli forces raided Al-Shiyoukh, stormed a home and detained a resident.

• Detention:

- (i) At 19:20, Israeli forces detained Abd Al-Teety near Ein Al-Badalah area located on south Hebron.
- (ii) Israeli forces detained Mohammad Al-Mashni in Al-Shiyoukh.
- <u>Settler Violence</u>: At 11:50, Israeli settlers stormed the old city of Hebron and installed several tents then removed them at 13:30.

At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the ALL fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by DISTRICTS the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical **NORTHERN** patients, journalists, NGO staff, businesspersons and passengers travelling abroad **GAZA** through Al-Karama crossing with previous coordination. **Closure of Crossing Points:** (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. **GAZA** (ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision. **Closure of Crossing Points:** (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (Al 'Awdah) Crossing is open for the entry and exit of residents, students and businesspersons in addition to several truckloads of construction **RAFAH** material. (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is open for the entry of tourist and foreign diplomats and the entry of Humanitarian assistance and construction

material funded by UNRWA.
