JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) On June 27th 2014, The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Ikksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Ikksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and impeded the free flow of traffic. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. • <u>Flying Checkpoint:</u> At 01:15, Israeli forces set up a checkpoint at the entrance of Al-Eizariya until 02:30. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 01:30, Israeli forces raided Anata, detained a resident then withdrew at 02:00. (ii) At 03:00, Israeli forces raided Abu Dis, detained a resident then withdrew at 03:35. (iii) At dawn on June 28th 2014, Israeli forces raided Al-Isawiya village and detained a resident.

(ii) Israeli forces detained Ismail Ibrahim in Abu Dis. (iii) Israeli forces detained Anas Obied in Al-Eisawiya. • <u>Attack:</u> At 16:30, Israeli forces positioned near Al-Ram junction fired rubber coated steel bullets stun and tear gas grenades towards several residents for alleged stoning, and as a result injured 3 residents: Eyad Hijazi, Yusef Shawki and Yasser Khamis leaving them hospitalised. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices. • <u>Wall Construction:</u> Wall construction resumed in the areas north and south of Qalandiya village; south of Al-Za'ayem village; and in Wadi Al-Eizariya west of the illegal settlement Ma 'ale Adumim.

(iii) Since 17:40 on June 22nd 2014, Israeli forces closed the main entrance of Al-Laban Al-Sharqiya with dirt mounds and cement blocks • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 20:10, Israeli forces raided Ramallah until 23:00. (ii) At 02:00, Israeli forces raided Deir Abu Mash'al until 03:30. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya'bad. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 05:45, Israeli forces raided Al-Zababdeh and Jalqamous village until 07:50. (ii) At 07:00, Israeli forces raided Al-Yamoun until 07:40.

	<ul style="list-style-type: none"> • Wall Gates: Passage through the Wall gates is restricted to civilians granted special Israeli permits, which undercuts the access to education and health services for civilians living behind the Wall.
TUBAS	<ul style="list-style-type: none"> • Raid: At 02:40, Israeli forces raided Tubas, clashed with several residents as they stormed and searched several homes, detained a resident then withdrew at 07:00. • Detention: Israeli forces detained Samer Sawafta in Tubas.
TULKAREM	<ul style="list-style-type: none"> • Closure of Main Roads: <ol style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road connecting Kafr Al-Labad town to Shufa village. (ii) The Israeli army continues to close with dirt mounds the detour road leading to Ramin village along the Tulkarem-Nablus main road. • Checkpoint: Israeli forces continue to intensify their restrictions at “Eniv” checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic. • Raid: At 17:30, Israeli forces raided Tulkarem until 19:25.

(ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. • Raid: <ol style="list-style-type: none"> (i) At 18:10, Israeli forces raided Azzun until 22:00 (ii) At 21:15, Israeli forces raided Qalqiliya and detained a resident. • Detention: Israeli forces detained Yiusef Ma’arbeh in Qalqiliya. • Temporary Detention: At 12:15, Israeli forces positioned near the wall gate near Qalimiya village temporarily detained Hisham Ba’ja (A Palestinian Police officer) then released him at 13:15. • Settler Violence: At 14:15, Israeli settlers stormed agricultural land in Kafr Qaddum and chopped off the limbs of several Olive trees owned by Zahi Thaher then withdrew at 14:30. • Demonstration: At 13:40 a demonstration took place in Kafr Qaddum against the closure of the east entrance, clashed with Israeli forces as they attempted to disrupt demonstrators and injured 4 residents: Awas Taha, Walid Barham and left several residents suffocating from tear gas inhalation. • Wall Gates: <ol style="list-style-type: none"> (i) The Israeli army continues to restrict access at ‘Azzun ‘Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate. • Wall Construction: Wall construction resumed in Kafr Laqif village north of Karnei Shomron settlement; in Immatin village northeast of Immanuel settlement; and east of Kafr Thulth town near Ma ’ale Shomron settlement.

(ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian which was closed since the year 2000 and prevented access from 08:00 until 09:20. (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks. • <u>Checkpoints:</u> Israeli forces closed Za'tara checkpoint and impeded the free flow of traffic. • <u>Settler Violence:</u> At 19:05, Israeli settlers positioned near Za'tara checkpoint stoned a Cellular Telephone tower owned by Jawal (Palestinian Telecommunications Company). • <u>Wall Construction:</u> Wall construction resumed in the area north of Deir Istiya town southeast of the illegal settlement.
<p style="text-align: center;">JERICHO</p>	<ul style="list-style-type: none"> • <u>Closure:</u> At 19:40, Israeli forces declared the Dead Sea area as a closed Military area {After announcing that 3 Israeli Settlers went missing in the Hebron area} • <u>Checkpoints:</u> At 17:25, Israeli forces continue to intensify its restrictions at Al-Hamra checkpoint set up along the road connecting Jericho and Nablus District and impeded the free flow of Traffic. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 08:00, and again at 10:10, Israeli forces set up a checkpoint at the south entrance of Jericho until 10:50. (ii) At 08:30 ,at 19:25 and again at 07:10 Israeli forces set up a checkpoint near Al-Nu'emeh village in North Jericho until 08:00 (iii) At 11:20, at 19:30 and again at 01:15 Israeli force set up a checkpoint along Al-Mu'arajat road which connects Jericho and Ramallah until 01:55. (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu'man:

a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; Wadi Rahal road near “Ifrat” settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds.

- (ii) The Israeli army continues to close the road leading to “Newe Daniyyel” settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za’tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks.
 - (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla.
 - (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
 - (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.
 - (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
 - (vii) Israeli forces closed the main road connecting Surif and Al-Jub’a village with dirt mounds.
 - (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.
 - (ix) Since 10:40 on June 19th 2014, Israeli forces closed the north entrance of Beit Jallah with steal gates.
 - (x) Since 18:30 on June 22nd 2014, Israeli forces closed all the entrances leading to the main roads in Al-Ubeidiya.
- **Checkpoint:** At 14:00, Israeli forces intensified their restrictions at Container checkpoint and impeded the free flow of traffic.
 - **Flying Checkpoints:**
 - (i) At 23:00, Israeli forces set up a checkpoint beneath Al-Khadr bridge located on the road leading to West Bethlehem until 00:25.
 - (ii) At 10:20, Israeli forces set up a checkpoint at the West entrance of Taqou’ until 01:30.
 - **Raid:**
 - (i) At 02:25, Israeli forces raided Bethlehem and detained a resident.
 - (ii) At 05:20, Israeli forces raided Al-Duheisha camp in Bethlehem, clashed with several residents and as a result injured Ibrahim Mahdi (15 years old) and detained 2 residents including a National Security force officer.
 - **Detention:**
 - (i) Israeli forces detained Walid Al-Bustanjji in Bethlehem.
 - (ii) Israeli forces detained 2 residents: Nidal Abu Al-Ikir and Shadi Ma’ali in Al-Duheisha camp in Bethlehem.
 - **Demonstration:** At 13:40, a demonstration took place in Al-Ma’sara village protesting against the construction of the wall during which Israeli forces prevented protesters from reaching the demonstration site.
 - **Wall Construction:**
 - (i) Wall construction resumed in North West of Beit Jala town.
 - (ii) On May 1st 2103, an Israeli court ordered the halt of wall construction near Betar village.
 - (iii) On July 21st 2013, Israeli courts ordered the halt of construction of

In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. . • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa’ towns, Al-‘Arrub refugee camp, and Al-Tuwani and Al-Karmil villages. (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron’s Old City. (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town. (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou’ and the entrance of Beit Annun with cement blocks. (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and also closed the entrance of south Yatta with cement blocks. (vi) Since December 27th 2012, Israeli forces closed the west entrance of Swiesiya village which connects Yatta and Al-Samou’ village with cement blocks. (vii) Since 09:45 on September 23rd 2013, Israeli forces closed the main road leading to “Haji” settlement and impeded the free flow of traffic. (viii) Since March 9th 2014, Israeli forces opened a steel gate in Beit Anun. (ix) Since March 9th 2014, Israeli forces closed a road leading to Al-Rihana area in east Yatta. (x) Since 08:00 on June 15th 2014, Israeli forces closed the steel gate at the North entrance of Hebron. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. • On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles and on March 21st 2013 re imposed fishing restrictions of 3 miles. • Israeli forces broke the cease fire agreement by opening fire, launching tank Artillery shells from their positions behind the Green Line towards Khan Yunis. • Israeli fighter Jets broke the ceasefire agreement by launching missiles in 5 consecutive strikes towards Gaza, Central Gaza and Khan Yunis and as a result killed 2 Palestinian Gunmen in Gaza. • Palestinian Gunmen broke the cease fire agreement by launching projectiles towards the Green Line (As alleged by the Israeli Authorities)
