| JERUSALEM | <ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continue to intensify their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Ikksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Ikksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and impeded the free flow of traffic. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. • <u>Demonstration:</u> At 11:15, a demonstration took place in Al-Khan Al-Ahmar area protesting against land confiscation for the purpose of settlement construction during which Israeli forces fired tear gas grenades towards demonstrators and as a result suffocated 3 demonstrators from tear gas inhalation and detained 4 others. • <u>Detention:</u> <ul style="list-style-type: none"> (i) At dawn on March 10th 2014, Israeli forces positioned near Bad Hata gate in the old city of Jerusalem detained Wissam Sadr after storming his home. (ii) At dawn on March 10th 2014, Israeli forces detained Abdel Rahim Barir (16 years old) in Ras Al-Amoud neighbourhood in Jerusalem. (iii) Israeli forces detained 4 residents: Mo’ayad Abu Haykal, Adel Aliyan, Hassan Halaweh and Ahmad Aliyan in Al-Kahn Al-Ahmar area. • <u>Assault on Places of Worship:</u> On the morning of March 10th 2014, Israeli settlers under the protection of Israeli forces stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshipers. |

(ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices. • <u>Wall Construction:</u> Wall construction resumed in the areas north and south of Qalandiya village; south of Al-Za'ayyem village; and in Wadi Al-Eizariya west of the illegal settlement Ma 'ale Adumim. |
| <p>RAMALLAH & AL BIREH</p> | <ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages. (ii) Since September 3rd 2013, Israeli forces closed the north east entrance of Al-Mughier village with dirt mounds. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 19:50, Israeli forces raided Al-Bireh city, occupied a home owned by Fayez Jabr near "Bet El" settlement, damaged furniture and converted its rooftop into a military post. (ii) At 14:00, Israeli forces raided Deir Nathim village, clashed with several residents as they stormed several homes, damaged home furniture owned by Diyab Al-Tamimi after assaulting him during which Israeli forces fired stun grenades into the home of Fadil Al-Tamimi and as a result set fire to a rug and damaged the windshield of a vehicle owned by Mohamamd Abdel Rahman, temporarily detained 3 children : Mohammad Assaf (16 years old), Ragheb Yahya (9 years old) and Eyas Yahya (15 years old) then released them at a later time. (iii) At 20:05, Israeli forces raided Beitin village and clashed with its residents. • <u>Attack:</u> At 16:20, Israeli forces positioned at the entrance of Deir Abu Mash'al village fired rubber coated steel bullets and tear gas grenades towards several residents for alleged stoning. • <u>Wall Construction:</u> Wall construction resumed in the area west of 'Abud town in the area surrounding the illegal settlement 'Ofarim and north of Al-Lubban Al-Gharbi and Rantis villages. |
| <p>JENIN</p> | <ul style="list-style-type: none"> • <u>Closure of Main Road:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road leading to the town of 'Arraba east of the illegal settlement Dotan. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya'bad. • <u>Flying Checkpoint:</u> At 15:25, Israeli forces set up a checkpoint at the entrance of Ti'innik village until 16:20. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 22:45, Israeli forces raided Ya'bad. (ii) At 01:00, Israeli forces raided Sanur village, stormed several homes, summoned 4 residents: Assad Issa, Mohammad Issa, Mahmoud Ali and Mohammad Ali to report to Israeli Intelligence for questioning then withdrew at 02:00. • <u>Wall Gates:</u> Passage through the Wall gates is restricted to civilians granted special Israeli permits, which undercuts the access to education and health services for civilians living behind the Wall. |

(ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. • <u>Flying Checkpoint:</u> At 15:15, Israeli forces set up a checkpoint at the entrance of Jinsafut village. • <u>Raid:</u> At 15:15, Israeli forces raided immatin village until 16:15. • <u>Detention:</u> At 01:00 on March 9th 2014, Israeli forces detained 4 residents: Omar Atta, Abby Nofal, Abdel Rahman Khadouj and Abdel Haq Khadouj during their raid into Qalqiliya. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at ‘Azzun ‘Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate. • <u>Wall Construction:</u> Wall construction resumed in Kafr Laqif village north of Karnei Shomron settlement; in Immatin village northeast of Immanuel settlement; and east of Kafr Thulth town near Ma ’ale Shomron settlement. |

(ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma’in and the villages of Duma and Qaryut. • <u>Checkpoint:</u> At 15:50, Israeli forces intensified its restrictions at Huwara checkpoint and impeded the free flow of traffic. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 09:00, Israeli forces set up a checkpoint at Sarah village junction until 09:30. (ii) At 09:10, Israeli forces set up a checkpoint at the entrance of Burin village until 10:30. (iii) At 16:40, Israeli forces set up a checkpoint at Qussin village junction. • <u>Raid:</u> |

(ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian which was closed since the year 2000 and prevented access from 08:00 until 09:20. (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks. • <u>Checkpoints:</u> At 15:50, Israeli forces continue to intensify their restrictions at Za'tara Al-checkpoint and impeded the free flow of traffic. • <u>Raid:</u> At 23:00, Israeli forces Kafil Harris village while escorting Israeli settlers as they stormed archeological sites in the area then withdrew at 05:30. • <u>Settlement Activity:</u> At 09:30, Israeli forces stormed the area in North Yasuf village, levelled plots of land owned by Sami Ayoub, Hussni Yassin and Mustafa Mustafa to pave a road between "Kafar Tabouh" and other settlement outposts in the area. • <u>Wall Construction:</u> Wall construction resumed in the area north of Deir Istiya town southeast of the illegal settlement. |

(ii) On May 1st 2103, an Israeli court ordered the halt of wall construction near Betar village. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta.
