- (i) The Israeli army continues to increase its restrictions at checkpoints located at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers from conducting prayers at Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

## • Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close the gate along the Wall section separating the area of Dahiyat Al-Bareed from Al-Ram town.
- (iii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Oalandiya checkpoint.

### • Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and at 16:00, Israeli forces closed the checkpoint impeded the free flow of traffic until 17:00.
- (ii) On September 19<sup>th</sup> 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

#### • Detention:

- (i) At 04:00 on March 12<sup>th</sup> 2013, Israeli forces detained 2 residents: Mus'ab Abd Rabbo and Ahmad Eliyan in Sur Bahar village.
- (ii) At dawn on March 12<sup>th</sup> 2013, Israeli force detained 2 residents: Ali Jadallah (17 years old) and Musa Dubrus in Al-Isawiya.
- (iii) At 18:00 on March 12<sup>th</sup> 2013, Israeli forces detained Munir Salah Al-Din at Hizma village junction.

Since August 2<sup>nd</sup> 2012, Israeli forces closed a road leading to Beit Jalla. (iii) Raid: At 02:00, Israeli forces raided Beit Fajjar, stormed and searched several homes and detained 12 residents including 2 children. **Detention:** Israeli forces detained 12 residents in Beit Fajjar: Ihab Thawabteh (16 years old), Yusef Thawabteh (16 years old), Ibrahim Thawabteh, Raf'fat Taqatqa, Ahmad Deriya, Saher Thawabteh, Ibrahim Tagatga, Moahmmad Thawabteh, Jihad Thawabteh, Shaker Thawabteh, Yunis Thawabteh and Yusef Thawabteh. Home Demolition: At 20:45, Israeli forces served demolition orders to demolish 4 homes owned by Simon Al-Araj for allegedly being built without proper licencing because of its location in area C. Settler Violence: At 18:30, Israeli settlers stormed agricultural land in Al-Khadr and destroyed 350 olive trees owned by Ismail Subieh. Wall Construction: Wall construction resumed in North West of Beit Jala town. **Closure:** The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq (i) Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. . **Closure of Main Roads:** (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling **HEBRON** along the old Al-Shalala Street leading to Hebron's Old City. The Israeli army continues to close all roads leading to Road # 60 as well as (iii) detour roads along the settler bypass road leading to Yatta town. The Israeli army continues to close with dirt mounds a detour road leading to e (iv) to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.

On July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat

and also closed the entrance of south Yatta with cement blocks.

- (i) At 09:25 and again at 02:25, Israeli forces raided Hebron, detained a resident, stormed a home and detained a University student.
- (ii) At 18:05, Israeli forces raided Al-Urub camp, clashed with its residents and injured 2 residents: Nassar Al-Alami and Mohammad Abu Ammar.
- (iii) At 01:55, Israeli forces raided Dura and detained 2 residents.

#### Attack

- (i) At 08:55, Israeli forces positioned near Al-Urub camp fired rubber coated steel bullets and tear gas grenades towards several residents for alleged stoning.
- (ii) At 09:35, Israeli forces positioned near the entrance of Al-Fuwar camp fired tear gas grenades towards several residents for alleged stoning.
- (iii) At 09:50, Israeli forces positioned near Tariq Bin Zayed School in the old city of Hebron fired tear gas grenades towards residents for alleged stoning.
- (iv) At 16:25, Israeli forces positioned near Bab Al-Zawiya area fired rubber coated steel bullets and tear gas grenades towards residents for alleged stoning and injured Ayman Al-Jub'a and detained a resident.

- (i) At 15:15, Israeli forces positioned at Al-Fuwar camp detained Sari Hamad.
- (ii) At 18:00, Israeli forces positioned near Al-Shalashla road in the old city of Hebron detained Ehab Abu Halaweh (16 years old).
- (iii) Israeli forces detained Nahil Abu Ayesheh and Mahmoud Shabaneh in Hebron.
- (iv) Israeli forces detained Nidal Agili and Ahmad Abu Rish in Dura.
- (v) Israeli forces detained Odeh Nidal in Hebron.
- <u>Wall Construction</u>: Wall construction continued in the area surrounding the illegal settlement Eshkolot, west of Al-Thahiriya town.

- At 21:00 on November 21<sup>st</sup> 2012, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire.
- On November 14<sup>th</sup> 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24<sup>th</sup> 2012, Israeli forces imposed floating marks of 6 miles.
- Israeli Naval vessels broke the cease fire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza.
