- On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles.
- Israeli force broke the cease fire agreement by raiding and opening fire towards North Gaza.
- Israeli air force broke the cease fire agreement after Israeli military helicopter opened fire towards North Gaza
- Israeli Naval vessels broke the ceasefire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza.
- Palestinian gunmen broke the cease fire agreement by launching projectiles towards the Green Line.

Detainee Update

• Israeli courts in Salem Prison sentenced Sami Sha'bolo (68 years old) to an 18 month prison term despite the fact he is suffering a heart condition and sentenced Iz Al-Din Salem to an 8 year and 9 month prison term with an additional 5 years and sentenced Sadam Daoud to a 5 and a half year prison term with an additional 3 years.
