JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and impeded the free flow of traffic. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. • <u>Flying Checkpoint:</u> At 22:00 on May 9th 2014, Israeli forces set up a checkpoint at the entrance of Biddu until 23:00 of the same day. • <u>Detention:</u> <ul style="list-style-type: none"> (i) On May 8th 2014, Israeli forces detained 2 residents: Ahmad Abaydah and Imad Abaydah (Both residents of Bethlehem) while they were in Jerusalem for allegedly entering the city without valid permits. (ii) On May 9th 2014, Israeli forces detained 3 residents: Mohammad Rayan, Khalid Ghazawneh and Qassim Barakat in Al-Ram. (iii) At dawn on May 11th 2014, Israeli forces detained Eyad Asayleh (14 years old) after storming his home in the old city of Hebron. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic

	<p>devices.</p> <ul style="list-style-type: none"> • Wall Construction: Wall construction was halted in the areas north and south of Qalandiya village; south of Al-Za'ayyem village; and in Wadi Al-Eizariya west of the illegal settlement Ma 'ale Adumim.
RAMALLAH & AL BIREH	<ul style="list-style-type: none"> • Closure of Main Roads: <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages. (ii) Since September 3rd 2013, Israeli forces closed the north east entrance of Al-Mughier village with dirt mounds. (iii) Since 00:20 on March 4th 2014, Israeli forces closed the main road connecting Al-Jalazun camp and Bet El settlement with cement blocks. • Flying Checkpoint: At 09:30 Israeli forces set up a checkpoint at the entrance of Al-Nabi Saleh village and impeded the free flow of traffic after closing the main entrance gate then reopened it at 11:20. • Raid: <ul style="list-style-type: none"> (i) At dawn on May 10th 2014, Israeli forces raided Abboud, stormed several homes, summoned 3 residents: Rami Jabr, Muti' Abu Hassan and Dawoud Abu Hassan to report to Israeli Intelligence for questioning. (ii) At 19:00, Israeli forces raided Al-Jalazun camp and detained 2 residents. • Detention: Israeli forces detained 2 residents: Ahmad Al-Tarifi and Wasfi Sa'adat in Al-Jalazun camp. • Wall Construction: Wall construction was halted in the area west of 'Abud town in the area surrounding the illegal settlement 'Ofarim and north of Al-Lubban Al-Gharbi and Rantis villages.
JENIN	<ul style="list-style-type: none"> • Closure of Main Road: <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road leading to the town of 'Arraba east of the illegal settlement Dotan. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya'bad. • Raid: <ul style="list-style-type: none"> (i) At 06:00 on May 10th 2014, Israeli forces raided Burqin, clashed with several residents as they took photographs of a local church and damaged a vehicle owned by Ahmad Murtada, detained a child then withdrew at 09:00. (ii) At 02:55, Israeli forces raided Meithalun, clashed with several residents then withdrew at 04:30. • Detention: <ul style="list-style-type: none"> (i) At 19:30, Israeli forces positioned near Al-Jamalah village detained 4 residents including 3 children: Ahmad Al-Qarini (17 years old), Ra'fat Al-Sa'di (17 years old), Khalil Al-Sa'di (17 years old), Ihab Washahi (17 years old) and Adnan Al-Aziza as they attempted to climb the wall into Israel. (ii) Israeli forces detained Mohammad Hammad (17 years old) in Bruqin • Wall Gates: Passage through the Wall gates is restricted to civilians granted special Israeli permits, which undercuts the access to education and health services for civilians living behind the Wall.
TULKAREM	<ul style="list-style-type: none"> • Closure of Main Roads: <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road connecting Kafr Al-Labad town to Shufa village. (ii) The Israeli army continues to close with dirt mounds the detour road leading to Ramin village along the Tulkarem-Nablus main road. • Checkpoint: Israeli forces continue to intensify their restrictions at "Eniv" checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic.

	<ul style="list-style-type: none"> • <u>Flying Checkpoint:</u> At 12:50 and again at 20:40, Israeli forces set up a checkpoint at the entrance of Beit Lid until 22:30. • <u>Wall Gates:</u> Passage through the Wall gates is restricted to civilians granted special Israeli permits, which undercuts the access to education and health services for civilians living behind the Wall.

(ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 08:00, Israeli forces set up a checkpoint between Azzun and Kafr Thulth until 10:00. (ii) At 13:55, Israeli forces set up a checkpoint at the east entrance of Qalqiliya until 14:40. (iii) At 18:50 and again at 23:50, Israeli forces set up a checkpoint at the entrance of Azzun, detained a resident then withdrew at 02:00. (iv) At 21:25, Israeli forces set up a checkpoint at Kafr Laqif village junction until 02:00. (v) At 23:50, Israeli forces set up a checkpoint at the entrance of Izbit Al-Tabib village until 02:00. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 11:20, Israeli forces raided Hajja village, summoned 2 residents: Khadr Masalha and Shadi Battat to report to Israeli Intelligence for questioning. (ii) At 13:55, Israeli forces raided Azzun, set up a checkpoint at its entrance then withdrew at 14:30. • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 16:40, Israeli forces positioned near Al-Nabi Elisa's village detained Harrith Barham, a resident of Kafr Qaddum. (ii) At 22:10, Israeli forces positioned near the wall gate in Habalat detained Mohammad Hillal, a resident of Habalat. (iii) Israeli forces detained Majdi Al-Sum near the entrance of Azzun. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. The Israeli army used bomb sniffing dogs to search residents and seized a Palestinian Police vehicle then allowed it to pass through at a later time. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate. • <u>Wall Construction:</u> Wall construction was halted in Kafr Laqif village north of Karnei Shomron settlement; in Immatin village northeast of Immanuel settlement; and east of Kafr Thulth town near Ma 'ale Shomron settlement.
	<ul style="list-style-type: none"> • <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the

(ii) At 21:00, Israeli forces set up a checkpoint at the entrance of Beit Furiq until 21:55.
<p>SALFIT</p>	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland. (ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian which was closed since the year 2000 and prevented access from 08:00 until 09:20. (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks. • <u>Checkpoints:</u> Israeli forces continue to intensify their restrictions at Za'tara Al-checkpoint and impeded the free flow of traffic. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 08:20, Israeli forces set up a checkpoint at the west entrance of Harris village until 09:00. (ii) At 15:15, Israeli forces set up a checkpoint between Deir Istiya junction and Harris village junction until 15:50. • <u>Wall Construction:</u> Wall construction resumed in the area north of Deir Istiya town southeast of the illegal settlement.
<p>JERICHO</p>	<ul style="list-style-type: none"> • <u>Checkpoints:</u> Israeli forces continue to intensify its restrictions at Al-Hamra checkpoint set up along the road connecting Jericho and Nablus District. • <u>Flying Checkpoints:</u> <ul style="list-style-type: none"> (i) At 08:20, Israeli forces set up a checkpoint along Al-Mu'arrajat road which connects Jericho and Ramallah until 09:50. (ii) At 10:15, Israeli forces set up a checkpoint near road (90) junction near Al-Nu'emeh village located at the north entrance of Jericho until 11:40. (iii) At 18:00, Israeli forces set up a checkpoint near Ein Dweik village located in North Jericho until 19:00. (iv) At 19:10, Israeli forces set up a checkpoint at the south entrance of Jericho until 20:20. • <u>Temporary Detention:</u> <ul style="list-style-type: none"> (i) At 11:25, Israeli forces positioned at Al-Humra checkpoint temporarily detained Nawaf Al-Jaihalin, a resident of Al-Jiftlik village then released him at 12:00. (ii) At 12:10, Israeli forces positioned at Allenby Bridge temporarily detained Mohammad Saleem, a resident of Qalqiliya as he was returning from Jordan then released him after reporting to Israeli intelligence officers for questioning.
<p>BETHLEHEM</p>	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village. (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area

	<p>in Beit Sahur and Bethlehem cities.</p> <ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; Wadi Rahal road near "Ifrat" settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds. (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks. (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla. (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires. (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds. (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds. (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds. (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 13:15, Israeli forces set up a checkpoint in Ush Al-Ghurab area in east Beit Sahur until 14:20. (ii) At 17:25, Israeli forces set up a checkpoint at the entrance of Jinata. • <u>Settler Violence:</u> At 14:30, Israeli settlers stoned resident and vehicles passing along the main road near Nahhalin village junction. • <u>Wall Construction:</u> <ul style="list-style-type: none"> (i) Wall construction halted in North West of Beit Jala town. (ii) On May 1st 2103, an Israeli court ordered the halt of wall construction near Betar village. (iii) On July 21st 2013, Israeli courts ordered the halt of construction of the wall in Al-Carmisan area in the west area of Beit Jalla.
HEBRON	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. . • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.

- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
 - (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
 - (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
 - (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and also closed the entrance of south Yatta with cement blocks.
 - (vi) Since December 27th 2012, Israeli forces closed the west entrance of Swiesiya village which connects Yatta and Al-Samou' village with cement blocks.
 - (vii) Since 09:45 on September 23rd 2013, Israeli forces closed the main road leading to "Haji" settlement and impeded the free flow of traffic
- **Flying Checkpoint:**
 - (i) At 08:30, Israeli forces set up a checkpoint at the entrance of Ithna.
 - (ii) At 21:50, Israeli forces set up a checkpoint in Abu Snineh neighbourhood in the old city of Hebron until 23:00.
 - **Raids:**
 - (i) At 16:50, Israeli forces raided Al-Hadab village in south Dura and occupied Yassir Dudawin's home and converted its rooftop into a Military post.
 - (ii) At 01:00, Israeli forces raided Al-Samou' and stormed several homes.
 - **Settler Violence:**
 - (i) On the evening of May 10th 2014, an Israeli settlers guarding "Magon" settlement in East Yatta temporally abducted the child: Mus'ab Al-Riba'I (6 years old) {a resident of Al-Tuwani village} then released him at a later time.
 - (ii) On the evening of May 10th 2014, Israeli settlers stormed Tel Al-Rumayda neighbourhood in the old city of Hebron and assaulted the child: Awni Abu Shamsiyeh as they temporally abducted him and assaulted his father as he attempted to prevent the settler attack on his son then released him at a later time.
 - (iii) At 02:25, Israeli settlers stormed Al-Nabi Yunis area in Halhul, stoned Al-Nabi Yunis Mosque then withdrew at 02:35.
 - **Wall Construction:** Wall construction was halted in the area surrounding the illegal settlement Eshkolot, west of Al-Thahriya town.

<p>ALL DISTRICTS</p>	<ul style="list-style-type: none"> • At 21:00 on November 21st 2012, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. • On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles and on March 21st 2013 re imposed fishing restrictions of 3 miles. • Israeli forces broke the ceasefire agreement after opening fire from their positions behind the Green Line towards North Gaza and Khan Yunis and as a result injured a resident in North Gaza.
<p>NORTHERN GAZA</p>	<ul style="list-style-type: none"> • Closure of Crossing Point: Beit Hanun (Erez) is closed. • Attack: At 06:40, Israeli forces positioned behind the Green Line opened fire towards several residents near Beit Hanun (Erez) in north Beit Hanun and as a result injured Nizar Alloun.
<p>GAZA</p>	<ul style="list-style-type: none"> • Closure of Crossing Points: <ul style="list-style-type: none"> (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. (ii) Al-Shija'iyah (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has been closed following a unilateral Israeli decision.
<p>KHAN YUNIS</p>	<ul style="list-style-type: none"> • Attack: On the morning of May 11th 2014, Israeli forces positioned behind the Green Line opened fire towards several residents and farmers as they farming their agricultural land in east Abasan Al-Kabira and Khazz'a.
<p>RAFAH</p>	<ul style="list-style-type: none"> • Closure of Crossing Points : <ul style="list-style-type: none"> (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (<i>Al 'Awdah</i>) Crossing is closed. (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is closed.
