Since 05 January 2009, the Israeli army has closed the area located along the (ii) Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

- (viii) At 21:05, Israeli forces raided Al-Tabaqa village and clashed with residents.
- <u>Detention:</u> At 11:35, Israeli forces detained Abdel Rahman Abu Sneina after storming 2 homes in the old city of Hebron area which is under Israeli control.

• Settler Violence:

- (i) At 22:30, Israeli settlers set fire to several fruit trees eastern Hebron.
- (ii) On May 13th 2012, an Israeli settler assaulted Walid Sabarna as he was farming his land in Beit Ummar after smashing his vehicle windshield and opened fire at him as he returned to his land.
- (iii) On May 13th 2012, Israeli settlers raided agricultural land in Beit Ummar and uprooted 14 fruit trees and grape vines owned by Hammad Al-Salibi.
- <u>Wall Construction:</u> Wall construction resumed in the area surrounding the illegal settlement Eshkolot, west of Al-Thahiriya town.

At 02:00 on 18 January 2009, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. The ceasefire has been further renewed on 30 October 2011 at 22:00. On 14.12.2011, Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark. Detainees Update

- The Minister of Detainees called upon all International and local human rights organizations to pressure the Israeli occupation authorities to save the life of Bilal Diab, a Palestinian detainee who has been on hunger strike for the past 77 days and is in critical condition and claimed the Israeli prison authorities fully responsible for his health status.
- Head of the International Red Cross medical staff stated that the full capacity a human body can sustain without food is the limit of 77 days and claimed that the detainees on Hunger strike (protesting Israeli authorities administrative detention and better prison conditions as well as visitation rights and to end solitary confinement) is in critical condition.
