WEST BANK

• Closure:

- (i) The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 48 from conducting prayers at Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

• Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and at 12:05, Israeli forces closed the checkpoint thus impeded the free flow of traffic and again closed it at 07:00 thus impeding the free flow of traffic until reopening it at 08:00.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.
- **Raid:** At 11:30, Israeli forces raided Anata and stormed a merchant shop.
- <u>Attack:</u> At 14:00, Israeli forces positioned at Shu'fat checkpoint fired stun and tear gas grenades towards several residents for alleged stoning.

• Detention:

- (i) At 13:20, Israeli forces detained two residents: Billal Abd Rabbo and Tallal Abd Rabbo after storming their merchant shop in Beit Safafa village.
- (ii) At 05:00, Israeli forces detained Nour Boutil (a resident of Qalandiya camp).

• Home Demolition:

- (i) At 04:00 on May 19th 2015, Israeli forces stormed Ein Al-Lawza area in Silwan and demolished an apartment (under construction) owned by Anis Karameh for allegedly being built without a licence.
- (ii) On the morning of May 20th 2015, Israeli forces stormed Ras Al-Amoud neighbourhood in Jerusalem and demolished a two floor building (consisting of eight Apartments) {under construction} owned by Ahmad Abu Snieneh for allegedly being built without a licence.

QALQILIYA

- (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town.
- (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village.
- (iii) Since 16:55 on December 18th 2014, Israeli forces closed an agricultural road leading to Far'ata village which is located near "Gillad" settlement with dirt mounds
- <u>Flying Checkpoint:</u> At 19:00, Israeli forces set up a checkpoint at the east entrance of Qalqiliya until 21:25.
- Raid: At 11:00, Israeli forces raided Al-Nabi Eliyas village, stormed several merchant shops and took photographs and recorded the store phone numbers.
- <u>Detention</u>: At 21:45, Israeli forces detained Mohammad Saleem (A resident of Azzun) as he was reporting to Israeli intelligence for questioning.

• Wall Gates:

- (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access.
- (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
- <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin.
- (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut.

• Raids:

- (i) At 23:35, Israeli forces raided Al-Nussauyra village.
- (ii) At 01:05, Israeli force raided Beit Furiq, clashed with several residents as they stormed homes and summoned Qussay Hanini to report to Israeli intelligence for questioning then withdrew at 03:20.
- (iii) At dawn on May 20^{th} 2015, Israeli force raided Huwara, detained a resident after storming his home

- (ii) At 10:05, Israeli force set up a checkpoint at the west entrance of Nihalin village until 12:00.
- (iii) At 15:50, Israeli forces set up a checkpoint at the north entrance of Taqou' until 16:20.
- (iv) At 19:35, Israeli force set up a checkpoint at the west entrance of Taqou' until 21:50.
- (v) At 19:40, Israeli forces set up a checkpoint in Ush Al-Ghurab area located in east Beit Sahur until 20:30.

• Raid:

- (i) At 16:40, Israeli forces raided Al-Iskan area in Beit Jalla, inspected surveillance camera footage of a cement block and plastic factory then withdrew at 17:30.
- (ii) At 19:30, Israeli forces raided Khirbeit Al-Dir, occupied Nayef Musa'a home and converted its rooftop into a military post then withdrew at 22:10
- (iii) At 03:30, Israeli forces raided Al-Khader, detained 5 residents including 4 children.

• Detention:

- (i) Israeli forces detained 5 residents including 4 children: Amir Salah (15 years old), Mohammad Otwan (16 years old), Karam Sabieh (15 years old), Marwan Sabieh (15 years old) and Khaled Issa in Al-Khader,
- <u>Attack:</u> At 09:40, Israeli forces positioned in Al-Ayda camp in Bethlehem fired stun and tear gas grenades towards several children for alleged stoning.

Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit
