| <b>ALL DISTRICTS</b> | <ul style="list-style-type: none"> <li>• The Israeli army continues to intensify its restrictions at checkpoints set up on the main roads connecting the West Bank districts, thereby isolating the northern districts from the southern districts as well as the Jericho district and the Jordan Valley from the remainder of the West Bank.</li> </ul>  |
| <b>JERUSALEM</b>     | <ul style="list-style-type: none"> <li>• <b>Closure:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to intensify its restrictions at checkpoints located at the entrances to the city of Jerusalem. The Israeli army also continues to close the entrances to Al Aqsa Mosque compound in the old city of Jerusalem and impede civilian access to the mosque.</li> <li>(ii) On 05 January 2009, the Israeli authorities issued Military Order # S/02/09 on the closure of and denial of civilian access to the "demarcation area" along the Wall in the area surrounding the city of Jerusalem. Accordingly, local residents and civilians holding permits can access this area through crossings and gates set up at the entrances to the city of Jerusalem. (The demarcation area is defined by a set of military orders relating to land confiscation for Wall construction).</li> <li>(iii) Beginning on 02 April 2009, the Israeli army has continued to impose a blockade and deny civilian access to a hill located in an area between the village of Biddu and Beit Iksa due to its geographical significance as it overlooks the city of Jerusalem.</li> </ul> </li> <li>• <b>Closure of Main Roads:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks and dirt barricades the entrance to the village of Jaba'.</li> <li>(ii) The Israeli army continues to close the iron gate along the Wall section, separating the area of Dahiyat al Bareed from the town of Ar Ram.</li> </ul> </li> <li>• <b>Checkpoint:</b> The Israeli army continues to consider Qalandiya checkpoint a "border crossing point" and has designated a special crossing for holders of Jerusalem IDs and those possessing permits to access the city of Jerusalem.</li> <li>• <b>Attack on Property:</b> On 28 May 2009, the Israeli army closed the Palestinian National Theatre (Al Hakawati) in the city of Jerusalem and prevented organisation of the conclusive celebration of the Palestine Festival of Literature.</li> <li>• <b>Wall Gates:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the Wall gate in the town of Abu Dis with cement blocks.</li> <li>(ii) The Israeli army continues to deny civilian access through the Wall gate on Ash Shayyah road in the area between the villages of As Sawahira ash Sharqiya and As Sawahira al Gharbiya, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</li> </ul> </li> </ul> |

The Israeli army also arrested the driver.</li> <li>(ii) At 00:10, the Israeli army raided the village of Jit and arrested 1 house.</li> <li>(iii) At 01:45, the Israeli army raided the city of Qalqiliya, set up a checkpoint, searched civilians and vehicles, and patrolled the area.</li> <li>(iv) At 01:50, the Israeli army raided and patrolled the area between the town of 'Azzun and the village of Misliya. On all other days, it is open for civilian residents of the neighborhood only.</li> <li>(ii) The Israeli army continues to allow Palestinians holding Israeli-issued IDs to access the city of Nablus by their private vehicles through Beit Furik checkpoint and Biet Iba iron gate. Additionally, the Israeli army allows free access to physicians, who are residents of the city of Nablus.</li> <li>(iii) Beginning on 15 February 2009, the Israeli army has allowed free access by private vehicles to all residents of the city of Nablus, who are above 50 years of age and in company with their families, through checkpoints set up around the city of Nablus.</li> <li>(iv) Having removed Beit Iba checkpoint, the Israeli army installed an iron gate near the junction to the village of Deir Sharaf along the Nablus-Tulkarem main road. The Israeli army also continues to deny access to the city to holders of Israeli IDs.</li> <li>• <b>Checkpoints:</b> The Israeli army continues to intensify its restrictions and impede civilian access at Al Hamra checkpoint set up along Al Badhan road connecting the districts of Jericho and Nablus as well as on the checkpoint set up on the junction to the village of Al ‘Auja along Al Mu’arrajat road that connects the districts of Jericho and Ramallah.</li> </ul>  |
| <p style="text-align: center;"><b>BETHLEHEM</b></p> | <ul style="list-style-type: none"> <li>• <b>Closure:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the roads to the village of An Nu’mān, with the exception of the road leading to the Wall gate in the south-eastern area of the village.</li> <li>(ii) According to Military Order # 07/02/S, the Israeli army has continued since 15 September 2007 to deny civilian access to an area measuring 22 <i>dunums</i> (5.436 acres) of land in the area of Mazmuriya in the cities of Beit Sahur and Bethlehem. The land was confiscated pursuant to Military Order # 07/31/T.</li> </ul> </li> <li>• <b>Closure of Main Roads:</b> In addition to 2 side roads east and south of the village of Al Walaja, the Israeli army continues to close with dirt barricades the roads of Beit Jala-Wadi Ahmad; Talita-Nazlet as Sidr in the city of Beit Jala; Al Khadr -Road # 60; Al Khadr -Beit Jala Housing Project; Wadi Rahal-Efrat; and the side road east of the town of Beit Fajjar.</li> <li>• <b>Checkpoint:</b> At 13:00, the Israeli army intensified its restrictions at As Sawahira ash Sharqiya (the ‘Container’) checkpoint and searched civilians and vehicles.</li> <li>• <b>Flying Checkpoint:</b> At 00:20, the Israeli army set up a flying checkpoint on the junction to the area of An Nashash (the southern entrance to the city of Bethlehem) and searched civilians and vehicles until 02:00.</li> <li>• <b>Raids:</b> <ul style="list-style-type: none"> <li>(i) At 10:00, the Israeli army raided and patrolled the town of Al Khadr.</li> <li>(ii) At 21:30, the Israeli army raided Ad Duheisha refugee camp in the city of Bethlehem and arrested 1 civilian.</li> </ul> </li> <li>• <b>Arrest:</b> The Israeli army arrested Ibrahim Fat’hi ‘Ayyad in Ad Duheisha refugee camp in the city of Bethlehem.</li> <li>• <b>Palestinian Security Measure:</b> At 13:00, Palestinian security forces handed over to the Israeli authorities (through the DCO) 2 Israeli citizens, who had been located in possession of narcotic drugs, in the city of Bethlehem.</li> <li>• <b>Wall Construction:</b> Wall construction continues in the area northwest of the town of Al Khadr; northwest of the city of Beit Jala; in the area of Wadi Rahhal east of Ifrat settlement; and in the area surrounding the village of Al Walaja.</li> </ul> |

**HEBRON**

- **Closure:**
  - (i) The Israeli army continues to close the following locales in the old city of Hebron: Ash Shuhada' Street and the area of As Sahleh with cement blocks and barbed wire; the old gold market with an iron gate; the area of Khuzq al Far near the settlement of Abraham Avino with a dirt barricade and an iron gate; and the entrance to the area of Al Khan with an electronic gate, isolating the area from Al Laban Market and the area of As Sahleh. The Israeli army also continues to install an iron gate at the entrance to the area of Al Hisba (the fruits and vegetables market) in the old city of Hebron, thereby controlling civilian access in the area.
  - (ii) The Israeli army continues to prevent civilian vehicles from travelling along the road connecting the settlement of Kiryat Arba' to the Ibrahimi Mosque in the old city of Hebron.
  - (iii) On 05 January 2009, the Israeli army issued Military Order # 09/06/S for closure of the area located along the Green Line south of the town of Yatta, evacuation of civilian residents, and prevention of civilian access to the area. According to Military Orders # 05/03/T and 05/04/T, land in this area was confiscated for Wall construction.
- **Closure of Main Roads:**
  - (i) The Israeli army continues to close with cement blocks the entrance to the town of As Samoa'; the area of Al Hawawir leading to the town of Halhul; the road connecting the town of Surif to the village of Al Jab'a; the eastern entrance to the village of Kharsa; the entrance to the Al Qeisi neighbourhood in the old city of Hebron; as well as the entrances to Al 'Arrub refugee camp, the village of At Tuwani, and the town of Adh Dhahiriya.
  - (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along Ash Shalala Old Street in the old city of Hebron.
  - (iii) The Israeli army continues to close with dirt barricades the road between the villages of Al Karmil and At Tuwani and all roads leading to Road # 60.
  - (iv) The Israeli army continues to open the iron gate on the Farsh Al Hawa junction to Road # 35, which leads to Tarqumiya Crossing, from 05:00 until 07:00 and from 09:00 until 13:00.
- **Flying Checkpoints:**
  - (i) At 08:30, the Israeli army set up a flying checkpoint on Al Fawwar junction and searched civilians and vehicles.
  - (ii) At 13:00, the Israeli army set up a flying checkpoint at the entrance to the area of Al Fahs south of the city of Hebron and searched civilians and vehicles.
  - (iii) At 15:40, the Israeli army set up a flying checkpoint along Road # 35 in the area of Wadi Qayyun north of the city of Hebron and searched civilians and vehicles.
  - (iv) At 16:00, the Israeli army set up 2 flying checkpoints and searched civilians and vehicles at the entrances to the area of An Nabi Yunis (the eastern entrance to the town of Halhul) and the town of Tarqumiya.
