At 02:00 on 18 January 2009, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups **ALL** announced an agreement to cease fire. The ceasefire has been further renewed on 30 October 2011 at 22:00. **DISTRICTS** Palestinian gunmen broke the ceasefire agreement after firing 5 projectiles including 3 grad missiles towards the Green Line. Closure of Crossing Point: Beit Hanun (Erez) is open to previously-coordinated patients, foreign journalists, staff of international organizations, merchants, business people and civilians travelling to Jordan through Al-Karama (Allenby) bridge in the West Bank. **Palestinian Attack: NORTHERN** At 09:30, members of an armed group launched 1 projectile towards (i) GAZA (ii) At 03:35, members of an armed group launched 1 projectile towards the Green Line. At 10:45, members of an armed group launched 1 projectile towards (iii) the Green Line. **Closure of Crossing Points:** Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the (i) Crossing has been effectively closed following a unilateral Israeli decision. Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, (ii) GAZA the Crossing has been closed following a unilateral Israeli decision. Palestinian Attack: At 18:05, members of an armed group launched 1 projectile towards the Green Line. Closure of Crossing Points: Yasser 'Arafat International Airport remains closed. Rafah (Al 'Awdah) Crossing is closed Sufa Crossing is closed. Karm Abu Salem (Karem Shalom) Crossing is open for the transportation of food supplies, goods, humanitarian aid and cooking gas and construction material designated to internationally funded projects. **RAFAH** Al Awda crossing – Rafah is open for patients, students and civilians with permits. Palestinian Attack: At 18:35, members of Armed Palestinian groups launched

projectiles towards the Green Line.

- An Israeli Military courts in Jerusalem sentenced Ali Kanaan, a resident of Silwan neighbourhood in Jerusalem to 13 years with an additional 3 years prison sentence and fined him 7500 NIS (approximately \$2050 USD) and also sentenced Ammar Al-Absi, a resident of Silwan to 10 months imprisonment.
- An Israeli military court in Salim detention camp sentenced Jamal Al-Tirawi, a Member of the Palestinian Legislative Council and resident of Balata refugee camp to 30 days.
