| JERUSALEM | <ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) On November 3rd 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers from conducting prayers at Al-Aqsa mosque compound, which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound. (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Ikksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Ikksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. (iii) On October 14th 2015, Israeli forces closed the main road leading to Al-Eisawiya village with cement blocks. (iv) On October 14th 2015, Israeli forces closed the four entrances of Jabal Al-Mukabir neighbourhood with cement blocks. (v) On October 14th 2015, Israeli forces closed the three entrances of Sur Bahar with Cement blocks. (vi) On October 14th 2015, Israeli forces closed the entrance of Al-Tur neighbourhood (leading to Al-Za'im village in Jericho and Al-Eizariya) and Suliman French road with cement blocks. (vii) On October 14th 2015, Israeli forces closed the entrance of Wadi Al-Rabaybeh area in Silwan neighbourhood in Jerusalem with cement blocks. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall. • <u>Flying Checkpoint:</u> At 19:00, Israeli forces set up a checkpoint in the area located between Jaba' and Hizma villages then inspected residents Identification cards and searched vehicles. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 23:00, Israeli forces raided Al-Eisawiya village, clashed with several residents as they stormed and searched a health clinic in the village {allegedly searching for injured residents} and attempted to confiscate a medical file and detained 6 residents. (ii) At 00:50, Israeli forces raided Al-Ram. |

| | <ul style="list-style-type: none"> • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 24:00, Israeli forces detained two residents: Abboud Shihab and Ashraf Shihab in Al-Sunah neighbourhood. (ii) On November 4th 2015, Israeli forces detained Hiba Sarhan after storming her home in Silwan neighbourhood in Jerusalem. (iii) At dawn on November 4th 2015, Israeli forces detained five residents: Omar Al-Za'anin, Rami Al-Za'anin, Khaled Mighrabi, Aboud Al-Haddad and Mohammad Jaber after storming their homes in the old city of Jerusalem. (iv) Israeli forces detained six residents: Mohammad Aliyan, Bashar Dari, Hamad Obied, Mohammad Mahmoud, Amir Khaldoun Mustafa and Samer Anwar Obied in Al-Eisawiya village. • <u>Temporary Detention:</u> At 18:00, Israeli forces temporarily detained two children: Mohammad Abdallah Yacoub (7 years old) and Ameer Mohammad Al-Abbassi (9 years old) in Al-Thouri neighbourhood then released them later. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 11:50, Israeli forces positioned at the wall gate near Al-Quds University in Abu Dis fired stun and tear gas grenades towards several children for alleged stoning. (ii) At 14:50, Israeli forces positioned at the wall gate near Qutna village fired stun and tear gas grenades towards several residents for alleged stoning. (iii) At 15:00, Israeli forces positioned at Jaba' checkpoint fired stun and tear gas grenades towards several residents for alleged stoning. (iv) At 21:00, Israeli forces positioned in Ras Al-Amoud neighbourhood fired stun and tear gas grenades towards several residents for alleged stoning. • <u>Assault on Places of Worship:</u> <ul style="list-style-type: none"> (i) At 09:00, a group of Israeli settlers under the protection of the Israeli Military and Police stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshippers during which a Israeli settler began performing Talmudic rituals near the Dome of the Rock and was moved from the area by Ahmad Abu Aliya (a Mosque guard) who was then assaulted by Israeli forces and Police. (ii) At 21:00, Israeli forces stormed Ain Al-Louz area in Silwan and served a military border for the demolition of al-Qa'qaa mosque. • <u>Settler Violence:</u> At 10:00, an Israeli settler attempted to stab an unidentified Palestinian child (A resident of Shu'fat camp) as he was accompanied by his mother near "Armat Ishkol" settlement. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices. |

On October 3rd 2015, Israeli forces closed the main road located near "Bet El" settlement and leading to Al-Jalazoun camp with cement blocks. (iii) At 22:00 on November 2nd 2015, Israeli forces closed the entrance of Silwad with Cement blocks. (iv) At 09:00 on November 3rd 2015, Israeli forces closed the North East entrance of Ain Yabrud village with Cement blocks and dirt mounds. |

- **Checkpoint:** At 08:40, Israeli forces closed Al-Mahkama” checkpoint located near “Bet El” settlement in North Al-Bireh city and impeded the free flow of traffic for allegedly locating a suspicious object near the checkpoint and reopened it at a later time.

 - (i) At 08:00, Israeli forces set up a checkpoint at the entrance of Budrous village then inspected residents Identification cards and searched vehicles until 16:00.
 - (ii) At 11:15, Israeli forces set up a checkpoint near Atarah bridge located in North Bir Ziet then inspected residents Identification cards and searched vehicles until 15:35.
 - (iii) At 15:35, Israeli forces set up a checkpoint at the entrance of Al-Jalazoun camp then inspected residents Identification cards and searched vehicles until 18:00.
 - (iv) At 17:25, Israeli forces set up a checkpoint at the entrance of Beit Illo village then inspected residents Identification cards and searched vehicles.
 - (v) At 17:25, Israeli forces set up a checkpoint at the entrance of Deir Ammar village then inspected residents Identification cards and searched vehicles.
 - (vi) At 17:25, Israeli forces set up a checkpoint at the entrance of Al-Jamala village then inspected residents Identification cards and searched vehicles.

 - (i) At 02:05, Israeli forces raided Safa village and clashed with several residents.
 - (ii) At 02:30, Israeli forces raided Al-Nabi Saleh village, stormed several homes and detained three residents.
 - (iii) At 03:10, Israeli forces raided Beit Rima and summoned Faraj Ismail Assi to report to Israeli Intelligence for questioning.
 - (iv) At 04:00, Israeli forces raided Silwad and detained two residents including a Preventive Security Force officer.
- **Detention:**
 - (i) Israeli forces detained three residents: Bassil Ahmad Azmi Odeh, Issam Samih Mohammad Al-Tamimi and Mu’tasim Samih Mohammad Al-Tamimi in Al-Nabi Saleh village.
 - (ii) Israeli forces detained two residents: Haytham Faris Ibrahim Hamad (a Preventive Security Force officer) and Mohammad Abdel-Majid Hamad in Silwad.
- **Attack:**
 - (i) At 13:40, Israeli forces positioned at “Ofar” Military Base/ Prison fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents) for alleged stoning and as a result injured 6 residents.
 - (ii) At 14:30, Israeli forces positioned in the vicinity Al-Mahakma checkpoint located near “Bet El” settlement in North Al-Bireh city fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents (who were protesting against the continued Israeli Military and Settler assault on Al-Aqsa mosque compound) for alleged stoning and as a result injured 4 residents: Ammar Saleh Tawfiq Zied, Sami Mohammad Assi, Mohammad Khalil Abu Ja’far and Wissam Ahmad Abdel-Qadder and again 17:45 Israeli forces opened fire in the area for the alleged gunfire towards Israeli soldiers at the checkpoint.
 - (iii) At 14:55, Israeli forces positioned near “Pesagout” settlement located in east Al-Bierh city fired live ammunition; rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
 - (iv) At 17:40, Israeli forces positioned near the entrance of Budrus village fired stun and tear gas grenades towards several residents for alleged stoning.

(ii) At 01:45, Israeli forces raided Bi’r Al-Basha village then stormed and searched a home. • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 09:40, Israeli forces positioned at Al-Jalma crossing point temporarily detained the child: Mohammad Jallal Al-Mahr (16 years old) {A resident of Jenin camp} for allegedly finding a knife and an Explosive device in his possession {as alleged by the Israeli Military}. (ii) Israeli forces detained two residents: Majd Mohammad Tawfiq Kamil and Salah Al-Din Najeh Kamil in Qabatiya. • <u>Wall Gates:</u> Israeli forces continue too close the wall gate and only allow those holding special permits to enter through it. |

| TULKAREM | <ul style="list-style-type: none"> • <u>Checkpoint:</u> Israeli forces continue to intensify their restrictions at “Eniv” checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 10:25, Israeli forces positioned near Wall gate (664) in Al-Shweikiya neighbourhood in Tulkarem fired fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning residents (who were protesting against the continued Israeli Military and Settler assault on Al-Aqsa mosque compound) and as a result injured 2 residents: Mirvat Fihmi Salah Abu Shanab and Khaled Hassan Mohammad Sabah and left several residents suffocated from tear gas inhalation. (ii) At 11:30, Israeli forces positioned in “Ghishouri” factory area located in West Tulkarem fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning residents (who were protesting against the continued Israeli Military and Settler assault on Al-Aqsa mosque compound) and as a result injured 5 residents: Abdallah Mahmoud Qaroush, Sharar Sa’id Abu Azziz, Suhayeb Mohammad Rabah, Ahmad Wael Subhi Aboudi and Assef Mahmoud Shaqir and also left several residents suffocated from tear gas inhalation. • <u>Temporary Detention:</u> At 08:15, Israeli forces positioned at Wall gate (623) located in Deir Al-Ghusoun temporarily detained Mohammad Zuhier Mohammad Ghanem (A resident of Deir Al-Ghusoun) then released him at 09:15. |

HEBRON

- **Closure:**
 - (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
 - (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.
- **Closure of Main Roads:**
 - (i) The Israeli army continues to close the entrances to Al-Karmil villages.
 - (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
 - (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
 - (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
