GAZA STRIP

At 02:00 on 18 January 2009, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. The ceasefire has been further renewed on 10 April 2011. The Israeli breached the ceasefire and fired missiles on Gaza and Khan Younis injuring 3 civilians.
