JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) On November 10th 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound, which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Ikksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Ikksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. (iii) On October 14th 2015, Israeli forces closed the main road leading to Al-Eisawiya village with cement blocks. (iv) On October 14th 2015, Israeli forces closed the entrance of Al-Tur neighbourhood (leading to Al-Za’im village in Jericho and Al-Eizariya) and Suliman French road with cement blocks. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. (iii) At 13:30, Israeli forces closed Shu’fat checkpoint in Jerusalem then reopened it later. • <u>Raid:</u> <ul style="list-style-type: none"> (i) On the afternoon of November 10th 2015, Israeli forces raided Al-Eisawiya village, stormed the home of Mohammad Nimr (A resident killed by Israeli forces in Al-Masrara neighbourhood in Jerusalem) and temporarily detained 4 of his family members (his father and 3 brothers) then released them after questioning. (ii) At 03:30, Israeli forces raided Bir Nabala, stormed and searched a home, detained a resident then withdrew at 05:20. • <u>Killing:</u> At 13:20, Mohammad Abed Ali Nimr (37 years old){A resident of Al-Eisawiya village} was killed after Israeli forces opened fire towards him in Al-Masrara neighbourhood for allegedly attempting to stab a Israeli Settler as alleged by the Israeli military. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 12:30, Israeli forces positioned in Ras Al-Amoud neighbourhood fired rubber coated steel bullets, stun and tear gas grenades towards several school children for alleged stoning. (ii) At 12:30, Israeli forces positioned near Hizma village fired stun and tear gas grenades towards several residents for alleged stoning.

	<ul style="list-style-type: none"> (iii) At 13:30, Israeli forces positioned near the wall gate near Al-Quds University campus in Abu Dis fired stun and tear gas grenades towards several school children for alleged stoning. (iv) At 13:30, Israeli forces positioned in Al-Tur neighbourhood stun and tear gas grenades towards several school children for alleged stoning. (v) At 14:30, Israeli forces positioned near “Pisgat Ze’ev” settlement located in east Jerusalem opened fire towards 2 children: Ali Ehab Al-Qam (12 years old){Critically injured} and Mo’awiya Ahmad Alqam (13 years old){Both residents of Shu’fat camp} for allegedly attempting to stab a Israeli settler then detained them. (vi) At 15:30, Israeli forces positioned near the North junction of Al-Ram, fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning. • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 19:40, Israeli forces detained Mohammad Abu Maliya after storming his home in Silwan neighbourhood. (ii) On the morning of November 11th 2015, Israeli forces detained three residents: Muntasir Saleme, Malik Al-Shawiky and Mohammad Nasser in Ras Al-Amoud neighbourhood. (iii) Israeli forces detained Khadr Adel Shahin in Bir Nabalah. (iv) Israeli forces detained Ali Ehab Al-Qam (12 years old) {critically injured} and Mo’awiya Ahmad Alqam (13 years old) {both residents of Shu’fat camp} for allegedly attempting to stab an Israeli settler near “Pisgat Ze’ev” settlement located in east Jerusalem. • <u>Assault on Places of Worship:</u> <ul style="list-style-type: none"> (i) At 09:00, a group of Israeli settlers under the protection of Israeli Military and Police forces stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshippers. (ii) At 09:30, several employees of the Israeli Minister of Archaeology protection of Israeli Military and Police forces stormed Al-Aqsa mosque compound in the old city of Jerusalem. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

On October 3rd 2015, Israeli forces closed the main road located near “Bet El” settlement and leading to Al-Jalazoun camp with cement blocks. (iii) On November 5th 2015, Israeli forces closed the main road connecting Silwad and Ein Yabroud village. • <u>Flying Checkpoint:</u> At 16:30, Israeli forces set up a checkpoint at the entrance of Al-Nabi Saleh village and impeded the free flow of traffic after closing the steel entrance gate. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 08:30, Israeli forces raided Beituniya until 08:40. (ii) At 15:15, Israeli forces raided Al-Bireh city, detained a resident, temporarily detained Sharif Jum’a Hassan Hamidat (25 years old) {a resident of Al-Jalazoun camp} then released him later and withdrew at 16:10.

	<p>(iii) At 03:00, Israeli forces raided Kobar village, stormed and searched three homes then withdrew at 04:00.</p> <ul style="list-style-type: none"> • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 12:35, Israeli forces positioned in the vicinity Al-Mahakma checkpoint located near “Bet El” settlement in North Al-Bireh city fired rubber coated steel bullets, stun and tear gas grenades towards several residents (who were protesting against the continued Israeli Military and Settler assault on Al-Aqsa mosque compound)for alleged stoning and stormed a Abandoned home. (ii) At 1245, Israeli forces positioned at “Pesagout” settlement located in the east area of Al-Bireh city fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning (iii) At 14:10, Israeli forces positioned near the entrance of Al-Jalazoun camp fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning. (iv) At 16:20, Israeli forces positioned near the entrance of Deir Nathim village fired stun and tear gas grenades towards several residents for alleged stoning. • <u>Detention:</u> Israeli forces detained Tarik Daoud Issa Al-Hilew (A resident of Al-Bireh city). • <u>Temporary Detention:</u> At 18:50, Israeli forces positioned at “Pesagout” settlement located in the east area of Al-Bireh city temporarily detained three children and then released them after strip-searching them.
JENIN	<ul style="list-style-type: none"> • <u>Closure of Main Road:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road leading to the town of ‘Arraba east of the illegal settlement Dotan. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya’bad. • <u>Checkpoint:</u> At 10:15, Israeli forces closed “Movo Dotan” checkpoint located in south Ya’bad (along the main road connecting Jenin and Tulkarem) and impede the free flow of traffic until 11:15. • <u>Flying Checkpoint:</u> At 14:20, Israeli forces set up a checkpoint at Arrabah junction then searched vehicles and inspected resident’s identification cards. • <u>Raid:</u> At 18:00, Israeli forces raided Sanour village then stormed and searched a home. • <u>Wall Gates:</u> Israeli forces continue too close the wall gate and only allow those holding special permits to enter through it.
TULKAREM	<ul style="list-style-type: none"> • <u>Checkpoint:</u> Israeli forces continue to intensify their restrictions at “Eniv” checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic. • <u>Flying Checkpoint:</u> At 17:35, Israeli forces set up a checkpoint in the area between Shufa and Izbit Shufa villages then searched vehicles and inspected resident’s identification cards. • <u>Raid:</u> At 20:30, Israeli forces raided Zieta. • <u>Temporary Detention:</u> At 09:55, Israeli forces positioned near the wall gate near Zieta temporarily detained the child Abdel-Latif Saber Khalifa (A resident of Ajja village in Jenin) as he was farming (collecting on agricultural land then released him at 11:00. • <u>Attack:</u> At 09:30, Israeli forces positioned in “Ghishouri” factory area located in West Tulkarem fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning residents (who were protesting against the continued Israeli Military and Settler assault on Al-Aqsa mosque compound) and as a result injured Ahmad Khaled Khadr Jaber and left another resident suffocated from tear gas inhalation.

	<ul style="list-style-type: none"> • Closure of Wall Gate: At 16:35, Israeli forces closed wall gate (436) located in Quffin village and as a result impeded the free flow of traffic then reopened it at 17:15.
QALQILIYA	<ul style="list-style-type: none"> • Closure of Roads: <ul style="list-style-type: none"> (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) Since 10:40 on September 1st 2015, Israeli forces closed an agricultural road leading to Far'ata village which is located near "Gillad" settlement with a steel Gate • Raid: At 03:00 on November 10th 2015, Israeli forces raided Immatin village and detained a resident. • Detention: Israeli forces Jafar Yusef Ghannam in Immatin village. • Attack: <ul style="list-style-type: none"> (i) At 14:10, Israeli forces positioned near the wall gate in West Qalqiliya fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and left several other suffocated from tear gas inhalation. (ii) At 21:00, Israeli forces positioned at Al-Jaljouiya gate located in South Qalqiliya fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning as result injured 3 residents: Anas Mamdouh Hamad and left 12 others suffocated from tear gas inhalation. • Settler Violence: At 15:20, Israeli settler positioned near Al-Jaljouiya gate located in South Qalqiliya assaulted the child: Mohammad Abdallah Owiesat (17 years old) {A resident of Qalqiliya} and as a result left him hospitalised with contusions. • Wall Gates: <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
NABLUS	<ul style="list-style-type: none"> • Closure: Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. • Closure of Main Roads: <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut. (iii) At 22:00 on October 3rd 2015, Israeli forces closed the North entrance of Awarta village with dirt mounds. • Checkpoints: At 19:25, The Israeli Military intensified its restrictions at Beit Furiq checkpoint and impeded the free flow of traffic until 22:00. • Flying Checkpoint: At 14:15, Israeli forces set up a checkpoint near "Shav Shomron" settlement junction then searched vehicles and inspected resident's identification cards until 15:15. • Raid: <ul style="list-style-type: none"> (i) At 04:00, Israeli forces raided Beita and detained a resident.

(v) At 02:30, Israeli forces raided Beit Ibba, detained a resident then withdrew at 05:45. (vi) At 02:50, Israeli forces raided Nablus. • <u>Detention:</u> <ul style="list-style-type: none"> (i) Israeli forces detained Hamad Owayda Jaghoub in Beita. (ii) Israeli forces detained Muhanad Abdel-Rahim Saba'neh in Beit Ibba. • <u>Temporary Detention:</u> At 19:15, Israeli forces positioned at the entrance of Beit Furiq temporarily detained the child: Qayis Bassam Hanini (16 years old) then released him later. • <u>Attack:</u> At 16:00, Israeli forces positioned in Jabal Al-Qa'da located near "Gillad" settlement outpost in south Beit Furiq fired stun and tear gas grenades towards several residents for alleged stoning. • <u>Settler Violence:</u> At 09:10, a group of Israeli settlers stormed east Yanoun village and placed organic fertilizer on a plot of land in an attempt to plant and seize the land.
SALFIT	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland. (ii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks. • <u>Checkpoint:</u> Israeli forces intensified their restrictions at Za'tara checkpoint and impeded the free flow of traffic. • <u>Flying Checkpoint:</u> At 18:10, Israeli forces set up a checkpoint at the entrance of Al-Zawiya village then searched vehicles and inspected resident's identification cards.
JERICHO	<ul style="list-style-type: none"> • <u>Checkpoints:</u> Israeli forces continue to intensify its restrictions at Al-Hamra checkpoint set up along the road connecting Jericho and Nablus District. • <u>Flying Checkpoint:</u> At 24:00, Israeli forces set up a checkpoint at the south entrance of Jericho then searched vehicles and inspected resident's identification cards. • <u>Detention:</u> At 15:50, Israeli forces detained Mahmoud Ahmad Odat Ka'abneh (A resident of Ein Al-Sultan camp) at a flying checkpoint located between Jericho and Ramallah.

BETHLEHEM

- **Closure:**
 - (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village.
 - (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities.
- **Closure of Main Roads:**
 - (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; Wadi Rahal road near "Ifrat" settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds.
 - (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks.
 - (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla.
 - (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
 - (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.
 - (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
 - (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds.
 - (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002 } and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.
 - (ix) Since 10:45 on September 8th 2015, Israeli forces closed the agricultural road located in Arab Al-Rashaydeh village located near "Malee Amous" settlement with dirt mounds.
- **Checkpoint:** At 15:00, Israeli forces closed Al-Container checkpoint and impeded the free flow of traffic until reopening it later.
- **Flying Checkpoint:**
 - (i) At 08:00, Israeli forces set up a checkpoint at the west entrance of Beit Fajjar then searched vehicles and inspected resident's identification cards until 12:25.
 - (ii) At 10:05 and again at 19:20, Israeli forces set up a checkpoint near Dar Salah village located at the east entrance of Beit Sahur then searched vehicles and inspected resident's identification cards.
 - (iii) At 11:55, Israeli forces positioned at Al-Nashash area junction located at the south entrance of Bethlehem then searched vehicles and inspected resident's identification cards until 13:45.
- **Raid:**
 - (i) At 12:50, Israeli forces raided Irtas village until 13:45.
 - (ii) At 13:40, Israeli forces raided Al-Khader, clashed with several school children then withdrew at 14:30.

	<p>(iii) At 02:15, Israeli forces raided Husan village, stormed several homes, detained four residents including two children then withdrew at 04:00.</p> <ul style="list-style-type: none"> • <u>Killing:</u> At 15:00, Sadek Ziyad Sadek Gharbiya (16 years old) {A resident of Sanur village in Jenin) was killed after Israeli forces opened fire towards him near Al-Container checkpoint in Bethlehem for allegedly attempting to stab an Israeli soldier as alleged by the Israeli military. • <u>Detention:</u> Israeli forces detained four residents: Rami Mohammad Khalil Hamarah (16 years old), Mohammad Ziyad Abd Al-Aridi (17 years old), Daoud Hassan Daoud Hamad and Shaker Attiyah Hamaraah in Husan village. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 15:00, Israeli forces positioned in the vicinity of Billal Bin Rabah mosque and in Al-Ayda camp located in North Bethlehem fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as result injured 4 residents including a child: Ahmad Qassim Al-Azraq (14 years old){critical head injury} leaving him hospitalised. (ii) At 23:10, Israeli forces positioned at the entrance of Betar village fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured Eyad Ibrahim Mustafa Qaisiya leaving him hospitalised.
<p style="text-align: center;">HEBRON</p>	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Karmil villages. (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City. (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
