• Closure:

- (i) Israeli army continues to intensify their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

- (i) At 16:30, Israeli forces positioned at Anata junction fired stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 20:30, Israeli forces positioned in Ras Kabseh area located between Abu Dis and Al-Eizariya fired stun and tear gas grenades towards several residents for alleged stoning.
- Home Demolition: On November 12th 2013, Israeli forces demolished a home in Beit Hanina owned by Afif Kastro and Ayman Kastro {After forcing Afif Kastro to demolish a mobile home used to shelter his family after Israeli forces demolished their home which consisted of 2 floors almost 9 months ago in Beit Hanina as mentioned in the previous report} and also served a demolition order to demolish a storage room owned by Saleh Kastro in Beit Hanina.

• Wall Gates:

- (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem

- (ii) At 09:45, Israeli forces positioned at Container checkpoint detained Thaer Raba'ya.
- Attack: At 12:30, Israeli forces positioned at the entrance of Al-Ayda camp in Bethlehem fired tear gas grenades towards several school children for alleged stoning.
- Settler Violence: At 14:40, Israeli settlers stormed agricultural land in Taqou' and set fire to 5 Olive trees then withdrew at 15:40.

Wall Construction:

- (i) Wall construction has continued in North West of Beit Jala town.
- (ii)On May 1st 2103, an Israeli court ordered the halt of wall construction near Betar village.
- (iii) On July 21st 2013, Israeli courts ordered the halt of construction of the wall in Al-Carmisan area in the west area of Beit Jalla.

Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. .

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and also closed the entrance of south Yatta with cement blocks.
- (vi) Since December 27th 2012, Israeli forces closed the west entrance of Swiesiya village which connects Yatta and Al-Samou' village with cement blocks.
- (vii) Since 09:45 on September 23rd 2013, Israeli forces closed the main road leading to

"Haji" settlement and impeded the free flow of traffic

- (i) At 08:00, Israeli forces set up a checkpoint along the entrance leading to "Hadgi" settlement in south Hebron and impeded the free flow of traffic after closing the main entrance gate then reopened it at 09:30.
- (ii) At 08:15, Israeli forces set up a checkpoint in Farsh Al-Hawa area located in north Hebron.
- (iii)At 08:15, Israeli forces set up a checkpoint in Wadi Qabun area located in north Hebron.
- (iv)At 20:35, Israeli forces set up a checkpoint at the entrance of Al-Fah's area located in south Hebron.
- <u>Raid:</u> At 11:00, Israeli forces raided Sinjir area which is located between Hebron and Dura until 13:30.
- <u>Detention:</u> At 08:00, Israeli forces detained Mahdi Abu Hata in the old city of Hebron.

• Temporary Detention:

- (i) At 13:00, Israeli forces positioned in Talat Abu Hadid area in the old city of Hebron temporally detained Foad Tabash (17 years old) and released him at a later time.
- (ii) At 18:00, Israeli forces positioned in Al-Sahlat area in the old city of Hebron temporarily detained 3 children: Alaa Al-Rajabi (14 years old), Mohammad Rajabi (12 years old) and Fahed Al-Bakri (11 years old) then released them at a later time.

• Attack:

- (i) At 12:10, Israeli forces positioned at the entrance of Al-Fuwar camp fired stun and tear gas grenades towards several school children for alleged stoning.
- (ii) At 14:00, Israeli forces positioned in Al-Shuhada' road in the old city of Hebron fired stun and tear gas grenades towards several residents for alleged stoning.
- (iii)At 16:20, Israeli forces positioned near Al-Urub camp, fired tear gas grenades towards several residents for alleged stoning and temporarily detained 5 residents including a child: Khalid Abdallah (16 years old), Mohammad Jawabra, Husam Jawabra, Rami Othman and Yusef Abu Afifeh.
- <u>Installation of Military Post:</u> At 08:40, Israeli forces installed several mobile caravans on a hill top in south Hebron.
 - Wall Construction: Wall construction continued in the area surrounding the illegal settlement Eshkolot, west of Al-Thahriya town.

GAZA STRIP

November 13th 2013 At 21:00 on November 21st 2012, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles and on March 21st 2013 ALL re imposed fishing restrictions of 3 miles. DISTRICTS Israeli military broke the ceasefire agreement by raiding and opening fire towards Central Gaza and Khan Yunis and as a result injured a resident. Israeli Naval Vessels broke the cease fire agreement by opening fire towards Palestinian fishing boats off the shores North Gaza and Khan Yunis. Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical patients, journalists, NGO staff, businessmen and passengers travelling abroad through Al-Karama crossing with previous coordination. **NORTHERN** Attack: **GAZA** (i) At 17:30, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Beit Lahiya. (ii) At 06:30, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Beit Lahiya **Closure of Crossing Points:** (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. **GAZA** Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, (ii) the Crossing has been closed following a unilateral Israeli decision. Raid: On the morning of November 13th 2013, Israeli forces escorting several military bulldozers stormed Al-Buriej camp and opened fire as they levelled a plot **CENTRAL** of land near the border fence. **GAZA** Raid: On the morning of November 13th 2013, Israeli forces escorting several military bulldozers stormed 300m into the vicinity of Khaz'a, opened fire as they levelled a plot of agricultural land and as a result injured a resident. **KHAN YUNIS** Attack: On the morning of November 13th 2013, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Khan Yunis. **Closure of Crossing Points:**

- Sufa Crossing is closed.
