• Closure:

- (i) On November 19th 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound, which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.
- (iii) On November 16th 2015, Israeli forces closed the south entrance of Jabal Al-Mukabir neighbourhood in Jerusalem, which leads to "Armon Hanzif" settlement with cement blocks.

Checkpoints:

(i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.

(ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

• Flying Checkpoint:

- (i) At 23:20, Israeli forces set up a checkpoint at the entrance of Bir Nabala then searched residents and vehicles.
- (ii) At 00:30, Israeli forces set up a checkpoint at the entrance of Biddo then searched residents and vehicles.
- Attack: At 15:00, Israeli forces positioned near Abu Dis opened fire towards the child Mohammad Maaher Jamous (14 years old) and as result left him hospitalised in critical condition.

• Detention:

- (i) On November 19th 2015, Israeli forces detained seven residents including three children: Mustafa Abu Sneineh (16 years old), Mohammad Zahakika (16 years old) Malik Shaqir (16 years old), Ayoub Adaqadiq, Mahmoud Obied, Nader Odwan Oday Nader Odwan in Jerusalem.
- (ii) At 21:30, Israeli forces positioned at Jaba' checkpoint detained Mahdi Salah Ahmad Taqatqa (A resident of Beit Fajjar in Bethlehem).
- **<u>Killing:</u>** On November 19th 2015, Mahmoud Sa'id Mahmoud Aliyan (23 years old){A resident of Anataa in Jerusalem} died of injuries sustained during confrontations with Israeli forces near "Al-Mahakma" checkpoint located near "Bet

- (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks
- (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla.
- (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
- (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.
- (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
- (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds
- (viii) Since January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.
- (ix) Since 10:45 on September 8th 2015, Israeli forces closed the agricultural road located in Arab Al-Rashaydeh village located near "Malee Amous" settlement with dirt mounds.
- (x) At 11:00 on November 19th 2015, Israeli forces closed the raod connecting Za'tara and Al-Faradis village with dirt mounds.

• Flying Checkpoint:

- (i) At 08:50, Israeli forces set up a checkpoint in Ush Ak-Ghurab area located in east Beit Sahour, detained three school girls for allegedly carrying knives then withdrew at 11:25.
- (ii) At 13:45 and again at 16:55, Israeli forces set up a checkpoint beneath Al-Khadr bridge an impeded the free flow of traffic until a later time.
- (iii) At 15:20, Israeli forces set up a checkpoint at the North entrance of Taqou' then searched residents and vehicles until 17:10.
- (iv) At 17:30, Israeli forces set up a checkpoint along the main road near Al-Minat village located along the road near Wadi Sa'ir then searched residents and vehicles.
- (v) At 20:45, Israeli forces set up a checkpoint at the west entrance of Beit Fajjar then searched residents and vehicles until 02:20.

- (ii) At 13:40, Israeli forces raided Al-Khadr, clashed with several residents then withdrew at 14:20.
- (iii) At 20:45, Israeli forces raided Bethlehem and set up a checkpoint near Billal Bin Rabah mosque then withdrew at 21:30.
- (iv) At 02:20, Israeli forces raided Betar village, stormed and searched several homes and warned residents about alleged stoning by village children then withdrew at 02:50.

• Attack:

- (i) At 09:35, Israeli forces positioned in the vicinity of Billal Bin Rabah mosque located in North Bethlehem fired stun and tear gas grenades towards several residents for alleged stoning, temporarily detained 6 residents and seized their book bags and jackets then were released at a later time and again at 14:15 fired rubber coated steel bullets, stun and tear gas grenades towards residents for alleged stoning.
- (ii) At 15:45, Israeli forces positioned at the entrance of Taqou' fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured 2 residents including a child: Ahmad Samir Al-Amour and left several others suffocated from tear gas inhalation.
- (iii) At 16:45, Israeli forces positioned near "Kafr Itsiyon" settlement opened fire towards a resident driving a vehicle { for alleged shooting towards several Israeli settler near "Aylon Shavot" settlement which killed 2 Israeli settlers and injured 10 others} and as a result killed a resident and detained an injured resident { for allegedly opening fire towards Israeli settlers.
- <u>Killing:</u> Israeli forces opened fire towards and killed Shadi Zuhdi Rateb Arafa (16 years old) {A resident of Hebron} near "Kafr Itsiyon" settlement.

• Detention:

- (i) Israeli forces positioned at a flying checkpoint in Ush Ak-Ghurab area located in east Beit Sahour, detained 3 school girls: Hadeel Mazen Ali (15 years old){A resident of Bethlehem}, Hiba Raed Farid (15 years old) and Nour Nidal Slama (16 years old).
- (ii) Israeli forces detained Ahmad Yasser Ahmad Shushat and Awni Qassim Ahmad Shushat in Husan village.
- (iii) Israeli forces positioned near "Kafr Itsiyon" settlement detained Mohammad Abdel-Baset Al-Haroub (A resident of Deir Sammit village)

• Closure:

- (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and also closed the entrance of south Yatta with cement blocks.
- (vi) At 11:00 on August 6th 2015, Israeli forces closed the entrance of Al-Hajara village located in south Dura with cement blocks.
- (vii)At 05:50 on November 5th 2015, Israeli forces closed the entrance leading Farsh Al-Hawa area in Hebron with Cement blocks.
- (viii) Since November 11th 2015, Israeli forces closed the main road connecting Beit Awwa and Al-Majd village with cement block and dirt mounds.
- (ix) Since November 11th 2015, Israeli forces closed the steel gate entrance of Beit Einoun village and Al-Fuwar junction and the entrance of Bani Na'im with cement blocks.
- (x) At 15:45 on November 15th 2015, Israeli forces closed Al-Samiya village junction located at the west entrance of Al-Samou' with cement blocks.
- (xi) On November 15th 2015, Israeli forces closed the entrances of Khaliat Al-Miya and Al-Dirat villages located along the bypass roads near east Yatta with dirt mounds.

• Flying Checkpoint:

- (i) At 08:20, Israeli forces set up a checkpoint at the north entrance of Hebron located along road (35) near Halhoul bridge) then searched residents and vehicles.
- (ii) At 09:40, Israeli forces set up a checkpoint along Halhoul Bridge then searched residents and vehicles.
- (iii) At 17:25, Israeli forces set up a checkpoint at the entrance of Beit Ummar then searched residents and vehicles.
- (iv) At 02:40, Israeli forces set up a checkpoint at the entrance of Al-Fa's area located in south Hebron and impeded the free flow of traffic from both directions.
- (v) At 07:00, Israeli force set up a checkpoint at Al-Nabi Yunis area junction located along the main road connecting Hebron and Bethlehem and prevented residents from entering Halhoul.

Raid:

- (i) At 17:05, Israeli forces raided Beit Awwa.
- (ii) At 17:10, Israeli forces raided Tarusat village, stormed and searched Raed Mahmoud Jabarat Masalmeh's {who was detained by Israeli forces for allegedly stabbing several Israeli Settlers in Tel Aviv and as a result killed 2 settlers and injured another}.
- (iii) At 18:00, Israeli forces raided Deir Sammit village, stormed and searched two homes and detained six residents.
- (iv) At 18:50, Israeli forces raided Sinjir neighbourhood in Dura.
- (v) At 01:50, Israeli forces raided Halhoul, stormed two homes, temporarily detained children in the homes then released them after questioning them about stoning incidents then withdrew at 05:10.
- (vi) At 02:05, Israeli forces raided Hebron, detained 3 residents then withdrew at 05:00.
- (vii)At 02:25, Israeli forces raided Dura and Beit Awwa, detained 3 residents in Dura then withdrew at 05:00.
- (viii) At dawn on November 20th 2015, Israeli forces raided Beit Ummar and detained a resident.

• Detention:

- (i) At 10:15, Israeli forces detained Ahmad Najeh Al-Ajlouni after storming his home in the old city of Hebron.
- (ii) At 15:40, Israeli forces positioned in the old city of Hebron detained he child Omar Thiyab Jibril Abu Sbeih (16 years old) for allegedly carrying a knife.
- (iii) Israeli forces detained six residents: Ibrahim Raed Masalmeh, Iz Al-Din Mohammad Masalmeh, Masaud Mohammad Khaled Al-Haroub, Ziyad Mahmoud Musa Masalmeh, Ismail Nayef Ismail Awad and Ahmad Mohammad Masalmeh in Deir Sammit village.
- (iv) Israeli forces detained three residents Fihmi Sami Al-Ja'bari, Raed Othman Al-Sahawmar and Samer Hilmi Al-Natsheh in Hebron.
- (v) Israeli forces detained three residents: Ismail Hussien Al-Awwadat, Yasser Abdel-Fattah Ammro and Hussien Mohammad Ammro in Dura.
- (vi) Israeli forces detained Farhan Musa Hussien Algam in Beit Ummar.

• Attack:

- (i) At 08:45, Israeli forces positioned in Tal'at Abu Hadeed area in the old city of Hebron fired stun and tear gas grenades towards residents for alleged stoning.
- (ii) At 09:20, Israeli forces positioned near Abu Rish checkpoint and Tarik Bin Zied school in the old city of Hebron fired stun and tear gas grenades towards 4 schools: AlZahra school, Al-Ibrahimiya school, Tarik Bin Zied School and Al-Hajriya school for alleged stoning and as a result left several school children suffocated from tear gas inhalation and as a result cancelled classes.
- (iii) At 15:30, Israeli forces positioned near Khursa village junction fired stun and tear gas grenades towards several residents for alleged stoning.
- (iv) At 16:00, Israeli forces positioned near Al-Fuwar junction fired stun and tear gas grenades towards several residents for alleged stoning.

• Settler Violence:

- (i) At 18:40, Israeli settlers positioned near Al-Simiya village junction stoned residents and vehicles.
- (ii) At 20:55, Israeli settlers positioned near "Kiryat Arab" settlement located in the old city of Hebron stoned homes in Al-Kasarat and Wadi Al-Nasri area's and stoned vehicle travelling along a bypass road near the settlement

GAZA STRIP
