WEST BANK

• Closure:

- (i) On November 21st 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound, which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.
- (iii) On November 16th 2015, Israeli forces closed the south entrance of Jabal Al-Mukabir neighbourhood in Jerusalem, which leads to "Armon Hantsiv" settlement with cement blocks.

• Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.
- <u>Flying Checkpoint:</u> At 16:30, Israeli forces set up a checkpoint at the entrance of Anata then searched residents and vehicles.

• Raid:

- (i) At 01:30, Israeli forces raided Abu Dis and detained two residents including a child.
- (ii) At 04:00, Israeli forces raided Al-Eizariya and clashed with several residents.

• Attack:

- (i) At 08:00 and again at 22:00, Israeli forces positioned near Al-Madaris road in Jabal Al-Mukabir neighbourhood in Jerusalem fired stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 08:00, Israeli forces positioned near Al-Madaris road in Ras Al-Amoud neighbourhood in Jerusalem fired stun and tear gas grenades towards several residents for alleged stoning and detained three residents.
- (iii) At 14:30, Israeli forces positioned near Shu'fat checkpoint fired stun and tear gas grenades towards several residents for alleged stoning.
- (iv) At 16:40, Israeli forces positioned near Qalandiya checkpoint fired stun and tear gas grenades towards several residents for alleged stoning.

Detention:

JERUSALEM

- (i) At 15:30, Israeli forces positioned near "Malee Adumim" settlement detained Ramadan Mohammad Izat Shtewi (A resident of Kafr Qaddum village in Qalqiliya).
- (ii) Israeli forces detained two residents: Ali Salah Al-Amouri (14 years old) and Tariq Salah Al-Amouri in Abu Dis.
- (iii) Israeli forces detained three residents: Jibril Al-Amour, Eyad Al-Jindi and Hussien Ayash in near Al-Madaris road in Ras Al-Amoud neighbourhood in Jerusalem.

• Wall Gates:

- (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages
- (ii) . On October 3rd 2015, Israeli forces closed the main road located near "Bet El" settlement and leading to Al-Jalazoun camp with cement blocks.
- (iii) On November 5th 2015, Israeli forces closed the main road connecting Silwad and Ein Yabroud.

• Flying Checkpoint:

- (i) At 07:35 on November 21st 2015, Israeli forces set up a checkpoint near Atarah Bridge in Bir Ziet then searched residents and vehicles until 11:15.
- (ii) At 08:40 and again at 20:15, Israeli force set up a checkpoint at the entrance of Al-Nabi Saleh village then searched residents and vehicles until 21:20.
- (iii) At 16:00, Israeli forces set up a checkpoint near the entrance of Ein Sinya then searched residents and vehicles.
- (iv) At 16:15, Israeli forces set up a checkpoint near the entrance of Turmus'aya then searched residents and vehicles.
- (v) At 17:20, Israeli forces set up a checkpoint near the entrance of Abboud then searched residents and vehicles.
- (vi) At 17:35, Israeli forces set up a checkpoint at the entrance of Deir Abu Mash'al village then searched residents and vehicles.
- (vii) At 18:05, Israeli forces set up a checkpoint at the entrance of Deir Ammar village then searched residents and vehicles until 21:20.
- (viii) At 18:40, Israeli forces set up a checkpoint in the area between Beit Ur Al-Tahta and Beit Ur Al-Foqa then searched residents and vehicles until 21:20.
- (ix) At 21:20, Israeli forces set up a checkpoint at the entrance of Sinjil then searched residents and vehicles.

• Raid:

- (i) At 03:00 on November 21st 2015, Israeli forces raided Abu Qash village and stormed a home.
- (ii) At 16:15, Israeli forces raided Al-Bireh city, stormed a coffee shop, temporarily detained 2 children: Suhayeb Hamdi Al-Shilat (14 years old) and Mohammad Mawawiya (14 years old).

Attacks

- (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village.
- (iii) Since 16:55 on December 18th 2014, Israeli forces closed an agricultural road leading to Far'ata village which is located near "Gillad" settlement with dirt mounds
- (iv) Since 10:40 on September 1st 2015, Israeli forces closed an agricultural road leading to Far'ata village which is located near "Gillad" settlement with a steel Gate

• Flying Checkpoint:

- (i) At 11:45, Israeli forces set up a checkpoint at the east entrance of Qalqiliya then searched residents and vehicles until 12:30.
- (ii) At 21:00, Israeli forces set up a checkpoint at the entrance of Immatin village then searched residents and vehicles until 23:00.

• Attack:

- (i) At 12:10, Israeli forces positioned near the wall gate in West Qalqiliya fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured the child Bisan Rami Abu Issa (6 years old) leaving him hospitalised with contusions.
- (ii) At 19:30, Israeli forces positioned near the wall gate in Azzun Atma village opened fire towards Hamadah Abdel-Aziz Atwanah (A resident of Al-Jiftl;ik village in Jericho) for allegedly attempting to cross the Green Line without a valid permit and as a result left him hospitalised.
- **Demonstration:** At 15:20, a demonstration took place in Kafr Qaddum protesting against the Israeli military closure of village east entrance during which Israeli forces fired stun and tear gas grenades towards several residents as they attempted to reach the demonstration site and as a result left several residents suffocated from tear gas inhalation.

Wall Gates:

- (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access.
- (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
- <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin.
- (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Oaryut.
- (iii) At 22:00 on October 3^{rd} 2015, Israeli forces closed the North entrance of Awarta village with dirt mounds.
- (iv) At 06:30 on November 22nd 2015, Israeli forces closed the main road connecting Aqraba and Yanoun village with dirt mounds.
- <u>Checkpoints:</u> At 14:15, Israeli forces intensified their restrictions at Huwara checkpoint and impeded the free flow of traffic until 15:00.
- **Flying Checkpoint:** At 18:00, Israeli forces set up a checkpoint at Burin village junction then searched residents and vehicles.

- (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village.
- (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities.

• Closure of Main Roads:

- (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala; Wadi Rahal road near "Ifrat" settlement, the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds.
- (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks
- (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla.
- (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
- (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.

(vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.

- (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds.
- (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.
- (ix) Since 10:45 on September 8th 2015, Israeli forces closed the agricultural road located in Arab Al-Rashaydeh village located near "Malee Amous" settlement with dirt mounds.
- (x) At 15:30 on November 20th 2015, Israeli forces closed the east entrance of Jinata and the entrance of Marah Rabah village with dirt mounds.
- (xi) At 13:10 on November 22nd 2015, Israeli forces closed the entrance of Marah Rabah village with dirt mounds.

• Flying Checkpoint:

- (i) At 17:00, Israeli forces set up a checkpoint at the entrance of Dar Salah village and at the east entrance of Beit Sahour then searched residents and vehicles.
- (ii) At 17:20, Israeli forces positioned underneath Al-Khader Bridge located along the main road connecting the west village of the district then searched residents and vehicles.
- (iii) At 17:30, Israeli forces positioned at the west entrance of Beit Fajjar then searched residents and vehicles.
- (iv) At 18:45, Israeli forces set up a checkpoint in Ush Al-Ghurab area located in east Beit Sahur then searched residents and vehicles until 20:00.

BETHLEHEM

• Raid:

- (i) At 01:20, Israeli forces raided Beit Fajjar, stormed several homes, detained a resident and summoned Hussien Ahmad Jaber Thawabteh to report to Israeli Intelligence for questioning.
- (ii) At 06:15, Israeli forces raided Bethlehem, stormed a home, confiscated surveillance camera footage from a Pharmacy shop after destroying the main entrance and detained a child.

• Detention:

- (i) Israeli forces detained Jihad Jamal Mahmoud Thawabteh in Beit Fajjar.
- (ii) Israeli forces detained Ahmad Mohammad Abdallah Al-Harimi (17 years old) in Bethlehem.

• Attack:

- (i) At 14:25, Israeli forces positioned near Al-Ayda camp located in North Bethlehem fired stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 15:15, Israeli forces positioned near Billal Bin Rabah mosque located in North Bethlehem fired stun and tear gas grenades towards several residents for alleged stoning.
- (iii) At 18:55, Israeli forces positioned near the entrance of Nihalin village fired stun and tear gas grenades towards several residents for alleged stoning.
- Physical Assault: At 18:30, Jihad Mohammad Zawahra (A resident of Um Salmon village) was hospitalised with injuries after Israeli forces assaulted him as he was driving his vehicle near Um Salmona village.
- <u>Settler Violence:</u> At 16:00, Israeli settlers positioned near "Betar Aliyat" settlement located in the area between Husan and Nihalin villages stoned residents and vehicles passing along the main road near the settlement.

• Closure:

- (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) At 05:50 on November 5th 2015, Israeli forces closed the entrance leading Farsh Al-Hawa area in Hebron with Cement blocks.
- (vi) At 10:30 on November 8th 2015, Israeli forces closed the junction located near "Hagi" settlement located in south Hebron with cement blocks.
- (vii)At 21:00 on November 11th 2015, Israeli forces closed the main road connecting Beit Awwa and Al-Majd village with cement block and dirt mounds.

HEBRON

- (viii) At 15:45 on November 15th 2015, Israeli forces closed Al-Samiya village junction located at the west entrance of Al-Samou' with cement blocks.
- (ix) On November 15th 2015, Israeli forces closed the entrances of Khliat Al-Miya and Al Dirat and the two bypass roads leading east Yatta with cement blocks.
- (x) Since 14:00 on November 20th 2015, Israeli forces closed the east entrance of Yatta.
- (xi) Since 15:00 on November 20th 2015, Israeli forces closed the north entrance of Al-Thahriya.
- (xii)Since 14:00 on November 20th 2015, Israeli forces closed the entrances of Obada, Beit Marah, Deir Al-Asal, Deir Razeh and Qurma villages with dirt mounds.
- (xiii) Since 15:10 on November 21st 2015, Israeli forces closed the entrance of Beit Ummar.
- (xiv) Since 19:25 on November 21st 2015, Israeli forces closed the entrance of Al-Aroub camp with cement blocks.

• Flying Checkpoint:

- (i) At 11:20, Israeli forces set up a checkpoint at the North entrance of Hebron then searched residents and vehicles.
- (ii) At 19:10, Israeli forces set up a checkpoint in Wadi Sa'ir then searched residents and vehicles.

Raid:

- (i) At 09:05, Israeli forces raided Deir Sammit village, clashed with several residents and as a result left several residents suffocated from tear gas inhalation.
- (ii) At 09:30, Israeli forces raided Sa'ir, occupied Riyad Misa Al-Shalda's home and converted its rooftop into a military post, temporarily detained 2 residents: Baligh Mohammad Eid Jaradat and Samaha Jamal Hussien Qawazba and then summoned Omar Thiyab Issa Al-Faroukh to report to Israeli Intelligence for questioning.
- (iii) At 12:00, Israeli forces raided Al-Aroub camp, occupied Hassan Zaqout Al-Badawi's home and converted it into a military post and then stormed and searched several home and detained a resident.
- (iv) At 23:10, Israeli forces raided Beit Awa, stormed and searched seven homes, detained five residents including a disabled resident and then summoned Moath Jihad Abu Ghaliya to report to Israeli Intelligence for questioning.
- (v) At 00:10, Israeli forces raided Tafouh (after Israeli forces detained Mohammad Shaker Mohammad Al-Tardah whom Israeli forces accuse of stabbing four Israeli settlers in Kiryat Ghat city) then stormed and searched several homes, detained 3 residents then withdrew at 05:00.
- (vi) At 00:50, Israeli forces raided Hebron and detained two residents.
- (vii)At 00:50, Israeli forces raided Bani Na'im and Dura, clashed with several residents in Dura then withdrew at 05:00.
- (viii) At dawn on November 22nd 2015, Israeli forces raided Surif and detained four residents.
- (ix) At dawn on November 22nd 2015, Israeli forces raided Al-Shiyoukh, stormed a **charitable organization** and confiscated several files, electronic equipment, office furniture and telephones.

• Attack:

- (i) At 12:20, Israeli forces positioned at the entrance of Beit Awa fired stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 15:10, Israeli forces positioned near Beit Ummar fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and then detained six residents including three children.

Detention:

- (i) At 15:00, Israeli forces positioned at Al-Ibrahimi mosque compound in the old city of Hebron detained Tamara Mohammad Ahmad Shartih (A resident of Yatta) for allegedly attempting to stab an Israeli soldier.
- (ii) Israeli forces detained Yasser Yacoub Ahmad Al-Badawi in Al-Aroub camp.
- (iii) Israeli forces detained 5 residents: Hassan Abdel-Fattah Masalmah, Hamza Taysir Masalmah, Abdel-Aziz Omar Al-Souwiti, , Moath Hassan Abdel-Fattah Masalmah and Mohammad Suliman Abu Ithri' (A disabled patient) in Beit Awwa.
- (iv) Israeli forces detained three residents: Tarik Khalil Al-Tarda, Firas Khalil Al-Tarda and Ra'fat Mohammad Jibril Al-Tarda in Tafouh.
- (v) Israeli forces detained two residents: Raed Shoukat Mohammad Al-Fakhouri and Munjid Al-Ja'bari in Hebron.
- (vi) Israeli forces detained four residents: Ahmad Ismail Ghanimat, Ahmad Khaled Ghanimat, Mohammad Jihad Ghanimat and Saif Al-Din Ahmad Al-Hour in Surif.
- (vii)Israeli forces detained six residents: Mohammad Subhi Nimr Adi (13 years old), Daoud Al-Qadi (14 years old), Faif Ahmad Radwan Khalil (15 years old), Abdallah Shafiq Radwan Khalil and Ahmad Ibrahim Thalji Adi and Wael Yusef Al-Qadi in Beit Ummar.
- <u>Settler Violence:</u> At 22:15, a group of Israeli settlers positioned at the entrance of Bani Na'im and stoned residents and vehicles.

GAZA STRIP

At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. Israeli forces broke the cease fire agreement by opening fire from their positions behind the Green Line towards Rafah
