WEST BANK

Closure:

- The Israeli army, intensified their restrictions at the entrance to Jerusalem (i) city, set up several flying checkpoints on the main road leading to the city for the alleged stabbing of an Israeli settler.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- The Israeli army continues to impose a blockade and deny civilian access to a (iii) hill between Biddu and Beit Iksa villages.

Closure of Main Roads:

- The Israeli army continues to close with cement blocks and dirt mounds the (i) entrance to Jaba' village.
- The Israeli army continues to close with an iron gate the eastern entrance to (ii) Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and closed the checkpoint at 01:20 and impeded the free flow of traffic until 04:05.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

JERUSALEM

- Flying Checkpoint: At 23:40, Israeli forces set up a checkpoint at the entrance of "Adumin" settlement junction located at the east entrance of Al-Eizariya.
- Raid: At 03:10, Israeli forces raided Al-Eisawiya, stormed a home and detained a resident.

- (i) At 08:00, Israeli forces detained five residents including two children: Hamza Mahmoud Hamza (17 years old), Mohammad Hamza Atwan (17 years old), Hussein Musa Hamdan, Ahmad Khadr Nimr and Nayef Jadallah in Sur Bahar village.
- (ii) At 19:30. Israeli forces detained four residents: Alaa Al-Kiswani, Ahmad Abu Khdeir, Abdel-Rahman Issa and Eyad Afif in Shu'fat.
- (iii) At 01:00, Israeli forces detained Majd Ghayth in Silwan neighbourhood.
- (iv) At dawn on November 24th 2014, Israeli forces positioned in Jabal Al-Mukabir detained Zeid Khalayleh.
- (v) Israeli forces detained Abdallah Dari in Al-Eisawiya.

- (i) At 20:00, Israeli forces positioned near the entrance of Shu'fat camp fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 20:00, Israeli forces positioned at Bab Hata area in the old city of Jerusalem fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- Temporary Detention: At 11:30, Israeli courts sentenced Samer Al-Karari and Ahmad Siyam to home detention and a financial penalty of 500 NIS approximately 130 USD to each of them.

Settler Violence:

(i) At 10:00, Israeli settlers positioned at Al-Magharbah gate (The main gate

	leading to Al-Aqsa mosque compound in the old city of Jerusalem) sprayed pepper spray onto the face of Riham Abu Adwan. (ii) At 13:00, Israeli settlers positioned in Jerusalem assaulted two children: Bara' Abu Sneieneh (15 years old) and Sahar Khalifeh (15 years old) as they were returning home from school. (iii) At 18:00, Israeli settlers positioned at Yafa road in Jerusalem assaulted Musa Al-A'war and as a result, left him hospitalised with contusions. (iv) At 20:00, Israeli settlers positioned in Silwan neighbourhood assaulted Hamada Al-Ghour and as a result, left him hospitalised with contusions. • Assault on Places of Worship: At 08:00, Israeli settlers under the protection of Israeli Police and Military stormed Al-Aqsa mosque compound and provoked worshipers. • Wall Gates: (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

cement blocks.

- (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla.
- (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
- (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.
- (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
- (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds.
- (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.

- (i) At 16:55, Israeli forces set up a checkpoint near Al-Khadr Bridge.
- (ii) At 22:00, Israeli forces set up a checkpoint at the entrance of Taqou'.

Raid:

- (i) At dawn on November 23rd 2014, Israeli forces raided Um Salmona village and detained two residents.
- (ii) At 12:05, Israeli forces raided Al-Khadr until 12:20.
- (iii) At 14:00, Israeli forces raided Irtas village until 15:00.
- (iv)At 14:45, Israeli forces raided Taqou', occupied a home on wed by Nayef Musa and converted its rooftop into a military post then withdrew at 17:05.
- <u>Detention:</u> Israeli forces detained Ali Hayan and Mahmoud Hayan in Um Salmona village.
- **Physical Assault:** At 19:10, Israeli forces positioned at "Kafar Eitsiyon" settlement junction assaulted Munthir Ziyadah (A resident of Hebron) leaving him hospitalised with contusions.

• Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the

area.

Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.
- (vi) On September 4^{th} 2014, Israeli forces closed a road in Eiwn Al-Bas and Al-Bayda and Al-Ras area in Ithna locat6ed near the wall gate.
- (vii)At 13:40 on September 16th 2014, Israeli forces closed the main road leading to Al-Ibrahim mosque in the old city of Hebron.

• Flying Checkpoint:

- (i) At 07:30 on November 23rd 2014, Israeli forces set up a checkpoint at Al-Fuwar junction until 08:30.
- (ii) At 11:15, Israeli forces set up a checkpoint at the entrance of Beit Awwa until 12:50.

• Raid:

- (i) At dawn on November 23rd 2014, Israeli forces raided east Yatta, stormed and searched "Al-Sadaq Al-Amin "mosque and searched worshipers inside the mosque.
- (ii) At 09:45, Israeli forces raided Bab Al-Zawiya area in Hebron, occupied the homes and merchant shops and converted their roof tops into military posts and fired stun and tear gas grenades towards several residents for alleged stoning then withdrew at 10:40.
- (iii)At 17:00, Israeli forces raided Beit Awa, stormed several homes, detained three residents then withdrew at 19:20.
- **Physical Assault:** At 20:25, Israeli forces positioned at the entrance of Al-Urub camp assaulted Basel Al-Amarin (A resident of Al-Urub camp) and as a result, left him hospitalised with contusions.

• Detention:

- (i) At 23:40, Israeli forces detained Thaer Dandis in the old city of Hebron.
- (ii) Israeli forces detained three residents: Walid Al-Ghallassi, Yusef Abu Jamal and Oday Masalmeh in Beit Awa.

• Attack:

- (i) At 08:40, Israeli forces positioned at Al-Shuhada' road in the old city of Hebron fired stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 09:00, Israeli forces positioned at the entrance of Al-Urub camp fired rubber coated steel bullets fired stun and tear gas grenades towards several residents for alleged stoning.

At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed

to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the **ALL** fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by **DISTRICTS** the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. Israeli forces broke the cease-fire agreement by opening fire towards North Gaza and Khan Yunis and as a result killed a resident and critically injured a child. Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical patients, journalists, NGO staff, businesspersons and passengers travelling abroad through Al-Karama crossing with previous coordination. Attack: At 09:30, Israeli forces positioned behind the Green line opened fire towards east Jabaliya and as a result killed a resident. **NORTHERN GAZA** Killing: Israeli forces killed Fadil Hawalah (A resident of Jabaliya). **Detention:** On November 18th 2014, Israeli forces positioned at Beit Hanun (Erez) detained Mohammad Hamdan (A terminally ill patient) {A resident of Al-Nussayrat camp} as he was travelling to receive treatment at a Jordanian hospital then they allowed him to pass through. **Closure of Crossing Points:** (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. **GAZA** (ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision. **Closure of Crossing Points:** (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (Al 'Awdah) Crossing is closed. (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is open for the entry of tourist and foreign diplomats and the entry of Humanitarian assistance. **RAFAH** Attack: At 17:30, Israeli forces positioned behind the Green Line opened fire towards 3 residents in Al-Shuka town in Rafah for allegedly being near the border fence and as a result critically injured the child: Abdel-Ra'of Al-Qaddi (17 years old) and detained 2 others. **Detention:** Israeli forces detained two unidentified residents near the border fence in Rafah.
